

HB 1514 -- Interest on Overpayment of Income Taxes

Sponsor: Smith (150)

This bill changes the time period before interest is paid on an overpayment of income tax from four months to 45 days after the last date to file a return, including an extension, or the date the return was filed, whichever is later.
