

HB 1823 -- Tax Increment Financing

Sponsor: Brown (85)

This bill prohibits a company from benefitting from a tax increment financing project if it relocates from within the state. If a company opens a new business within 10 miles of an existing business and closes the existing business within two years, the company must forfeit any benefits it received for the new business.
