FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Social Services (DSS)**, **MO HealthNet Division (MHD)**, **Children's Division (CD)** and **Division of Legal Services (DLS)** state this legislation revises Section 337.503 and prohibits discrimination against all professions licensed under chapter 337 (i.e. psychologists, social workers, behavior analysts, marital and family therapists, and licensed professional counselors) only in regard to where services can be performed and the populations that can be served. This provision applies to entities including "agencies of the state".

MHD officials provide the following behavioral health providers are authorized to serve MO HealthNet eligible children under the age of 21:

- Psychiatrists
- Licensed Psychologists
- Licensed Clinical Social Workers (LCSW)
- Licensed Professional Counselors (LPC)
- Licensed Behavioral Analysts (only for children with Autism Spectrum Disorder)

The following providers are authorized to serve MO HealthNet eligible adults:

- Psychiatrists
- Licensed Psychologists
- Licensed Clinical Social Workers (only if the service is provided in a Federally Qualified Health Clinic (FQHC) or Rural Health Clinic (RHC)

Because the added language refers to all professions within Chapter 337, RSMo, MO HealthNet assumes this legislation requires MHD to reimburse LPCs and LCSWs for services provided to adults as well as children (as is the case with psychologists) without regard to the location in which the service is provided (i.e. LCSWs can serve adults currently, but only in an RHC or FQHC). MO HealthNet further assumes this bill requires MHD to reimburse licensed marital and family therapists (LMFTs) who are currently not authorized MO HealthNet providers. MO HealthNet also assumes this bill would expand the population currently served by behavioral analysts to include adults and children with other diagnoses than Autism Spectrum Disorder (ASD).

Fee-For-Service (FFS) Estimate

In FY16, there were 1,191 LPCs paid for providing MO HealthNet services and 608 LCSWs. MO HealthNet assumes increased access to the adult MO HealthNet population will increase the number of LPC and LCSWs providing MO HealthNet services by 30% in the first year (1,191 * 30% = 357 LPCs; 608 * 30% = 182 LCSWs) and 5% each year thereafter.

<u>ASSUMPTION</u> (continued)

In FY16, there were 281 LMFTs licensed in Missouri. MHD assumes 30% of these providers would enroll with MO HealthNet in the first year (281 * 30% = 84) and an additional 5% each year thereafter.

In the first six months of FY17, there were 112 behavior analysts enrolled with MO HealthNet to serve children with ASD. MO HealthNet assumes there will be a 30% increase of behavioral analyst providers serving MO HealthNet children and adult recipients with disorders other than ASD (112 * 30% = 34) and a 5% increase each year thereafter.

Annual MO HealthNet reimbursement per provider:

LPC: \$13,760.26LCSW: \$9,940.08

• Behavior Analyst: \$27,478.26

• MFT: \$11,850.17 (average of LPC and LCSW cost per provider)

MO HealthNet then calculated the increased cost per provider to arrive at a first full year FFS cost of \$8,651,850 Total Funds.

Managed Care Estimate

To calculate the Managed Care cost, MO HealthNet calculated the Per Member Per Year (PMPY) cost for a FFS participant by applying the FFS cost of this legislation (\$8,651,850.05) divided by the FFS participants (368,274) as of June 2016 for a PMPY cost of \$23.49. Then this was applied to the June 2016 Managed Care population of 614,502 for a total first year cost of \$14,434,652 (\$23.49 PMPY cost X 614,502 Managed Care population).

Savings are expected under managed care because Missouri expects the Managed Care Organizations (MCOs) to improve the quality of care of the beneficiaries and to ultimately reduce the utilization of services and/or shift services to a more appropriate setting. Based on results from the Managed Care Cost Avoidance Study which examined a mature managed care model, MO HealthNet assumes a 2.2% savings in the third year (FY 20). MHD assumes these savings would be phased in beginning the second year, so only a 1.1% savings are applied in FY 19. There are no managed care savings in the first year of implementation (FY 18).

FY18 was calculated for 10 months. MO HealthNet assumes a 4.1% inflation factor for FY19 and FY20.

A one-time \$50,000 actuarial study will also be necessary to determine the impact such changes would have on the MO HealthNet Managed Care program.

ASSUMPTION (continued)

Currently, some MO Health rates paid to behavioral health providers are slightly higher if the service is provided in the participant's home. If the language is interpreted to prohibit this rate differential ("location where the services can be performed"), MHD would either have to increase all rates to the "in-home" rate or remove this differential. This fiscal estimate does not include the costs or savings associated with the rate differential.

CD officials provide that Children's Treatment Services (CTS) contracts for services provided by professions affected by this statute that mirror those requirements held by MHD for the same services.

The CD states MO HealthNet assumes this legislation requires MHD to reimburse LPCs for services provided to adults as well as children (as is the case with psychologists). MO HealthNet further assumes this bill does not require MHD to reimburse LPCs according to the same fee schedule as psychologists, who are required to have doctoral level training versus the required masters level training for LPCs.

CD currently pays LPCs for services on behalf of parents who are not Medicaid eligible on whom CD has an open child welfare case. If the fee schedule for these providers does not change, this will have no fiscal impact on CD.

Further, CD has a rate differential for when services are provided in the client's home vs. in the providers' office. The CD is not interpreting this legislation to require the division pay the inhome rate for services provided in the office.

The Children's Division does not anticipate any programmatic or fiscal impacts as a result of the implementation of this bill.

DLS officials assume this proposal will have no fiscal impact on their division.

Therefore, in summary the DSS assumes this proposal will have the following fiscal impact:

FY18 (10 months): \$19,290,273 (GR \$6,901,474; Federal \$12,388,799); FY19: \$24,320,542 (GR \$8,692,162; Federal \$15,628,380); and FY20: \$25,240,032 (GR \$9,020,787; Federal \$16,219,245).

Officials from the **Office of Attorney General (AGO)** assume any potential costs arising from this proposal can be absorbed with existing resources.
