#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Public Safety - Missouri Highway Patrol (MHP)** state there is additional information that would need to be collected such as the disability status of the individual, the English language proficiency of the individual, if a mental health professional was consulted, and if the driver was handcuffed before an arrest. Some of these, if not all, are currently captured in the narrative portion of reports but would need to be mandatory reporting to be compliant with the proposed legislation. Additionally, all reporting information on pedestrian stops would need to be added as we do no currently capture this data.

The following programming would be required to change/add the necessary fields and/or picklists to the field reporting forms to collect the necessary data to report. The interface between the field reporting application and the records management system would need to have programmatic changes to pass the necessary data to the records management system. The records management system would need to be modified to accept the new fields and data required to report the statistics. The reports and statistics analysis would also need to be changed to reflect and report the new data that is being collected and reported.

**Oversight** assumes that the MHP could potentially absorb some of the internal IT costs. Therefore, Oversight will reflect the cost as "Up to" the estimate provided by MHP.

Officials from the **Department of Public Safety - Office of the Director (DPS)** state there will be cost in developing the course outlined within subsection 590.650.1, but we do not know how much it will cost to consult with "...appropriate groups and individuals having an interest and expertise in the field of implicit bias, fair and impartial policing, civil rights, cultural awareness, and diversity." This could require several meetings with several groups. Including this, with the cost to develop a training program we are not able to ascertain a definitive fiscal impact. Thus,

### <u>ASSUMPTION</u> (continued)

DPS assumes a cost of unknown, under \$100,000 in FY 2018 to the General Revenue Fund.

Officials from the Attorney General's Office (AGO) did not respond to our request for fiscal impact. Therefore, **Oversight** will assume the AGO could implement the changes in this proposal with existing resources.

Officials from the **Department of Social Services - State Technical Assistance Team** and the **Department of Natural Resources** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Missouri Department of Conservation (MDC)** assume an unknown cost of less than \$100,000 for training and staff time for reporting requirements.

Officials from the **Springfield Police Department** state this would have a dramatic fiscal impact to their agency in staff time, and it is not possible to determine an amount. This bill is essentially asking for a police report on every single citizen contact, and the information being required to far too extensive to be captured on a "form" in the same manner as the Vehicle Stop data currently required by the state and submitted to the Attorney General by this agency.

Officials from the Boone County Sheriff's Department, the Columbia Police Department, the Platte County Sheriff's Department, the St. Joseph Police Department, and the St. Louis Metropolitan Police Department did not respond to **Oversight's** request for fiscal impact.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill requires every law enforcement agency in Missouri to adopt a policy prohibiting unlawful policing that provides for appropriate counseling and training for any peace officer found to have engaged in unlawful policing.

The bill also specifies what a peace officer must report each time he or she stops a driver of a motor vehicle or completes a pedestrian stop, what each law enforcement agency shall do with the data it receives from its peace officers, and what the Attorney General shall do with the data received from each law enforcement agency, as well as what the Attorney General shall require of law enforcement agencies that report significant disproportions.

The bill specifies that each law enforcement agency with more than 50 peace officers shall create a community partnership and comply with requirements specified in the bill. If a law enforcement agency fails to comply with the requirements for three consecutive years, the Attorney General shall order the jurisdiction or governing body the law enforcement agency serves to forfeit 10% of its annual general operating revenue received from fines, bond forfeitures, and court costs for traffic violations. The penalty shall continue until such time as the requirements are met.

The bill specifies that all law enforcement agency training shall be in accordance with Police Officer Standards and Training (POST) commission standards, and it specifies that POST shall develop and disseminate guidelines and training for peace officers.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
