AN ACT

To repeal section 302.186, RSMo, and to enact in lieu thereof one new section relating to driver's license renewals.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 302.186, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 302.186, to read as follows:

302.186. 1. Notwithstanding any other law, if the driver's license of any person expires while such person is on active duty in the Armed Forces of the United States, the license of such person shall be renewable, without examination, at any time prior to the end of the sixth month following the discharge of such person from the Armed Forces, or within ninety days after reestablished residence within the state, whichever time is sooner. Missouri residents on active duty in the Armed Forces of the United States or any dependent thereof age twenty-one or older residing outside the state of Missouri or the United States may renew their driver's license by mail.

2. **Notwithstanding any other law, if the driver's license of any person expires while such person is employed or otherwise engaged in business outside the jurisdiction of the United States, the license of such person shall be renewable, without examination, at any time prior to the end of sixth months following such person's return to the jurisdiction of the United States, or within ninety days after reestablishing residence within the state, whichever time is sooner. Missouri residents employed or otherwise engaged in business outside the jurisdiction of the United States or any dependent thereof age twenty-one or older residing outside the state of Missouri or the United States may renew their driver's license by mail.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18 **3. Notwithstanding any other law, if the driver's license of any person expires while**
19 **such person is enrolled in an institution of higher education outside of the state, the license**
20 **of such person shall be renewable, without examination, at any time prior to the end of**
21 **sixth months following such person's graduation, or within ninety days after reestablishing**
22 **residence within the state, whichever time is sooner. Missouri residents enrolled in an**
23 **institution of higher education outside of the state or any dependent thereof age twenty-one**
24 **or older residing outside the state of Missouri or the United States may renew their driver's**
25 **license by mail.**

26 **4.** The department of revenue may promulgate rules necessary to implement the
27 provisions of this section. Any rule or portion of a rule, as that term is defined in section
28 536.010, that is created under the authority delegated in this section shall become effective only
29 if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section
30 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the
31 general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove
32 and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority
33 and any rule proposed or adopted after August 28, 2011, shall be invalid and void.
