11 12 13 14 15	WHEREAS, like Mr. Donald J. Trump, Mr. Pruitt is committed to clean air and clean water, and to faithfully enforcing the environmental laws written by Congress. At the direction of Mr. Donald J. Trump, Mr. Pruitt will restore a thoughtful balance to the Environmental Protection Agency and will seek to preserve the environment in a responsible manner that will not unduly sacrifice our nation's economic well-being to appease the extreme left; and
