### AN ACT

To repeal sections 546.680, 546.690, 546.700, 546.710, 546.720, 546.730, 546.740, 546.750, 546.800, 546.810, 546.820, 565.004, 565.006, 565.020, 565.030, 565.032, 565.035, and 565.040, RSMo, and to enact in lieu thereof four new sections relating to repealing the death penalty, with a penalty provision.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 546.680, 546.690, 546.700, 546.710, 546.720, 546.730, 546.740, 546.750, 546.800, 546.810, 546.820, 565.004, 565.006, 565.020, 565.030, 565.032, 565.035, and 565.040, RSMo, are repealed and four new sections enacted in lieu thereof, to be known as sections 565.004, 565.006, 565.020, and 565.040, to read as follows:

565.004. 1. Each homicide offense which is lawfully joined in the same indictment or information together with any homicide offense or offense other than a homicide shall be charged together with such offense in separate counts. A count charging any offense of homicide may only be charged and tried together with one or more counts of any other homicide or offense other than a homicide as provided in subsection 2 of section 545.140. Except as provided in subsections 2, 3, and 4 of this section, no murder in the first degree offense may be tried together with any offense other than murder in the first degree. In the event of a joinder of homicide offenses, all offenses charged which are supported by the evidence in the case, together with all proper lesser offenses under section 565.029, shall, when requested by one of the parties or the court, be submitted to the jury or, in a jury-waived trial, considered by the judge.

2. A count charging any offense of homicide of a particular individual may be joined in an indictment or information and tried with one or more counts charging alternatively any other homicide or offense other than a homicide committed against that individual. The state shall not

14 be required to make an election as to the alternative count on which it will proceed. This  
15 subsection in no way limits the right to try in the conjunctive, where they are properly joined  
16 under subsection 1 of this section, either separate offenses other than murder in the first degree  
17 or separate offenses of murder in the first degree committed against different individuals.

18 3. When a defendant has been charged and proven before trial to be a prior offender  
19 pursuant to chapter 558 so that the judge shall assess punishment and not a jury for an offense  
20 other than murder in the first degree, that offense may be tried and submitted to the trier together  
21 with any murder in the first degree charge with which it is lawfully joined. In such case the  
22 judge will assess punishment on any offense joined with a murder in the first degree charge  
23 according to law and, when the trier is a jury, it shall be instructed upon punishment on the  
24 charge of murder in the first degree in accordance with section 565.030.

25 ~~[4. When the state waives the death penalty for a murder first degree offense, that offense~~  
26 ~~may be tried and submitted to the trier together with any other charge with which it is lawfully~~  
27 ~~joined.]~~

565.006. 1. At any time before the commencement of the trial of a homicide offense,  
2 the defendant may, with the assent of the court, waive a trial by jury and agree to submit all  
3 issues in the case to the court, whose finding shall have the force and effect of a verdict of a jury.  
4 Such a waiver must include a waiver of a trial by jury of all issues and offenses charged in the  
5 case, including the punishment to be assessed and imposed if the defendant is found guilty.

6 2. No defendant who pleads guilty to a homicide offense or who is found guilty of a  
7 homicide offense after trial to the court without a jury shall be permitted a trial by jury on the  
8 issue of the punishment to be imposed, except by agreement of the state.

9 3. ~~[If a defendant is found guilty of murder in the first degree after a jury trial in which~~  
10 ~~the state has not waived the death penalty, the defendant may not waive a jury trial of the issue~~  
11 ~~of the punishment to be imposed, except by agreement with the state and the court.]~~

12 ~~————4.]~~ Any waiver of a jury trial and agreement permitted by this section shall be entered  
13 in the court record.

565.020. 1. A person commits the crime of murder in the first degree if ~~[he]~~ **such**  
2 **person** knowingly causes the death of another person after deliberation upon the matter.

3 2. Murder in the first degree is a class A felony, and the punishment shall be ~~[either death~~  
4 ~~or]~~ imprisonment for life without eligibility for probation or parole, or release except by act of  
5 the governor~~]; except that, if a person has not reached his sixteenth birthday at the time of the~~  
6 ~~commission of the crime, the punishment shall be imprisonment for life without eligibility for~~  
7 ~~probation or parole, or release except by act of the governor].~~

565.040. ~~[1. In the event that the death penalty provided in this chapter is held to be~~  
2 ~~unconstitutional,]~~ Any person convicted of murder in the first degree ~~[shall be]~~ **and** sentenced

3 by the court to **death prior to August 28, 2017, shall be sentenced by the court to life**  
4 **imprisonment without eligibility for probation, parole, or release except by act of the governor**;  
5 ~~with the exception that when a specific aggravating circumstance found in a case is held to be~~  
6 ~~unconstitutional or invalid for another reason, the supreme court of Missouri is further authorized~~  
7 ~~to remand the case for resentencing or retrial of the punishment pursuant to subsection 5 of~~  
8 ~~section 565.035.~~

9 ~~2. In the event that any death sentence imposed pursuant to this chapter is held to be~~  
10 ~~unconstitutional, the trial court which previously sentenced the defendant to death shall cause~~  
11 ~~the defendant to be brought before the court and shall sentence the defendant to life~~  
12 ~~imprisonment without eligibility for probation, parole, or release except by act of the governor,~~  
13 ~~with the exception that when a specific aggravating circumstance found in a case is held to be~~  
14 ~~inapplicable, unconstitutional or invalid for another reason, the supreme court of Missouri is~~  
15 ~~further authorized to remand the case for retrial of the punishment pursuant to subsection 5 of~~  
16 ~~section 565.035].~~

2 ~~[546.680. When judgment of death is rendered by any court of competent~~  
3 ~~jurisdiction, a warrant signed by the judge and attested by the clerk under the seal~~  
4 ~~of the court must be drawn and delivered to the sheriff. It must state the~~  
5 ~~conviction and judgment and appoint a day on which the judgment must be~~  
6 ~~executed, which must not be less than thirty nor more than sixty days from the~~  
7 ~~date of judgment, and must direct the sheriff to deliver the defendant, at a time~~  
8 ~~specified in said order, not more than ten days from the date of judgment, to the~~  
9 ~~chief administrative officer of a correctional facility of the department of~~  
10 ~~corrections, for execution.]~~

2 ~~[546.690. The judge of a court at which a conviction is had must,~~  
3 ~~immediately after the conviction, transmit to the governor of the state, by mail or~~  
4 ~~otherwise, a statement of the conviction and judgment.]~~

2 ~~[546.700. Whenever, for any reason, any convict sentenced to the~~  
3 ~~punishment of death shall not have been executed pursuant to such sentence, and~~  
4 ~~the cause shall stand in full force, the supreme court, or the court of the county~~  
5 ~~in which the conviction was had, on the application of the prosecuting attorney,~~  
6 ~~shall issue a writ of habeas corpus to bring such convict before the court, or if he~~  
7 ~~be at large, a warrant for his apprehension may be issued by such court, or any~~  
8 ~~judge thereof.]~~

2 ~~[546.710. Upon such convicted offender being brought before the court,~~  
3 ~~they shall proceed to inquire into the facts, and if no legal reasons exist against~~  
4 ~~the execution of sentence, such court shall issue a warrant to the director of the~~

5

4 department of corrections, for the execution of the prisoner at the time therein  
5 specified, which execution shall be obeyed by the director accordingly.]  
6

2 [546.720. 1. The manner of inflicting the punishment of death shall be  
3 by the administration of lethal gas or by means of the administration of lethal  
4 injection. And for such purpose the director of the department of corrections is  
5 hereby authorized and directed to provide a suitable and efficient room or place,  
6 enclosed from public view, within the walls of a correctional facility of the  
7 department of corrections, and the necessary appliances for carrying into  
8 execution the death penalty by means of the administration of lethal gas or by  
9 means of the administration of lethal injection.

10 2. The director of the department of corrections shall select an execution  
11 team which shall consist of those persons who administer lethal gas or lethal  
12 chemicals and those persons, such as medical personnel, who provide direct  
13 support for the administration of lethal gas or lethal chemicals. The identities of  
14 members of the execution team, as defined in the execution protocol of the  
15 department of corrections, shall be kept confidential. Notwithstanding any  
16 provision of law to the contrary, any portion of a record that could identify a  
17 person as being a current or former member of an execution team shall be  
18 privileged and shall not be subject to discovery, subpoena, or other means of  
19 legal compulsion for disclosure to any person or entity, the remainder of such  
20 record shall not be privileged or closed unless protected from disclosure by law.  
21 The section of an execution protocol that directly relates to the administration of  
22 lethal gas or lethal chemicals is an open record, the remainder of any execution  
23 protocol of the department of corrections is a closed record.

24 3. A person may not, without the approval of the director of the  
25 department of corrections, knowingly disclose the identity of a current or former  
26 member of an execution team or disclose a record knowing that it could identify  
27 a person as being a current or former member of an execution team. Any person  
28 whose identity is disclosed in violation of this section shall:

29 (1) Have a civil cause of action against a person who violates this  
30 section;

31 (2) Be entitled to recover from any such person:

32 (a) Actual damages; and

33 (b) Punitive damages on a showing of a willful violation of this section.

34 4. Notwithstanding any provision of law to the contrary, if a member of  
35 the execution team is licensed by a board or department, the licensing board or  
36 department shall not censure, reprimand, suspend, revoke, or take any other  
37 disciplinary action against the person's license because of his or her participation  
38 in a lawful execution. All members of the execution team are entitled to  
39 coverage under the state legal expense fund established by section 105.711 for  
40 conduct of such execution team member arising out of and performed in  
connection with his or her official duties on behalf of the state or any agency of

41 the state, provided that moneys in this fund shall not be available for payment of  
42 ~~claims under chapter 287.~~  
43

2 ~~[546.730. A judgment of death must be executed within a correctional~~  
3 ~~center of the department of corrections; and such execution shall be under the~~  
4 ~~supervision and direction of the director of the department of corrections.]~~

2 ~~[546.740. The chief administrative officer of the correctional center, or~~  
3 ~~his duly appointed representative shall be present at the execution and the~~  
4 ~~director of the department of corrections shall invite the presence of the attorney~~  
5 ~~general of the state, and at least eight reputable citizens, to be selected by him;~~  
6 ~~and he shall at the request of the defendant, permit such clergy or religious~~  
7 ~~leaders, not exceeding two, as the defendant may name, and any person, other~~  
8 ~~than another incarcerated offender, relatives or friends, not to exceed five, to be~~  
9 ~~present at the execution, together with such peace officers as he may think~~  
10 ~~expedient, to witness the execution; but no person under twenty-one years of age~~  
11 ~~shall be allowed to witness the execution.]~~

2 ~~[546.750. After the execution the chief administrative officer of the~~  
3 ~~correctional facility shall make a return upon the death warrant to the court by~~  
4 ~~which the judgment was rendered, showing the time, mode and manner in which~~  
5 ~~it was executed.]~~

2 ~~[546.800. If, after any female convict shall be sentenced to the~~  
3 ~~punishment of death, the officer having charge of her person shall have reason~~  
4 ~~to suspect that she is pregnant, he shall in like manner summon a jury of six~~  
5 ~~persons, not less than three of whom shall be physicians, and shall give notice~~  
6 ~~thereof to the prosecuting attorney of the county where such criminal proceedings~~  
7 ~~originated, or to the circuit attorney of the city of St. Louis, if such criminal~~  
8 ~~proceedings originated in that city, who shall attend, and the proceedings shall~~  
9 ~~be had as provided.]~~

2 ~~[546.810. The inquisition shall be signed by the jury and the officer in~~  
3 ~~charge of such convict, and if it appear that such female convict is pregnant with~~  
4 ~~child, her execution shall be suspended and the inquisition shall be transmitted~~  
5 ~~to the governor.]~~

2 ~~[546.820. Whenever the governor shall be satisfied that the cause of such~~  
3 ~~suspension no longer exists, he shall issue his warrant, appointing a day for the~~  
4 ~~execution of such convict, pursuant to her sentence; or he may, at his discretion,~~  
5 ~~commute her punishment to imprisonment in the penitentiary for life.]~~

2           ~~[565.030. 1. Where murder in the first degree is charged but not~~  
3           ~~submitted or where the state waives the death penalty, the submission to the trier~~  
4           ~~and all subsequent proceedings in the case shall proceed as in all other criminal~~  
5           ~~cases.—~~

6           ~~2. Where murder in the first degree is submitted to the trier without a~~  
7           ~~waiver of the death penalty, the trial shall proceed in two stages before the same~~  
8           ~~trier. At the first stage the trier shall decide only whether the defendant is guilty~~  
9           ~~or not guilty of any submitted offense. The issue of punishment shall not be~~  
10           ~~submitted to the trier at the first stage. If an offense is charged other than murder~~  
11           ~~in the first degree in a count together with a count of murder in the first degree,~~  
12           ~~the trial judge shall assess punishment on any such offense according to law, after~~  
13           ~~the defendant is found guilty of such offense and after he finds the defendant to~~  
14           ~~be a prior offender pursuant to chapter 558.—~~

15           ~~3. If murder in the first degree is submitted and the death penalty was not~~  
16           ~~waived but the trier finds the defendant guilty of a lesser homicide, a second~~  
17           ~~stage of the trial shall proceed as in all other criminal cases. The attorneys may~~  
18           ~~then argue as in other criminal cases the issue of punishment, after which the trier~~  
19           ~~shall assess and declare the punishment as in all other criminal cases.—~~

20           ~~4. If the trier at the first stage of a trial where the death penalty was not~~  
21           ~~waived finds the defendant guilty of murder in the first degree, a second stage of~~  
22           ~~the trial shall proceed at which the only issue shall be the punishment to be~~  
23           ~~assessed and declared. Evidence in aggravation and mitigation of punishment,~~  
24           ~~including but not limited to evidence supporting any of the aggravating or~~  
25           ~~mitigating circumstances listed in subsection 2 or 3 of section 565.032, may be~~  
26           ~~presented subject to the rules of evidence at criminal trials. Such evidence may~~  
27           ~~include, within the discretion of the court, evidence concerning the murder victim~~  
28           ~~and the impact of the offense upon the family of the victim and others. Rebuttal~~  
29           ~~and surrebuttal evidence may be presented. The state shall be the first to proceed.~~  
30           ~~If the trier is a jury it shall be instructed on the law. The attorneys may then~~  
31           ~~argue the issue of punishment to the jury, and the state shall have the right to~~  
32           ~~open and close the argument. The trier shall assess and declare the punishment~~  
33           ~~at life imprisonment without eligibility for probation, parole, or release except by~~  
34           ~~act of the governor.—~~

35           ~~(1) If the trier finds by a preponderance of the evidence that the defendant~~

 48 ~~or verdict, set out in writing the aggravating circumstance or circumstances listed~~

 50 ~~the trier is a jury it shall be instructed before the case is submitted that if it is~~  
 51 ~~unable to decide or agree upon the punishment the court shall assess and declare~~

 63 ~~functioning with continual extensive related deficits and limitations in two or~~  
 64 ~~more adaptive behaviors such as communication, self-care, home living, social~~  
 65 ~~skills, community use, self-direction, health and safety, functional academics,~~  
 66 ~~leisure and work, which conditions are manifested and documented before~~  
 67 ~~eighteen years of age.—~~

68 ~~————— 7. The provisions of this section shall only govern offenses committed~~  
 69 ~~on or after August 28, 2001.]~~

2 ~~[565.032. 1. In all cases of murder in the first degree for which the death~~  
 3 ~~penalty is authorized, the judge in a jury-waived trial shall consider, or shall~~  
 4 ~~include in his or her instructions to the jury for it to consider:—~~

5 ~~————— (1) Whether a statutory aggravating circumstance or circumstances~~  
 6 ~~enumerated in subsection 2 of this section is established by the evidence beyond~~  
 7 ~~a reasonable doubt; and—~~

8 ~~————— (2) If a statutory aggravating circumstance or circumstances is proven~~  
 9 ~~beyond a reasonable doubt, whether the evidence as a whole justifies a sentence~~  
 10 ~~of death or a sentence of life imprisonment without eligibility for probation,~~  
 11 ~~parole, or release except by act of the governor.—~~

12 ~~————— In determining the issues enumerated in subdivisions (1) and (2) of this~~  
 13 ~~subsection, the trier shall consider all evidence which it finds to be in aggravation~~  
 14 ~~or mitigation of punishment, including evidence received during the first stage~~  
 15 ~~of the trial and evidence supporting any of the statutory aggravating or mitigating~~  
 16 ~~circumstances set out in subsections 2 and 3 of this section. If the trier is a jury,~~

19 any evidence which he or she considers to be aggravating or mitigating;—

20 ~~2. Statutory aggravating circumstances for a murder in the first degree~~  
21 ~~offense shall be limited to the following:—~~

22 ~~(1) The offense was committed by a person with a prior record of~~  
23 ~~conviction for murder in the first degree, or the offense was committed by a~~  
24 ~~person who has one or more serious assaultive criminal convictions;—~~

25 ~~(2) The murder in the first degree offense was committed while the~~  
26 ~~offender was engaged in the commission or attempted commission of another~~  
27 ~~unlawful homicide;—~~

28 ~~(3) The offender by his or her act of murder in the first degree knowingly~~  
29 ~~created a great risk of death to more than one person by means of a weapon or~~  
30 ~~device which would normally be hazardous to the lives of more than one person;—~~

31 ~~(4) The offender committed the offense of murder in the first degree for~~  
32 ~~himself or herself or another, for the purpose of receiving money or any other~~  
33 ~~thing of monetary value from the victim of the murder or another;—~~

34 ~~(5) The murder in the first degree was committed against a judicial~~  
35 ~~officer, former judicial officer, prosecuting attorney or former prosecuting~~  
36 ~~attorney, circuit attorney or former circuit attorney, assistant prosecuting attorney~~  
37 ~~or former assistant prosecuting attorney, assistant circuit attorney or former~~  
38 ~~assistant circuit attorney, peace officer or former peace officer, elected official or~~

40 ~~(6) The offender caused or directed another to commit murder in the first~~

43 ~~(7) The murder in the first degree was outrageously or wantonly vile,~~  
44 ~~horrible or inhuman in that it involved torture, or depravity of mind;—~~

45 ~~(8) The murder in the first degree was committed against any peace~~  
46 ~~officer, or fireman while engaged in the performance of his or her official duty;—~~

47 ~~(9) The murder in the first degree was committed by a person in, or who~~  
48 ~~has escaped from, the lawful custody of a peace officer or place of lawful~~

50 ~~(10) The murder in the first degree was committed for the purpose of~~  
51 ~~avoiding, interfering with, or preventing a lawful arrest or custody in a place of~~

54 ~~was engaged in the perpetration or was aiding or encouraging another person to~~  
55 ~~perpetrate or attempt to perpetrate a felony of any degree of rape, sodomy,~~

57 ~~(12) The murdered individual was a witness or potential witness in any~~  
58 ~~past or pending investigation or past or pending prosecution, and was killed as~~  
59 ~~a result of his or her status as a witness or potential witness;—~~

60 ~~————— (13) The murdered individual was an employee of an institution or~~  
 61 ~~facility of the department of corrections of this state or local correction agency~~  
 62 ~~and was killed in the course of performing his or her official duties, or the~~  
 63 ~~murdered individual was an inmate of such institution or facility;—~~

64 ~~————— (14) The murdered individual was killed as a result of the hijacking of an~~  
 65 ~~airplane, train, ship, bus or other public conveyance;—~~

66 ~~————— (15) The murder was committed for the purpose of concealing or~~  
 67 ~~attempting to conceal any felony offense defined in chapter 195 or 579;—~~

68 ~~————— (16) The murder was committed for the purpose of causing or attempting~~  
 69 ~~to cause a person to refrain from initiating or aiding in the prosecution of a felony~~  
 70 ~~offense defined in chapter 195 or 579;—~~

71 ~~————— (17) The murder was committed during the commission of an offense~~  
 72 ~~which is part of a pattern of criminal street gang activity as defined in section~~  
 73 ~~578.421.—~~

74 ~~————— 3. Statutory mitigating circumstances shall include the following:—~~

75 ~~————— (1) The defendant has no significant history of prior criminal activity;—~~

76 ~~————— (2) The murder in the first degree was committed while the defendant~~  
 77 ~~was under the influence of extreme mental or emotional disturbance;—~~

78 ~~————— (3) The victim was a participant in the defendant's conduct or consented~~  
 79 ~~to the act;—~~

80 ~~————— (4) The defendant was an accomplice in the murder in the first degree~~  
 81 ~~committed by another person and his or her participation was relatively minor;—~~

82 ~~————— (5) The defendant acted under extreme duress or under the substantial~~  
 83 ~~domination of another person;—~~

84 ~~————— (6) The capacity of the defendant to appreciate the criminality of his or~~  
 85 ~~her conduct or to conform his or her conduct to the requirements of law was~~  
 86 ~~substantially impaired;—~~

87 ~~————— (7) The age of the defendant at the time of the offense.]~~

2 ~~[565.035. 1. Whenever the death penalty is imposed in any case, and~~  
 3 ~~upon the judgment becoming final in the trial court, the sentence shall be~~  
 4 ~~reviewed on the record by the supreme court of Missouri. The circuit clerk of the~~  
 5 ~~court trying the case, within ten days after receiving the transcript, shall transmit~~  
 6 ~~the entire record and transcript to the supreme court together with a notice~~  
 7 ~~prepared by the circuit clerk and a report prepared by the trial judge. The notice~~  
 8 ~~shall set forth the title and docket number of the case, the name of the defendant~~  
 9 ~~and the name and address of his attorney, a narrative statement of the judgment,~~  
 10 ~~the offense, and the punishment prescribed. The report by the judge shall be in~~  
 11 ~~the form of a standard questionnaire prepared and supplied by the supreme court~~  
 12 ~~of Missouri.—~~

13 ~~————— 2. The supreme court of Missouri shall consider the punishment as well~~  
 14 ~~as any errors enumerated by way of appeal.—~~
