

## HCS SB 686 Transportation w/ committee amendments

Bill Number	Section	Sponsor	Summary
SB 686	301.030	Sater	This act specifies that fees for the renewal of noncommercial motor vehicle registrations shall be payable no later than the last day of the month that follows the final month of the expired registration period. No renewal penalty shall be assessed, and no violation for expired registration shall be issued, until the second month that follows the expired registration period.
HB 1333	137.115; 143.441; 144.805; 305.800; 305.802; 305.804; 305.806; 305.808; 305.810	Sharpe	<p>This bill makes changes to statutes pertaining to aircraft. Increases the number of hours of operation per year a noncommercial aircraft at least 25 years old can fly from less than 50 hours to less than 200 hours in order to be assessed and valued at 5% of the aircraft's true value for property tax purposes. Defines "Qualified air freight forwarders" and adds it to the definition of "corporation" as a transportation corporation for the purposes of corporate income allocation.</p> <p>If a derelict aircraft or abandoned aircraft is on airport property, the airport superintendent shall make a record of the date the aircraft was discovered on the airport and inquire as to the name and address of any person having an equitable or legal interest in the aircraft by either contacting the Federal Aviation Administration, aircraft registration branch, or contacting an aircraft title search company. Within 10 business days of receiving the information the airport superintendent shall notify the owner and all other interested parties by certified mail. The airport superintendent may remove the aircraft in less than 30 calendar days if the aircraft poses a danger to the health or safety of users of the airport. If the aircraft is not removed from the airport and all fees and charges paid in full all or shown reasonable cause for the failure to do so within 30 calendar days, the airport superintendent may take action. The bill also contains procedures for the sale or other disposition of the aircraft and for the perfection and release of liens by the airport superintendent.</p>
HB 1334	302.205	Kelley (127)	Allows a resident of Missouri to have a medical alert notation placed on his or her driver's license or nondriver's identification card. The applicant must sign a waiver for the release of medical information and provide a sworn statement with the applicant's diagnosis from a physician or psychologist. Parental consent is required for anyone under 18 years of age. This bill has a delayed effective date of July 31, 2021.
HB 1403	230.205	Hudson	<p>A county that has adopted the alternative county highway commission under Sections 230.200 to 230.260, RSMo, may only abolish it by a vote of the people. This bill adds by a vote of the governing body as an additional method.</p> <p>Currently, once abolished, or in counties that did not adopt the alternative county highway commission, the county shall retain the county highway commission under Sections 230.010 to 230.110. This bill allows the county to adopt the county highway commission or the county road overseers provided under Sections 231.010 to 231.130.</p>

HB 1418	32.056	McGill	Includes anyone employed by the Department of Corrections, corrections officers, and jailers to the list of persons whose home address and vehicle information is to be kept confidential by the Department of Revenue under Section 32.056, RSMo.
HB 1473	301.3069; 301.3159; 301.3174	Hudson	<p>Authorizes a special license plate with the official emblem of the Central Missouri Honor Flight. The license plate requires an annual \$25 contribution for emblem use to Central Missouri Honor Flight. Criteria for the license plate design submitted by Central Missouri Honor Flight are specified in the bill. Previously issued special plates must be reauthorized with the \$25 contribution fee to have a plate with the emblem. The contributions shall be used solely for reasonable administrative costs and financial assistance to transport veterans to Washington D.C. to view various veteran memorials.</p> <p>Authorizes a special license plate for recipients of the Meritorious Service Medal. The license plate requires an additional fee equal to the fee for personalized license plates. The plates will bear an image of the Meritorious Service Medal with the words "MERITORIOUS SERVICE" in place of the words "SHOW-ME STATE".</p> <p>The Association of Missouri Electric Cooperatives authorizes the use of its official lineman image emblem on personalized license plates, except for license plates for an apportioned motor vehicle or commercial motor vehicle licensed in excess of 24,000 pounds gross weight. This exception is removed and allows these plates to be issued for any non-apportioned vehicles for which a license plate or plates is issued.</p>
HB 1488	577.011	Bromley	Requires a person who has pled guilty to or been found guilty of driving while intoxicated to complete a victim impact program approved by the court, except for good cause shown, and makes him or her responsible for any charges imposed by the program.
HB 1641	301.010	Taylor	Removes from the definition of "autocycle" the provision that it is designed to be controlled with a steering wheel and pedals.
HB 1744	302.171	Sommer	Requires the Department of Revenue to accept electronic versions of documents used to verify the Missouri residency of an applicant for a Missouri driver's license.

<p>HB 1800</p>	<p>136.055; 301.451</p>	<p>Morris</p>	<p>Requires the Director of the Department of Revenue to award fee office contracts through a competitive bidding process and to give preference to certain factors, such as Missouri not-for-profit corporations, persons and entities that reinvest at least 75% of net proceeds to charitable organizations in the state, and persons or entities that are based in a location near the fee office location.</p> <p>If the department utilizes a scoring mechanism to evaluate bids, the scoring mechanism must ensure that:</p> <ol style="list-style-type: none"> <li>(1) A person or entity based no more than 35 miles from the fee office location shall be awarded a bonus 15% of the total available points;</li> <li>(2) A person or entity based more than 35 miles but no more than 60 miles from the fee office location shall be awarded a bonus of 10% of the total available points;</li> <li>(3) A person or entity that is a resident of the state, as defined in the bill, shall be awarded a bonus of 10% of the total available points; and</li> <li>(4) A person or entity based more than 60 miles but no more than 75 miles from the fee office location shall be awarded a bonus of 7% of the total available points.</li> </ol> <p>No fee office contract shall be awarded to any person or entity that is not in compliance with the established rules. The department shall not consider for a contract award any entity that has not be registered with the Secretary of State for at least one year.</p> <p>Currently, Purple Heart recipients may receive specialty Purple Heart license plates by paying the regular registration fees and may not be charged an additional fee. This bill allows for the issuance of two sets of these specialty license plates. The first set of plates shall be issued without a fee and only the regular registration fee shall apply to any additional set of plates. Additionally, in the event of the death of a Purple Heart recipient, the co-owner of the motor vehicle who was also the spouse</p>
<p>HB 1898</p>	<p>217.850; 577.800; 632.460</p>	<p>Henderson</p>	<p>Creates the offense of unlawful use of an unmanned aircraft near a correctional center, mental health hospital, or certain open air facilities, including sports stadiums holding 5,000 or more within a distance of 400 feet or allows an unmanned aircraft to make contact with these places including any person or object on the premises of or within the facility. Exceptions to the offense include a law enforcement agency, fire department, or utility company under specified circumstances.</p> <p>Use of an unmanned aircraft near a correctional center or mental health hospital is an infraction.</p> <p>Use of an unmanned aircraft in these facilities to:</p> <ol style="list-style-type: none"> <li>(1) deliver a weapon or item that may be used in a manner to endanger the life of an offender or correctional center or mental health hospital employee is a class B felony;</li> <li>(2) Facilitating an escape from confinement is a class C felony; or</li> <li>(3) Deliver a controlled substance is a class D felony.</li> </ol> <p>Each correctional center or mental health hospital shall post a sign of the provisions of the offense. The sign must be at least 11" by 14" and be posted in a conspicuous location.</p> <p>Unlawful use of an unmanned aircraft near an open air facility is a class A misdemeanor.</p> <p>Use of an unmanned aircraft in an open air facility for</p> <ol style="list-style-type: none"> <li>(1) Delivering a weapon or item may be used in such a manner to endanger the life of an employee or guest is a class B felony;</li> <li>(2) Delivering a controlled substance, in which case it is a class D felony</li> </ol>

HB 1912	407.1329	Bailey	Currently, a recreation vehicle (RV) manufacturer must repurchase new, untitled RVs from the current and prior model year from an RV dealer when the dealer agreement is terminated, canceled, or not renewed by the manufacturer for cause. This bill modifies such repurchase to include voluntary dealer terminations within the RV dealer agreement, discontinuation of a franchise or line-make, distributor changes, and ceasing to do business in the state. The repurchase requirement is limited to new, untitled recreation vehicle inventory acquired from the manufacturer in the previous 18 months that has not been altered or damaged at 100% of the net invoice cost, including transportation, less applicable rebates and discounts to the dealer.
HB 1935	306.127	Miller	Currently, a person or company that rents or sells vessels may issue a temporary boating safety identification card to an individual to operate a rented vessel or one that is being considered for sale. This provision expires December 31, 2022. The bill changes the expiration date to December 31, 2032.
HB 1959	301.576	Ruth	This bill provides that a motor vehicle dealer and persons or entities affiliated with the dealer who, in conjunction with the actual or potential sale or lease of a motor vehicle, provides or makes available to the vehicle purchaser or lessee a third-party motor vehicle report as defined in the bill is exempt from liability to the purchaser or lessee for any errors, omissions, or inaccuracies contained in the report that are not based upon information provided directly to the preparer of the report by the dealer. The exemption from liability does not apply in the case of any dealer having actual knowledge about a vehicle's accident, salvage, or service history which is different from, or not
HB 1963 (I Version)	227.600	Fitzwater	This bill defines a "tube transport system" as a high-speed transportation system, including infrastructure and facilities, in which pressurized pods containing passengers or freight ride or coast upon a cushion of air through magnetic levitation within a reduced-pressure or vacuum tube, propelled by electric power, and adds "tube transport system" to the types of projects that are eligible for a public-private partnership.
HB 2032	407.1025, 407.1028, 407.1031, 407.1034, 407.1035, 407.1037, 407.1043, 407.1047, and 407.1049	Ruth	This bill defines powersport vehicles to include motorcycles, allterrain vehicles, motorized bicycles, motortricycles, recreational off-highway vehicles, and utility vehicles. These powersport vehicles will all be subject to the vehicle franchising practices rules under Chapter 407, RSMo. Currently, only motorcycles and all-terrain vehicles are regulated under that chapter.
HB 2128	304.170, 304.172, and 304.180	Rone	Exempts vehicles towing trailers specifically designed to carry harvested cotton with a total length of not more than 93 feet from the size and length requirements for vehicles traveling on the state highways. The vehicle can also be used to transport hay within the state to areas affected by drought. Currently, vehicle regulations relating to height, width, weight, length, and load restrictions for motor vehicles do not apply to emergency vehicles. The bill also removes the exemption as to weight and

HB 2190	302.020	Taylor	Currently, all persons who operate or ride as a passenger on a motorcycle or motortricycle are required to wear protective headgear. This bill changes the restriction to apply only to persons under the age of 18, and persons 18 years and older who have instruction permits. Qualified motorcycle operators who are 18 years of age or older may operate a motorcycle or motortricycle without protective headgear if he or she, in addition to maintaining proof of financial responsibility, is covered by health insurance with medical benefits for injuries incurred as a result of an accident <del>while operating or riding on a motorcycle or motortricycle.</del>
HB2199	307.179	Gannon	This bill requires child restraint seats to be rear facing for children under two years of age.
HB 2249	301.3159	Bayse	This bill authorizes a special license plate for any recipient of the Meritorious Service Medal and provides proof as required by the Department of Revenue. The license plate will require an additional fee equal to the fee charged for personalized license plates. The plates will bear an image of the of the Meritorious Service Medal with the wo
HB 2280	32.450	Tate	This bill authorizes the Department of Revenue to implement a secure digital driver's license program so that applicants for a driver's license can receive a digital license as well as a physical card-based license. The digital license will be acceptable for all purposes that a card license is used. The department may contract with another entity to develop the digital license and may itself develop software that would allow a driver to access an image of his or her digital license. The digital license may be suspended, disabled, or terminated if the person's driving privilege is otherwise suspended, revoked, denied, withdrawn, or canceled under Chapter 302,RSMo, or the person's electronic device on which the digital license is viewed is lost, stolen, or otherwise compromised.
HB 2334	68.075	Ruth	Currently, no advanced industrial manufacturing (AIM) zone may be established after August 28, 2023. This bill extends the date to August 28, 2030.
HB 2444	301.032	Ruth	This bill specifies that registration fees for vehicles in the registered fleet owner's fleet will be fully payable at the time the plates are ordered, except if the plate is ordered after the first month of registration, the fees will be prorated by the month the plates were ordered. If biennial registration is requested, an additional year's annual fee will be added to the partial year's prorated fee.
HCA 1 (3809H03.02H )	302.768	Hicks	During a national state of emergency related to a pandemic or outbreak of contagious disease declared by the president of the United States, the requirements that an applicant certifying to operate in nonexcepted interstate commerce or nonexcepted intrastate commerce provide or renew a medical certification shall be waived so long as the applicant conforms to the requirements of subsections 4 and 6 within ninety days after the end of the national state of emergency

HCA 2 (3809H03.06H )	301.3139	O'Donnell	Adds HB 1704(O'Donnell) BOY SCOUTS OF AMERICA LICENSE PLATE Currently, an organization is required to send a list of at least 200 potential applicants who plan to purchase a specialty plate before such a specialty plate will be issued. This bill removes this requirement for Boy Scouts of America specialty license plates.
HCA 3 (3809H03.01H )	227.479 and 227.485	Anderson	Adds HB 2543 (Anderson) DEPUTY SHERIFF AARON P ROBERTS MEMORIAL HIGHWAY Adds HB 2129 (Rone) DUANE S MICHIE MEMORIAL HIGHWAY
