306.127 (Original underlying bill)	SB 782		Brown	Currently, a person or company that rents or sells vessels may issue a temporary boating safety identification card to an individual to operate a rented vessel or one that is being considered for sale. This provision expires December 31, 2022. The bill changes the expiration date to December 31, 2032.

32.300, 302.170, 302.181	SB 906	Hearing Conducted S Transportation, Infrastructure & Public Safety Committee 3/12/20	Libla	<p>Authorizes the DOR to design and implement a remote driver's license renewal system accessible through the Department's internet website connection or through one or more self-service terminals located within the state. The system shall comply with federal law; drivers may apply for no more than one consecutive renewal remotely, and shall apply within six months before or after the license expires as required for conventional renewal. Applicants for remote renewal are not required to complete the vision test or highway sign test unless there is technology for testing remotely.</p> <p>Removes "facial feature pattern characteristics" and "eye spacing" from the definition of biometric data, repeals the requirement for the department to store retained driver's license application documents on a system isolated from the internet and to purge the documents from previous systems on which they were stored. The bill allows the DOR to retain documents at the request of and for the convenience of an applicant regardless of whether the applicant requests that the department review alternative documents as proof required for issuance of a license, and allows the department to use digital images and license signatures as required for the use of software for purposes of combating fraud.</p> <p>Repeals obsolete references to Social Security numbers, and updates references to film photography to reflect the use of digital images.</p> <p>Authorizes the DOR to design/implement a secure digital driver's license program that allows license applicants to obtain a digital driver's license in addition to a card-based license. The digital license shall be accepted for all purposes for which a card-based license is used. The department may contract with one or more entities to develop the digital driver's license system, and the Department or entities may develop a mobile software application capable of being utilized through a person's electronic device to access the person's digital driver's license. The Department shall suspend, disable, or terminate a person's participation in the digital driver's license program if the driver's driving privilege is suspended, revoked, denied, withdrawn, or cancelled as provided by law, or if the person reports their electronic device has been lost, stolen, or compromised.</p>

136.055; 301.451	HB 1800	Referred: Veterans and Military Affairs (S) 3/12/20	Morris	<p>Requires the Director of the Department of Revenue to award fee office contracts through a competitive bidding process and to give preference to certain factors, such as Missouri not-for-profit corporations, persons and entities that reinvest at least 75% of net proceeds to charitable organizations in the state, and persons or entities that are based in a location near the fee office location.</p> <p>If the department utilizes a scoring mechanism to evaluate bids, the scoring mechanism must ensure that:</p> <ul style="list-style-type: none"> (1) A person or entity based no more than 35 miles from the fee office location shall be awarded a bonus 15% of the total available points; (2) A person or entity based more than 35 miles but no more than 60 miles from the fee office location shall be awarded a bonus of 10% of the total available points; (3) A person or entity that is a resident of the state, as defined in the bill, shall be awarded a bonus of 10% of the total available points; and (4) A person or entity based more than 60 miles but no more than 75 miles from the fee office location shall be awarded a bonus of 7% of the total available points. <p>No fee office contract shall be awarded to any person or entity that is not in compliance with the established rules. The department shall not consider for a contract award any entity that has not been registered with the Secretary of State for at least one year.</p> <p>Currently, Purple Heart recipients may receive specialty Purple Heart license plates by paying the regular registration fees and may not be charged an additional fee. This bill allows for the issuance of two sets of these specialty license plates. The first set of plates shall be issued without a fee and only the regular registration fee shall apply to any additional set of plates. Additionally, in the event of the death of a Purple Heart recipient, the co-owner of the motor vehicle who was also the spouse of the deceased may use and renew the license plates until he or she remarries or, if they do not remarry, for the remainder of their life.</p>

Increases the number of hours of operation per year a noncommercial aircraft at least 25 years old can fly from less than 50 hours to less than 200 hours in order to be assessed and valued at 5% of the aircraft's true value for property tax purposes. Defines "Qualified air freight forwarders" and adds it to the definition of "corporation" as a transportation corporation for the purposes of corporate income allocation. If a derelict aircraft or abandoned aircraft is on airport property, the airport superintendent shall make a record of the date the aircraft was discovered on the airport and inquire as to the name and address of any person having an equitable or legal interest in the aircraft by either contacting the Federal Aviation Administration, aircraft registration branch, or contacting an aircraft title search company. Within 10 business days of receiving the information the airport superintendent shall notify the owner and all other interested parties by certified mail. The airport superintendent may remove the aircraft in less than 30 calendar days if the aircraft poses a danger to the health or safety of users of the airport. If the aircraft is not removed from the airport and all fees and charges paid in full all or shown reasonable cause for the failure to do so within 30 calendar days, the airport superintendent may take action. The bill also contains procedures for the sale or other disposition of the aircraft and for the perfection and release of liens by the airport superintendent.</p>
<p>144.070, 227.600, 301.030</p>	<p>SCS/HB 1963</p>	<p>Referred: Fiscal Oversight (S) 5/4/20</p>	<p>Fitzwater</p>	<p>Provides that registered fleet owners of rental or lease motor vehicles, rather than vehicle lease or rental companies, shall post a bond with the Department of Revenue upon applying for a license to operate. Modifies the Missouri Public-Private Partnerships Transportationbill to authorize the Missouri Highways and Transportation Commission to form a public-private partnership to construct a "tube transport system", as defined in the bill. The power of eminent domain shall not apply to a tube transport system. The provisions of a tube transport system authorized under the bill shall sunset on August 28, 2025, unless reauthorized by the General Assembly in subsequent 5-year periods. Specifies that fees for the renewal of noncommercial motor vehicle registrations shall be payable no later than the last day of the month that follows the final month of the expired registration period. No renewal penalty shall be assessed, and no violation for expired registration shall be issued, until the second month that follows the expired registration period.</p>

The digital license shall be accepted for all purposes for which a card-based license is used. The Department may contract with one or more entities to develop the digital driver's license system, and the Department or entities may develop a mobile software application capable of being utilized through a person's electronic device to access the person's digital driver's license. If biennial registration is requested, an additional year's annual fee will be added to the partial year's prorated fee.
301.560, 301.564	HB 1489	Pub Hrg Completed, Special Comm on Homeland Security (H) 3/3/20	Wood	Replaces certain references to officers of the Missouri State Water Patrol with references to "authorized or designated employees" of the Missouri State Highway Patrol. The changes are made in a statute regarding the certification of a boat manufacturer's or boat dealer's bona fide place of business, and in a statute regarding the inspection of certain documents and records.
301.576	HCS/HB 1959	Public Hearing Held; Transp, Infrastructure & Pub Safety (S) 4/30/20	Ruth	This bill provides that a motor vehicle dealer and persons or entities affiliated with the dealer who, in conjunction with the actual or potential sale or lease of a motor vehicle, provides or makes available to the vehicle purchaser or lessee a third-party motor vehicle report as defined in the bill is exempt from liability to the purchaser or lessee for any errors, omissions, or inaccuracies contained in the report that are not based upon information provided directly to the preparer of the report by the dealer. The exemption from liability does not apply in the case of any dealer having actual knowledge about a vehicle's accident, salvage, or service history which is different from, or not disclosed on, any third-party motor vehicle report.
301.3069; 301.3159; 301.3174	HB 1473	Public Hearing Held; Transp, Infrastructure & Pub Safety (S) 4/30/20	Griffith	<p>Authorizes a special license plate with the official emblem of the Central Missouri Honor Flight. The license plate requires an annual \$25 contribution for emblem use to Central Missouri Honor Flight. Criteria for the license plate design submitted by Central Missouri Honor Flight are specified in the bill. Previously issued special plates must be reauthorized with the \$25 contribution fee to have a plate with the emblem. The contributions shall be used solely for reasonable administrative costs and financial assistance to transport veterans to Washington D.C. to view various veteran memorials.</p> <p>Authorizes a special license plate for recipients of the Meritorious Service Medal. The license plate requires an additional fee equal to the fee for personalized license plates. The plates will bear an image of the Meritorious Service Medal with the words "MERITORIOUS SERVICE" in place of the words "SHOW-ME STATE".</p> <p>The Association of Missouri Electric Cooperatives authorizes the use of its official lineman image emblem on personalized license plates, except for license plates for an apportioned motor vehicle or commercial motor vehicle licensed in excess of 24,000 pounds gross weight. This exception is removed and allows these plates to be issued for any non-apportioned vehicles for which a license plate or plates is issued.</p>
301.3139	HB 1704	Dropped from Calendar - Per House Rules (H) 3/18/20	O'Donnell	Currently, an organization is required to send a list of at least 200 potential applicants who plan to purchase a specialty plate before such a specialty plate will be issued. This bill removes this requirement for Boy Scouts of America specialty license plates.

301.3176	HB 2429	Read Second Time (H) 2/12/20	Griesheimer	This bill allows for the issuance of a "Backstoppers" specialty license plate upon making a \$10 contribution to the Backstoppers General Operating Fund or to the Backstoppers Education Fund, and a \$15 fee in addition to the regular registration fee.
302.171	HB 1744	Referred: Transportation, Infrastructure and Public Safety (S)	Sommer	Requires the Department of Revenue to accept electronic versions of documents used to verify the Missouri residency of an applicant for a Missouri driver's license.
302.188	HB 1607	Public Hearing Completed, Transp. (H) 3/12/20	Black (137)	Currently, a veteran may have a veteran designation placed on his or her driver's license if he or she provides specified information. Currently, it is up to the Department of Revenue to determine where the designation appears on the license. This bill requires the Department to place the designation on the front of the driver's license.
302.205	HCS HB 1334	Public Hearing Held; Transp, Infrastructure & Pub Safety (S) 4/30/20	Kelley (127)	Allows a resident of Missouri to have a medical alert notation placed on his or her driver's license or nondriver's identification card. The applicant must sign a waiver for the release of medical information and provide a sworn statement with the applicant's diagnosis from a physician or psychologist. Parental consent is required for anyone under 18 years of age. This bill has a delayed effective date of July 31, 2021.
304.170, 304.172, and 304.180	HCS HB 2128	Referred: Transportation, Infrastructure & Public Safety (S) 4/7/20	Rone	Exempts vehicles towing trailers specifically designed to carry harvested cotton with a total length of not more than 93 feet from the size and length requirements for vehicles traveling on the state highways. The vehicle can also be used to transport hay within the state to areas affected by drought. Currently, vehicle regulations relating to height, width, weight, length, and load restrictions for motor vehicles do not apply to emergency vehicles. The bill also removes the exemption as to weight and load restrictions.
407.1329	HCS/HB 1912	Public Hearing Held; Transp, Infrastructure & Pub Safety (S) 4/30/20	Bailey	Currently, a recreation vehicle (RV) manufacturer must repurchase new, untitled RVs from the current and prior model year from an RV dealer when the dealer agreement is terminated, canceled, or not renewed by the manufacturer for cause. This bill modifies such repurchase to include voluntary dealer terminations within the RV dealer agreement, discontinuation of a franchise or line-make, distributor changes, and ceasing to do business in the state. The repurchase requirement is limited to new, untitled recreation vehicle inventory acquired from the manufacturer in the previous 18 months that has not been altered or damaged at 100% of the net invoice cost, including transportation, less applicable rebates and discounts to the dealer.
