### Missouri House Forms Special Interim Committee to Take on Property Tax Reform

**JEFFERSON CITY, Mo.** – The Missouri House of Representatives is announcing the formation of the Special Interim Committee on Property Tax Reform, a newly created panel tasked with examining Missouri’s property tax system and recommending solutions to ensure fairness, transparency, and sustainability for taxpayers and municipalities across the state.

House Speaker Jon Patterson has appointed Rep. Tim Taylor to serve as Chair of the committee and Rep. Rodger Reedy as Vice-Chair. Rep. Kathy Steinhoff will serve as the Ranking Minority Member.

“This committee will take a thorough and thoughtful approach to reviewing Missouri’s property tax laws and hearing directly from residents and stakeholders across the state,” Speaker Patterson, R-Lee’s Summit, said. “Our goal is to find common-sense reforms that protect homeowners, promote economic stability, and ensure accountability.”

“Property taxes are one of the most common concerns we hear from Missourians, and it’s clear that our system needs a closer look,” Chairman Taylor, R-Bunceton, said. “This committee is committed to listening to the people, identifying the problems, and working toward meaningful reforms that ensure fairness and predictability for taxpayers in every corner of our state.”

The committee will hold a series of public hearings throughout the summer to gather input and explore legislative solutions. The scheduled hearing dates and locations are as follows:

- **July 16 – Jefferson City in House Hearing Room 3 at the State Capitol**

- **September 3 – Jefferson City**

Final locations for the July 30, August 13, and August 20 hearings will be announced soon and are expected to include St. Louis, Kansas City, and Chillicothe.
