AN ACT

To repeal section 301.058, RSMo 2000, relating to registration fees for property-carrying local commercial motor vehicles, and to enact in lieu thereof one new section relating to the same subject.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 301.058, RSMo 2000, is repealed and one new section enacted in lieu 2 thereof, to be known as section 301.058, to read as follows:

301.058. 1. The annual registration fee for property-carrying local commercial motor
vehicles, other than a land improvement contractors' commercial motor vehicles, based on gross
weight is:
