### AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to special license plates.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be  
2 known as section 301.3113, to read as follows:

**301.3113. 1. Any current member or alumnus of Delta Sigma Phi Greek  
2 organization may receive special license plates as prescribed by this section, for any motor  
3 vehicle such person owns, either solely or jointly, other than an apportioned motor vehicle  
4 or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight,  
5 after an annual payment of an emblem-use authorization fee to Delta Sigma Phi of which  
6 the person is a member. Delta Sigma Phi hereby authorizes the use of its official emblem  
7 to be affixed on multiyear personalized license plates as provided in this section. Any  
8 contribution to Delta Sigma Phi derived from this section, except reasonable administrative  
9 costs, shall be used solely for the purposes of Delta Sigma Phi. Any current member or  
10 alumnus of Delta Sigma Phi may annually apply for the use of the emblem.**

**11 2. Upon annual application and payment of a twenty-five dollar emblem-use  
12 contribution to Delta Sigma Phi, the organization shall issue to the vehicle owner, without  
13 further charge, an emblem-use authorization statement, which shall be presented by the  
14 owner to the department of revenue at the time of registration of a motor vehicle. Upon  
15 presentation of the annual statement, payment of a fifteen dollar fee in addition to the  
16 registration fee and documents which may be required by law, the department of revenue  
17 shall issue to the vehicle owner a personalized license plate which shall bear the emblem  
18 of Delta Sigma Phi and shall bear the words "DELTA SIGMA PHI" in place of the words**

19 **"SHOW-ME STATE". Such license plates shall be made with fully reflective material**  
20 **with a common color scheme and design, shall be clearly visible at night, and shall be**  
21 **aesthetically attractive, as prescribed by section 301.130. Notwithstanding the provisions**  
22 **of section 301.144, no additional fee shall be charged for the personalization of license**  
23 **plates pursuant to this section.**

24 **3. A vehicle owner, who was previously issued a plate with the Delta Sigma Phi**  
25 **emblem authorized by this section but who does not provide an emblem-use authorization**  
26 **statement at a subsequent time of registration, shall be issued a new plate which does not**  
27 **bear the Delta Sigma Phi emblem, as otherwise provided by law. The director of revenue**  
28 **shall make necessary rules and regulations for the administration of this section, and shall**  
29 **design all necessary forms required by this section. No rule or portion of a rule**  
30 **promulgated pursuant to the authority of this section shall become effective unless it has**  
31 **been promulgated pursuant to the provisions of chapter 536, RSMo.**
