JOINT RESOLUTION

Submitting to the qualified voters of Missouri an amendment repealing section 39 of article III of the Constitution of Missouri, and adopting two new sections in lieu thereof relating to gaming.

Be it resolved by the House of Representatives, the Senate concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2004, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article III of the Constitution of the state of Missouri:

Section A. Section 39, article III, Constitution of Missouri, is repealed and two new sections adopted in lieu thereof, to be known as sections 39 and 39(g), to read as follows:

Section 39. The general assembly shall not have power:

- (1) To give or lend or to authorize the giving or lending of the credit of the state in aid or to any person, association, municipal or other corporation;
- (2) To pledge the credit of the state for the payment of the liabilities, present or prospective, of any individual, association, municipal or other corporation;
- (3) To grant or to authorize any county or municipal authority to grant any extra compensation, fee or allowance to a public officer, agent, servant or contractor after service has been rendered or a contract has been entered into and performed in whole or in part;

EXPLANATION — Matter enclosed in bold faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law. Matter in boldface type in the above law is proposed language.

11 (4) To pay or to authorize the payment of any claim against the state or any county or
12 municipal corporation of the state under any agreement or contract made without express
13 authority of law;

14 (5) To release or extinguish or to authorize the releasing or extinguishing, in whole or
15 in part, without consideration, the indebtedness, liability or obligation of any corporation or
16 individual due this state or any county or municipal corporation;

17 (6) To make any appropriation of money for the payment, or on account of or in
18 recognition of any claims audited or that may hereafter be audited by virtue of an act entitled "An
19 Act to Audit and Adjust the War Debts of the State," approved March 19, 1874, or any act of a
20 similar nature, until the claim so audited shall have been presented to and paid by the
21 government of the United States to this state;

22 (7) To act, when convened in extra session by the governor, upon subjects other than
23 those specially designated in the proclamation calling said session or recommended by special
24 message to the general assembly after the convening of an extra session;

25 (8) To remove the seat of government from the City of Jefferson;

26 (9) Except as otherwise provided in section 39(b), section 39(c), section 39(e) [or],
27 section 39(f), **or section 39(g)** of this article, to authorize lotteries or gift enterprises for any
28 purpose, and shall enact laws to prohibit the sale of lottery or gift enterprise tickets, or tickets in
29 any scheme in the nature of a lottery; except that, nothing in this section shall be so construed
30 as to prevent or prohibit citizens of this state from participating in games or contests of skill or
31 chance where no consideration is required to be given for the privilege or opportunity of
32 participating or for receiving the award or prize and the term "lottery or gift enterprise" shall
33 mean only those games or contests whereby money or something of value is exchanged directly
34 for the ticket or chance to participate in the game or contest. The general assembly may, by law,
35 provide standards and conditions to regulate or guarantee the awarding of prizes provided for in
36 such games or contests under the provision of this subdivision;

37 (10) To impose a use or sales tax upon the use, purchase or acquisition of property paid
38 for out of the funds of any county or other political subdivision.

Section 39(g). The general assembly may authorize by law the licensing and use of
2 **gaming devices within combined retail transportation-fueling and food service**
3 **establishments which are located within one mile of an interstate highway.**
