AN ACT

To amend chapter 324, RSMo, by adding thereto ten new sections relating to the powers and duties of the Missouri high voltage electrical industry licensing board, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 324, RSMo, is amended by adding thereto ten new sections, to be
2 known as sections 324.808, 324.809, 324.810, 324.815, 324.820, 324.825, 324.830, 324.835,
3 324.837, and 324.840, to read as follows:

**324.808. As used in sections 324.808 to 324.840, unless the context clearly means
2 otherwise, the following terms shall mean:**

3 (1) "BAT", Bureau of Apprenticeship and Training, a bureau within the United
4 States Department of Labor;

5 (2) "Board", the Missouri high voltage electrical industry licensing board;

6 (3) "Certifying entity", the nongovernmental agency or association which certifies
7 or registers individuals who have completed academic and training requirements;

8 (4) "Director", the director of the division of professional registration;

9 (5) "Division", the division of professional registration within the department of
10 economic development;

11 (6) "Electrical contracting", the business of designing, installing, erecting,
12 repairing, or altering electrical wires or conductors equal to or in excess of fifty volts, to
13 be used for light, heat, or power. The term includes the installation or repair of ducts,
14 raceways, or conduits, for the reception or protection of wires or conductors, or the
15 installation or repair of any electrical machinery, apparatus, or system used for electrical
16 light, heat, or power; however, electrical contracting shall not include work done by any

- 17 **employee of an electric utility corporation, municipal utility, or rural electric cooperative;**
18 **(7) "Electrical contractor", a person engaged in electrical contracting;**
19 **(8) "Journeyman electrician", an individual that is qualified to perform electrical**
20 **work without supervision;**
21 **(9) "License", a valid license issued or recognized by the high voltage electrical**
22 **industry licensing board;**
23 **(10) "Nonpublic member", an individual who represents a professional association**
24 **on the board;**
25 **(11) "Person", an individual, corporation, partnership, association, or other legal**
26 **entity;**
27 **(12) "Public member", an individual who represents the public and not a**
28 **professional association on the board.**

324.809. 1. There is hereby created within the division of professional registration
2 **a board to be known as the "Missouri High Voltage Electrical Industry Licensing Board".**
3 **The board shall consist of seven voting members including one public member, all of whom**
4 **shall be citizens of the United States and domiciled within this state. The governor shall**
5 **appoint the members of the board with the advice and consent of the senate for terms of**
6 **four years; except as provided in subsection 3 of this section. The six nonpublic members**
7 **shall hold an electrical contractor's license for at least five years immediately preceding the**
8 **person's appointment to the board and shall at all times be holders of an electrical**
9 **contractor license in this state. All nonpublic members shall be chosen from lists submitted**
10 **by the director of the division of professional registration who shall inquire of Independent**
11 **Electrical Contractors Association, Associated Builders and Contractors, and National**
12 **Electrical Contractors Association, to obtain the names of individuals to be considered.**
13 **The governor shall appoint nonpublic members as follows:**

- 14 **(1) Two members belonging to Associated Builders and Contractors;**
15 **(2) Two members belonging to the Independent Electrical Contractors Association;**
16 **and**
17 **(3) Two members belonging to the National Electrical Contractors Association.**

18 **2. No person shall be eligible for reappointment to the board who has served as a**
19 **member for a total of eight years. A vacancy in the office of any board member shall only**
20 **be filled for the unexpired term.**

21 **3. The initial appointments to the board shall be two members for terms of two**
22 **years, two members for terms of three years, two members for terms of four years, and one**
23 **public member for a term of four years.**

24 **4. Any member of the board may be removed from the board by the governor for**

25 neglect of duty required by law, for incompetency or for unethical or dishonest conduct.
26 Upon the death, resignation, disqualification, or removal of any member of the board, the
27 governor shall appoint a successor.

324.810. 1. The board shall elect annually a chairperson and a vice chairperson
2 from their number.

3 2. The division, in collaboration with the board, shall adopt, implement, rescind,
4 amend, and administer such rules and regulations as may be necessary to carry out the
5 provisions of sections 324.808 to 324.840. The division, in collaboration with the board,
6 may promulgate necessary rules compatible with sections 324.808 to 324.840, including, but
7 not limited to, rules relating to professional conduct, continuing competency requirements
8 for renewal of licenses, approval of continuing competency programs and to the
9 establishment of ethical standards of practice for persons holding a license pursuant to
10 sections 324.808 to 324.840.

11 3. The board shall convene at the request of the director or as the board shall
12 determine. The board shall hold regular meetings at least four times per year.

13 4. Each member of the board shall receive as compensation, an amount set by the
14 division not to exceed fifty dollars per day, for each day devoted to the affairs of the board
15 and may be reimbursed for actual and necessary expenses incurred in the performance of
16 the member's official duties.

17 5. No rule or portion of a rule promulgated pursuant to the authority of this section
18 shall become effective unless it has been promulgated pursuant to chapter 536, RSMo.

324.815. 1. For the purpose of sections 324.808 to 324.840, the division shall:

2 (1) Employ, within the limits of the appropriations for that purpose, employees as
3 are necessary to carry out the provisions of sections 324.808 to 324.840;

4 (2) Exercise all administrative functions;

5 (3) Establish all applicable fees, set at an amount which shall not substantially
6 exceed the cost of administering sections 324.808 to 324.840;

7 (4) Deposit all fees collected pursuant to sections 324.808 to 324.840, by
8 transmitting such funds to the department of revenue for deposit to the state treasury to
9 the credit of the Missouri electrical industry licensing board fund; and

10 (5) Approve or disapprove certifying entities for professions within the electrical
11 industry included in the scope of sections 324.808 to 324.840.

12 2. The division may terminate recognition of any certifying entity included in the
13 scope of sections 324.808 to 324.840 following a subsequent review of the certification of
14 registration procedures of a certifying entity.

324.820. 1. The applicant applying for a high voltage electrical contractor's license

2 shall be twenty-one years of age, a United States citizen, provide proof of insurance, and
3 post a bond in an amount set by the board. The applicant shall have:

4 (1) Passed an electrical assessment test equivalent to the Experior Exam at the
5 master electrician's level administered by a third party;

6 (2) Completed twelve thousand verifiable practical hours installing equipment and
7 associated wiring;

8 (3) Completed ten thousand verifiable practical hours installing equipment and
9 associated wiring and received an electrical journeyman certificate from a BAT-approved
10 electrical apprenticeship program;

11 (4) Received an associate's degree from a state-accredited program and eight
12 thousand verifiable practical hours installing equipment and associated wiring; or

13 (5) Received a four-year electrical engineering degree and four thousand verifiable
14 practical hours installing equipment and associated wiring.

15 2. The certification requirement shall be waived for those electrical contractors who
16 apply for a waiver with the board on or before March 1, 2005. Electrical contractors
17 practicing prior to March 1, 2005, shall be eligible for a waiver of certification as follows:

18 (1) Electrical contractors who currently hold an electrical license that is in good
19 standing which was issued by any authority in this state that requires a written test to
20 obtain such license shall be issued a new state electrical contractor license; or

21 (2) Electrical contractors who currently hold an electrical license that is in good
22 standing which was issued by any authority in this state that does not require a written test
23 to obtain such license may apply to the board for a limited electrical contractor license.
24 Such application shall include a list of the counties for which the applicant seeks
25 authorization to practice as an electrical contractor; or

26 (3) Any person who was operating as an electrical contractor prior to August 28,
27 2004, in an area where no electrical license was required to operate such business shall be
28 granted a waiver of the certification requirement provided that the applicant:

29 (a) Has completed twenty thousand verifiable practical hours installing equipment
30 and associated wiring related to this license and has applied for a limited electrical
31 contractor's license;

32 (b) Has taken an electrical contractors test; or

33 (c) Applied for a temporary limited electrical contractor license on or before March
34 1, 2004, while awaiting passage of an electrical contractors examination. Such license shall
35 expire two years after issuance, and may not be renewed.

36 3. Notwithstanding any provision of sections 324.808 to 324.840 to the contrary, any
37 person operating as an electrical contractor in an area where no electrical license is

38 required to operate as such, shall not be required to possess a license pursuant to sections
39 324.808 to 324.840 in order to continue to operate as an electrical contractor in such
40 political subdivision.

41 4. The division, in collaboration with the board, may negotiate reciprocal contracts
42 with other states, the District of Columbia, or territories of the United States which require
43 standards for licensure, registration, or certification considered to be equivalent or more
44 stringent than the requirements for licensure pursuant to sections 324.808 to 324.840.

45 5. Upon the death or termination of the licensed electrical contractor, the business
46 which such person represented shall have one year following the date of the death or
47 termination of employment of the licensed electrical contractor to provide the state with
48 the name of a licensed electrical contractor who shall hold the license on behalf of the
49 business.

324.825. The "Missouri High Voltage Electrical Industry Licensing Board Fund"
2 is hereby created. The provisions of section 33.080, RSMo, to the contrary
3 notwithstanding, money in the Missouri high voltage electrical industry licensing board
4 fund shall not be transferred and placed to the credit of general revenue until the amount
5 in the fund at the end of the biennium exceeds three times the amount of appropriation
6 from the fund for the preceding fiscal year. All fees shall be set at an amount which shall
7 not substantially exceed the cost of administering sections 324.808 to 324.840.

324.830. 1. The division shall mail a renewal notice to the last known address of
2 each person licensed pursuant to sections 324.808 to 324.840 prior to the renewal date.
3 Failure to provide the division with the information required for renewal or to pay the
4 required fee after such notice shall result in the license being declared inactive and the
5 licensee shall not practice until he or she applies for reinstatement and pays the required
6 fees. The license shall be restored if the application is received within two years of the
7 renewal date.

8 2. Upon request, the division, in collaboration with the board, may grant inactive
9 status to a licensee, if the person:

10 (1) Does not hold himself or herself out as possessing a license required pursuant
11 to sections 324.808 to 324.840 in this state;

12 (2) Maintains any continuing competency requirements established by the division,
13 in collaboration with the board; and

14 (3) Remits any fee that may be required.

324.835. 1. The board may refuse to issue or renew any certificate of registration
2 or authority, permit or license required pursuant to sections 324.808 to 324.840 for one or
3 any combination of causes stated in subsection 2 of this section. The board shall notify the

4 applicant in writing of the reasons for the refusal and shall advise the applicant of his or
5 her right to file a complaint with the administrative hearing commission as provided by
6 chapter 621, RSMo.

7 2. The board may cause a complaint to be filed with the administrative hearing
8 commission as provided by chapter 621, RSMo, against any holder of any certificate of
9 registration or authority, permit, or license required by sections 324.808 to 324.840 or any
10 person who has failed to renew or has surrendered his or her certificate of registration or
11 authority, permit, or license for any one or any combination of the following causes:

12 (1) Use or unlawful possession of any controlled substance, as defined in chapter
13 195, RSMo, or alcoholic beverage to an extent that such use impairs a person's ability to
14 perform the work of an electrician;

15 (2) The person has been finally adjudicated and found guilty, or entered a plea of
16 guilty or nolo contendere, in a criminal prosecution under the laws of any state or of the
17 United States, for any offense reasonably related to the qualifications, functions, or duties
18 of any profession licensed or regulated by sections 324.808 to 324.840, for any offense an
19 essential element of which is fraud, dishonesty, or an act of violence, or for any offense
20 involving moral turpitude, regardless of whether a sentence is imposed;

21 (3) Use of fraud, deception, misrepresentation, or bribery in securing any certificate
22 of registration or authority, permit, or license issued pursuant to sections 324.808 to
23 324.840 or in obtaining permission to take any examination given or required pursuant to
24 sections 324.808 to 324.840;

25 (4) Obtaining or attempting to obtain any fee, charge, tuition, or other
26 compensation by fraud, deception, or misrepresentation;

27 (5) Incompetency, misconduct, gross negligence, fraud, misrepresentation, or
28 dishonesty in the performance of the functions and duties of any profession licensed or
29 regulated by sections 324.808 to 324.840;

30 (6) Violation of, or assisting or enabling any person to violate, any provision of
31 sections 324.808 to 324.840 or any lawful rule or regulation adopted pursuant to sections
32 324.808 to 324.840;

33 (7) Impersonation of any person holding a certificate of registration or authority,
34 permit, license, or allowing any person to use his or her certificate of registration or
35 authority, permit, license, or diploma from any school;

36 (8) Disciplinary action against the holder of a license or other right to practice any
37 profession regulated by sections 324.808 to 324.840 granted by another state, territory,
38 federal agency, or country upon grounds for which revocation or suspension is authorized
39 in this state;

40 **(9) A person is finally adjudged insane or incompetent by a court of competent**
41 **jurisdiction;**

42 **(10) Assisting or enabling any person to practice or offer to practice any profession**
43 **licensed or regulated by sections 324.808 to 324.840 who is not registered and currently**
44 **eligible to practice pursuant to sections 324.808 to 324.840;**

45 **(11) Issuance of a certificate of registration or authority, permit, or license based**
46 **upon a material mistake of fact;**

47 **(12) Violation of any professional trust or confidence;**

48 **(13) Use of any advertisement or solicitation which is false, misleading, or deceptive**
49 **to the general public or persons to whom the advertisement or solicitation is primarily**
50 **directed;**

51 **(14) Unethical conduct as defined in the ethical standards adopted by the division**
52 **and filed with the secretary of state;**

53 **(15) Violation of the drug laws or rules and regulations of this state, any other state,**
54 **or federal government.**

55 **3. After the filing of such complaint, the proceedings shall be conducted in**
56 **accordance with the provisions of chapter 621, RSMo. Upon a finding by the**
57 **administrative hearing commission that the grounds provided in subsection 2 of this**
58 **section for disciplinary action are met, the board may, singly or in combination, censure**
59 **or place the person named in the complaint on probation with such terms and conditions**
60 **as the board deems appropriate for a period not to exceed five years, or may suspend, for**
61 **a period not to exceed three years, or may revoke the license, certificate, or permit.**

62 **4. An individual whose license has been revoked shall wait at least one year from**
63 **the date of revocation to apply for relicensure. Relicensure shall be at the discretion of the**
64 **board after compliance with all requirements of sections 324.808 to 324.840 relative to the**
65 **licensing of the applicant for the first time.**

324.837. It is unlawful for any person in this state to hold himself out as, or engage
2 **in business as an electrical contractor, unless such person has first obtained a license**
3 **pursuant to sections 324.808 to 324.840. Any person licensed pursuant to sections 324.808**
4 **to 324.840 may exercise the privilege thereby granted within this state and shall not be**
5 **required by any municipality or other political subdivision having authority to adopt local**
6 **regulations or ordinances to obtain any other license in order to exercise such privilege.**

324.840. 1. Any person or corporation who knowingly violates any provision of
2 **sections 324.808 to 324.840 is guilty of a class B misdemeanor.**

3 **2. Any officer or agent of a corporation or member or agent of a partnership or**
4 **association, who knowingly and personally participates in, or is an accessory to, any**

5 violation of sections 324.808 to 324.840 is guilty of a class B misdemeanor.

6 **3. The provisions of this section shall not be construed to release any person from**
7 **civil liability or criminal prosecution pursuant to any other law of this state.**

8 **4. The division, in collaboration with the board, may cause a complaint to be filed**
9 **for any violation of sections 324.808 to 324.840 in any court of competent jurisdiction and**
10 **perform such other acts as may be necessary to enforce the provisions of sections 324.808**
11 **to 324.840.**
