No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

This legislation designates a portion of U.S. Highway 61 in Lewis County as the "Students of Missouri Assisting Rural Transportation (S.M.A.R.T.) Memorial Highway." Costs for such designation shall be paid by S.M.A.R.T. members.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
