**AN ACT**

To repeal sections 345.015, 345.022, 345.050, and 345.080, RSMo, and to enact in lieu thereof four new sections relating to the licensing of speech-language pathologists and audiologists.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 345.015, 345.022, 345.050, and 345.080, RSMo, are repealed and  
2 four new sections enacted in lieu thereof, to be known as sections 345.015, 345.022, 345.050,  
3 and 345.080 to read as follows:

345.015. As used in sections 345.010 to 345.080, the following terms mean:

2 (1) "Audiologist", a person who is licensed as an audiologist pursuant to sections  
3 345.010 to 345.080 to practice audiology;

4 (2) "Audiology aide", a person who is registered as an audiology aide by the board, who  
5 does not act independently but works under the direction and supervision of a licensed  
6 audiologist. Such person assists the audiologist with activities which require an understanding  
7 of audiology but do not require formal training in the relevant academics. To be eligible for  
8 registration by the board, each applicant shall submit a registration fee, be of good moral and  
9 ethical character; and:

10 (a) Be at least eighteen years of age;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

11 (b) Furnish evidence of the person's educational qualifications which shall be at a  
12 minimum:

13 a. Certification of graduation from an accredited high school or its equivalent; and

14 b. On-the-job training;

15 (c) Be employed in a setting in which direct and indirect supervision are provided on a  
16 regular and systematic basis by a licensed audiologist.

18 However, the aide shall not administer or interpret hearing screening or diagnostic tests, fit or  
19 dispense hearing instruments, make ear impressions, make diagnostic statements, determine case  
20 selection, present written reports to anyone other than the supervisor without the signature of the  
21 supervisor, make referrals to other professionals or agencies, use a title other than  
22 speech-language pathology aide or clinical audiology aide, develop or modify treatment plans,  
23 discharge clients from treatment or terminate treatment, disclose clinical information, either  
24 orally or in writing, to anyone other than the supervising speech-language  
25 pathologist/audiologist, or perform any procedure for which he or she is not qualified, has not  
26 been adequately trained or both;

27 (3) "Board", the state board of registration for the healing arts;

28 (4) "Clinical fellowship", the supervised professional employment period following  
29 completion of the academic and practicum requirements of an accredited training program as  
30 defined in sections 345.010 to 345.080;

31 (5) "Commission", the advisory commission for speech-language pathologists and  
32 audiologists;

33 (6) "Hearing instrument" or "hearing aid", any wearable device or instrument designed  
34 for or offered for the purpose of aiding or compensating for impaired human hearing and any  
35 parts, attachments or accessories, including ear molds, but excluding batteries, cords, receivers  
36 and repairs;

37 (7) "Person", any individual, organization, or corporate body, except that only  
38 individuals may be licensed pursuant to sections 345.010 to 345.080;

39 (8) "Practice of audiology":

40 (a) The application of accepted audiologic principles, methods and procedures for the  
41 measurement, testing, interpretation, appraisal and prediction related to disorders of the auditory  
42 system, balance system or related structures and systems;

43 (b) Provides consultation, counseling to the patient, client, student, their family or  
44 interested parties;

45 (c) Provides academic, social and medical referrals when appropriate;

- 46 (d) Provides for establishing goals, implementing strategies, methods and techniques,  
47 for habilitation, rehabilitation or aural rehabilitation, related to disorders of the auditory system,  
48 balance system or related structures and systems;
- 49 (e) Provides for involvement in related research, teaching or public education;
- 50 (f) Provides for rendering of services or participates in the planning, directing or  
51 conducting of programs which are designed to modify audition, communicative, balance or  
52 cognitive disorder, which may involve speech and language or education issues;
- 53 (g) Provides and interprets behavioral and neurophysiologic measurements of auditory  
54 balance, cognitive processing and related functions, including intraoperative monitoring;
- 55 (h) Provides involvement in any tasks, procedures, acts or practices that are necessary  
56 for evaluation of audition, hearing, training in the use of amplification or assistive listening  
57 devices;
- 58 (i) Provides selection and assessment of hearing instruments;
- 59 (j) Provides for taking impressions of the ear, making custom ear molds, ear plugs, swim  
60 molds and industrial noise protectors;
- 61 (k) Provides assessment of external ear and cerumen management;
- 62 (l) Provides advising, fitting, mapping assessment of implantable devices such as  
63 cochlear or auditory brain stem devices;
- 64 (m) Provides information in noise control and hearing conservation including education,  
65 equipment selection, equipment calibration, site evaluation and employee evaluation;
- 66 (n) Provides performing basic speech-language screening test;
- 67 (o) Provides involvement in social aspects of communication, including challenging  
68 behavior and ineffective social skills, lack of communication opportunities;
- 69 (p) Provides support and training of family members and other communication partners  
70 for the individual with auditory balance, cognitive and communication disorders;
- 71 (q) Provides aural rehabilitation and related services to individuals with hearing loss and  
72 their families;
- 73 (r) Evaluates, collaborates and manages audition problems in the assessment of the  
74 central auditory processing disorders and providing intervention for individuals with central  
75 auditory processing disorders;
- 76 (s) Develops and manages academic and clinical problems in communication sciences  
77 and disorders;
- 78 (t) Conducts, disseminates and applies research in communication sciences and  
79 disorders;
- 80 (9) "Practice of speech-language pathology":

- 81 (a) Provides screening, identification, assessment, diagnosis, treatment, intervention,  
82 including but not limited to prevention, restoration, amelioration and compensation, and  
83 follow-up services for disorders of:
- 84 a. Speech: articulation, fluency, voice, including respiration, phonation and resonance;
  - 85 b. Language, involving the parameters of phonology, morphology, syntax, semantics and  
86 pragmatic; and including disorders of receptive and expressive communication in oral, written,  
87 graphic and manual modalities;
  - 88 c. Oral, pharyngeal, cervical esophageal and related functions, such as dysphagia,  
89 including disorders of swallowing and oral functions for feeding; orofacial myofunctional  
90 disorders;
  - 91 d. Cognitive aspects of communication, including communication disability and other  
92 functional disabilities associated with cognitive impairment;
  - 93 e. Social aspects of communication, including challenging behavior, ineffective social  
94 skills, lack of communication opportunities;
- 95 (b) Provides consultation and counseling and makes referrals when appropriate;
- 96 (c) Trains and supports family members and other communication partners of individuals  
97 with speech, voice, language, communication and swallowing disabilities;
- 98 (d) Develops and establishes effective augmentative and alternative communication  
99 techniques and strategies, including selecting, prescribing and dispensing of augmentative aids  
100 and devices; and the training of individuals, their families and other communication partners in  
101 their use;
- 102 (e) Selects, fits and establishes effective use of appropriate prosthetic/adaptive devices  
103 for speaking and swallowing, such as tracheoesophageal valves, electrolarynges, **or** speaking  
104 valves;
- 105 (f) Uses instrumental technology to diagnose and treat disorders of communication and  
106 swallowing, such as videofluoroscopy, nasendoscopy, ultrasonography and stroboscopy;
- 107 (g) Provides aural rehabilitative and related counseling services to individuals with  
108 hearing loss and to their families;
- 109 (h) Collaborates in the assessment of central auditory processing disorders in cases in  
110 which there is evidence of speech, language or other cognitive communication disorders;  
111 provides intervention for individuals with central auditory processing disorders;
- 112 (i) Conducts pure-tone air conduction hearing screening and screening tympanometry  
113 for the purpose of the initial identification or referral;
- 114 (j) Enhances speech and language proficiency and communication effectiveness,  
115 including but not limited to accent reduction, collaboration with teachers of English as a second  
116 language and improvement of voice, performance and singing;

- 117 (k) Trains and supervises support personnel;
- 118 (l) Develops and manages academic and clinical programs in communication sciences  
119 and disorders;
- 120 (m) Conducts, disseminates and applies research in communication sciences and  
121 disorders;
- 122 (n) Measures outcomes of treatment and conducts continuous evaluation of the  
123 effectiveness of practices and programs to improve and maintain quality of services;
- 124 (10) "Speech-language pathologist", a person who is licensed as a speech-language  
125 pathologist pursuant to sections 345.010 to 345.080; who engages in the practice of  
126 speech-language pathology as defined in sections 345.010 to 345.080;
- 127 (11) "Speech-language pathology aide", a person who is registered as a speech-language  
128 aide by the board, who does not act independently but works under the direction and supervision  
129 of a licensed speech-language pathologist. Such person assists the speech-language pathologist  
130 with activities which require an understanding of speech-language pathology but do not require  
131 formal training in the relevant academics. To be eligible for registration by the board, each  
132 applicant shall submit a registration fee, be of good moral and ethical character; and:
- 133 (a) Be at least eighteen years of age;
- 134 (b) Furnish evidence of the person's educational qualifications which shall be at a  
135 minimum:
- 136 a. Certification of graduation from an accredited high school or its equivalent; and  
137 b. On-the-job training;
- 138 (c) Be employed in a setting in which direct and indirect supervision is provided on a  
139 regular and systematic basis by a licensed speech-language pathologist. However, the aide shall  
140 not administer or interpret hearing screening or diagnostic tests, fit or dispense hearing  
141 instruments, make ear impressions, make diagnostic statements, determine case selection, present  
142 written reports to anyone other than the supervisor without the signature of the supervisor, make  
143 referrals to other professionals or agencies, use a title other than speech-language pathology aide  
144 or clinical audiology aide, develop or modify treatment plans, discharge clients from treatment  
145 or terminate treatment, disclose clinical information, either orally or in writing, to anyone other  
146 than the supervising speech-language pathologist/audiologist, or perform any procedure for  
147 which he or she is not qualified, has not been adequately trained or both;
- 148 (12) "Speech-language pathology assistant", a person who is registered as a  
149 speech-language pathology assistant by the board, who does not act independently but works  
150 under the direction and supervision of a licensed speech-language pathologist and whose  
151 activities require both academic and practical training in the field of speech-language pathology  
152 although less training than those established by sections 345.010 to 345.080 as necessary for

153 licensing as a speech-language pathologist. To be eligible for registration by the board, each  
154 applicant shall submit the registration fee, be of good moral character and furnish evidence of  
155 the person's educational qualifications which meet the following:

156 (a) Hold a bachelor's level degree in **the field of** speech-language pathology from an  
157 institution accredited or approved by [the Council on Academic Accreditation of the American  
158 Speech-Language-Hearing Association in the area of speech-language pathology] **a regional**  
159 **accrediting body recognized by the United States Department of Education or its**  
160 **equivalent**; and

161 (b) Submit official transcripts from one or more accredited colleges or universities  
162 presenting evidence of the completion of bachelor's level course work and clinical practicum  
163 requirements equivalent to that required or approved by [the Council on Academic Accreditation  
164 of the American Speech-Language-Hearing Association] **a regional accrediting body**  
165 **recognized by the United States Department of Education or its equivalent.**

345.022. 1. Any person in the person's clinical fellowship as defined in sections 345.010  
2 to 345.080 shall hold a provisional license to practice speech-language pathology or audiology.  
3 The board may issue a provisional license to an applicant who:

4 (1) Has met the requirements for practicum and academic requirements from an  
5 accredited training program as defined in sections 345.010 to 345.080;

6 (2) Submits an application to the board on a form prescribed by the board. Such form  
7 shall include a plan for the content and supervision of the clinical fellowship, as well as evidence  
8 of good moral and ethical character; and

9 (3) Submits to the board an application fee, as set by the board, for the provisional  
10 license.

11 2. A provisional license is effective for one year and may be extended for an additional  
12 twelve months only for purposes of completing the postgraduate clinical experience portion of  
13 the clinical fellowship; provided that, the applicant has passed the national examination and shall  
14 hold a master's degree from an approved training program in his or her area of application.

15 3. Within twelve months of issuance of the provisional license, the applicant shall pass  
16 an examination promulgated or approved by the board.

17 4. Within twelve months of issuance of a provisional license, the applicant shall  
18 complete the master's or doctoral degree from [an institution] **a program** accredited by the  
19 Council on Academic Accreditation of the American Speech-Language-Hearing Association **or**  
20 **other accrediting agency approved by the board** in the area in which licensure is sought.

345.050. 1. To be eligible for licensure by the board by examination, each applicant  
2 shall submit the application fee and shall furnish evidence of such person's good moral and  
3 ethical character, current competence and shall:

4 (1) Hold a master's or a doctoral degree from [an institution] **a program** accredited by  
5 the Council on Academic Accreditation of the American Speech-Language-Hearing Association  
6 **or other accrediting agency approved by the board** in the area in which licensure is sought;

7 (2) Submit official transcripts from one or more accredited colleges or universities  
8 presenting evidence of the completion of course work and clinical practicum requirements  
9 equivalent to that required by the Council on Academic Accreditation of the American  
10 Speech-Language-Hearing Association **or other accrediting agency approved by the board**;

11 (3) Present written evidence of completion of clinical fellowship as defined in  
12 subdivision (4) of section 345.015 from supervisors. The experience required by this subdivision  
13 shall follow the completion of the requirements of subdivisions (1) and (2) of this subsection.  
14 This period of employment shall be under the direct supervision of a person who is licensed by  
15 the state of Missouri in the profession in which the applicant seeks to be licensed. **Persons**  
16 **applying with an audiology clinical doctoral degree are exempt from this provision**;

17 (4) Pass an examination promulgated or approved by the board. The board shall  
18 determine the subject and scope of the examinations.

19 2. To be eligible for licensure by the board without examination, each applicant shall  
20 make application on forms prescribed by the board, submit the application fee and shall be of  
21 good moral and ethical character, submit an activity statement and meet one of the following  
22 requirements:

23 (1) The board shall issue a license to any speech-language pathologist or audiologist who  
24 is licensed in another jurisdiction and who has had no violations, suspension or revocations of  
25 a license to practice speech-language pathology or audiology in any jurisdiction; provided that,  
26 such person is licensed in a jurisdiction whose requirements are substantially equal to, or greater  
27 than, Missouri at the time the applicant applies for licensure; or

28 (2) Hold the certificate of clinical competence issued by the American  
29 Speech-Language-Hearing Association in the area in which licensure is sought.

345.080. 1. There is hereby established an "Advisory Commission for Speech-Language  
2 Pathologists and Audiologists" which shall guide, advise and make recommendations to the  
3 board. The commission shall approve the examination required by section 345.050, and shall  
4 assist the board in carrying out the provisions of sections 345.010 to 345.075.

5 2. After August 28, 1997, the commission shall consist of seven members, one of whom  
6 shall be a voting public member, appointed by the board of registration for the healing arts. Each  
7 member shall be a citizen of the United States and a resident of this state. Three members of the  
8 commission shall be licensed speech-language pathologists and three members of the  
9 commission shall be licensed audiologists. The public member shall be at the time of  
10 appointment a citizen of the United States; a resident of this state for a period of one year and

11 a registered voter; a person who is not and never was a member of any profession licensed or  
12 regulated pursuant to sections 345.010 to 345.080 or the spouse of such person; and a person  
13 who does not have and never has had a material, financial interest in either the providing of the  
14 professional services regulated by sections 345.010 to 345.080, or an activity or organization  
15 directly related to any profession licensed or regulated pursuant to sections 345.010 to 345.080.  
16 Members shall be appointed to serve three-year terms, except as provided in this subsection.  
17 Each member of the advisory commission for speech pathologists and clinical audiologists on  
18 August 28, 1995, shall become a member of the advisory commission for speech-language  
19 pathologists and clinical audiologists and shall continue to serve until the term for which the  
20 member was appointed expires. Each member of the advisory commission for speech-language  
21 pathologists and clinical audiologists on August 28, 1997, shall become a member of the  
22 advisory commission for speech-language pathologists and audiologists and shall continue to  
23 serve until the term for which the member was appointed expires. The first public member  
24 appointed pursuant to this subsection shall be appointed for a two-year term and the one  
25 additional member appointed pursuant to this subsection shall be appointed for a full three-year  
26 term. No person shall be eligible for reappointment who has served as a member of the advisory  
27 commission for speech pathologists and audiologists or as a member of the commission as  
28 established on August 28, 1995, for a total of six years. The membership of the commission  
29 shall reflect the differences in levels of education, work experience and geographic residence.  
30 **For a licensed speech-language pathologist member,** the president of the Missouri [Speech,  
31 Hearing and Language] **Speech-Language-Hearing** Association in office at the time, **and for**  
32 **a licensed audiologist member, the president of the Missouri Academy of Audiologists in**  
33 **office at the time, in consultation with the president of the Missouri Speech-Language-**  
34 **Hearing Association,** shall, at least ninety days prior to the expiration of a term [of a member]  
35 of a commission member, other than the public member, or as soon as feasible after a vacancy  
36 on the commission otherwise occurs, submit to the director of the division of professional  
37 registration a list of five persons qualified and willing to fill the vacancy in question, with the  
38 request and recommendation that the board of registration for the healing arts appoint one of the  
39 five persons so listed, and with the list so submitted, the president of the Missouri [Speech,  
40 Hearing and Language] **Speech-Language-Hearing** Association **or the president of the**  
41 **Missouri Academy of Audiologists in office at the time** shall include in his or her letter of  
42 transmittal a description of the method by which the names were chosen by that association.

43 3. Notwithstanding any other provision of law to the contrary, any appointed member  
44 of the commission shall receive as compensation an amount established by the director of the  
45 division of professional registration not to exceed seventy dollars per day for commission  
46 business plus actual and necessary expenses. The director of the division of professional



47 registration shall establish by rule guidelines for payment. All staff for the commission shall be  
48 provided by the board of registration for the healing arts.

49         4. The commission shall hold an annual meeting at which it shall elect from its  
50 membership a chairman and secretary. The commission may hold such additional meetings as  
51 may be required in the performance of its duties, provided that notice of every meeting shall be  
52 given to each member at least ten days prior to the date of the meeting. A quorum of the  
53 commission shall consist of a majority of its members.

54         5. The board of registration for the healing arts may remove a commission member for  
55 misconduct, incompetency or neglect of the member's official duties after giving the member  
56 written notice of the charges against such member and an opportunity to be heard thereon.
