### AN ACT

To repeal section 302.080, RSMo, and to enact in lieu thereof one new section relating to automatic renewal of driver's licenses.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Section 302.080, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 302.080, to read as follows:

302.080. The following persons are exempt from license hereunder:

- (1) Any person while operating any farm tractor or implement of husbandry temporarily operated or moved on a highway;
- (2) A nonresident who is at least sixteen years of age and who has in his immediate possession a valid license issued to him in his home state or country;
- (3) A nonresident who is at least eighteen years of age and who has in his immediate possession a valid license issued to him in his home state or country which allows such person to operate a motor vehicle in the transportation of persons or property as classified in section 302.015;
- (4) Convicted offenders of the department of corrections who have not been convicted

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

11 of a motor vehicle felony as follows--driving while intoxicated, failing to stop after an accident  
12 and disclosing his or her identity, or driving a motor vehicle without the owner's consent--may  
13 operate state-owned trucks for the benefit of the correctional facilities, provided that such  
14 offender shall be accompanied by a correctional officer or other staff person in such truck;

15 **(5) Any member of the military service in an active duty status stationed outside**  
16 **the United States whose driver's license expired during the period of such active duty**  
17 **status. This exemption shall apply to such person's spouse and only apply for the ninety-**  
18 **day period immediately following the military member's discharge or the date on which**  
19 **the person returns to this state, whichever occurs first.**
