

HB 1121 -- Income Tax Deduction for Long-Term Care Insurance

This bill allows 100% of the amount paid for non-reimbursed qualified long-term care insurance premiums to be deducted from a taxpayer's Missouri taxable income to the extent the amount is not already included in the taxpayer's itemized deductions.
