AN ACT

To repeal section 337.500, RSMo, and to enact in lieu thereof one new section relating to licensed professional counselors.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 337.500, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 337.500, to read as follows:

337.500. As used in sections 337.500 to 337.540, unless the context clearly requires otherwise, the following words and phrases mean:

- 3 (1) **"Assessment", selecting, administering, scoring, and interpreting instruments**
- 4 **designed to evaluate an individual's attitudes, abilities, achievements, interests, personal**
- 5 **characteristics, disabilities, and mental, emotional, and behavioral symptoms and using**
- 6 **methods and techniques for understanding human behavior in relation to coping with,**
- 7 **adapting to, or changing life situations;**
- 8 (2) "Committee or board", the committee for professional counselors;
- 9 (3) **"Consulting", the application of scientific principles and procedures in**
- 10 **counseling and human development to provide assistance and understanding and solving**
- 11 **current or potential problems that the client or patient may have in relation to a third**
- 12 **party, whether an individual, group, or organization;**
- 13 (4) **"Counseling treatment interventions", the application of cognitive, affective,**
- 14 **behavioral, and systemic counseling strategies which include principles of development,**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

15 **wellness, and pathology that reflect a pluralistic society. Such interventions are specifically**
16 **implemented in the context of a professional counseling relationship;**

17 [(2)] (5) "Department", the Missouri [department of economic development]
18 **department of insurance, financial institutions and professional registration;**

19 (6) **"Diagnosis", identification of mental, emotional, and behavioral disorders based**
20 **upon assessment of the symptoms presented and observed characteristics;**

21 [(3)] (7) "Director", the director of the division of professional registration in the
22 department of economic development;

23 [(4)] (8) "Division", the division of professional registration;

24 [(5)] (9) "Licensed professional counselor", any person who offers to render professional
25 counseling services to individuals, groups, organizations, institutions, corporations, government
26 agencies or the general public for a fee, monetary or otherwise, implying that the person is
27 trained, experienced, and licensed in counseling, and who holds a current, valid license to
28 practice counseling;

29 [(6)] (10) "Practice of professional counseling", rendering, offering to render, or
30 supervising those who render to individuals, couples, groups, organizations, institutions,
31 corporations, schools, government agencies, or the general public any counseling service
32 involving the application of counseling procedures, and the principles and methods thereof, to
33 assist in achieving more effective intrapersonal or interpersonal, marital, decisional, social,
34 educational, vocational, developmental, or rehabilitative adjustments;

35 [(7)] (11) "Professional counseling", includes, but is not limited to:

36 (a) [The use of verbal or nonverbal counseling or both techniques, methods, or
37 procedures based on principles for assessing, understanding, or influencing behavior (such as
38 principles of learning, conditioning, perception, motivation, thinking, emotions, or social
39 systems);

40 (b) Appraisal or assessment, which means selecting, administering, scoring, or
41 interpreting instruments designed to assess a person's or group's aptitudes, intelligence, attitudes,
42 abilities, achievement, interests, and personal characteristics;

43 (c) The use of referral or placement techniques or both which serve to further the goals
44 of counseling;

45 (d) Therapeutic vocational or personal or both rehabilitation in relation to coping with
46 or adapting to physical disability, emotional disability, or intellectual disability or any
47 combination of the three;

48 (e) Designing, conducting, and interpreting research;

49 (f) The use of group methods or techniques to promote the goals of counseling;

- 50 (g) The use of informational and community resources for career, personal, or social
51 development;
- 52 (h) Consultation on any item in paragraphs (a) through (g) above; and
- 53 (i) **Individual, group, and marriage and family counseling and psychotherapy;**
- 54 (b) **Assessment for the purpose of establishing diagnosis or treatment goals and**
55 **objectives;**
- 56 (c) **Crisis intervention;**
- 57 (d) **Diagnosis of persons with mental, emotional, and behavioral disorders;**
- 58 (e) **Planning, implementing, and evaluating treatment plans using counseling**
59 **treatment interventions;**
- 60 (f) **Facilitating the achievement of more effective intrapersonal, marital, decisional,**
61 **social, educational, vocational, developmental, or rehabilitative adjustments throughout**
62 **the life span;**
- 63 (g) **Utilization of functional assessment and counseling for persons requesting**
64 **assistance in adjustment to a disability or handicapping condition;**
- 65 (h) **Consulting;**
- 66 (i) **Research;**
- 67 (j) **Referral.**

69 **The use of specific methods, techniques, or modalities within the practice of professional**
70 **counseling is restricted to professional counselors appropriately trained in the use of such**
71 **methods, techniques, or modalities, and licensed as a professional counselor or under the**
72 **supervision for licensure as a professional counselor.** No provision of sections 337.500 to
73 337.540, or of chapter 354 or 375, RSMo, shall be construed to mandate benefits or third-party
74 reimbursement for services of professional counselors in the policies or contracts of any
75 insurance company, health services corporation or other third-party payer;

76 [(8)] (12) "Provisional licensed professional counselor", any person who is a graduate
77 of an acceptable educational institution, as defined by division rules, with at least a master's
78 degree with a major in counseling, or its equivalent, and meets all requirements of a licensed
79 professional counselor, other than the supervised counseling experience prescribed by
80 subdivision (1) of section 337.510, and who is supervised by a person who is qualified for the
81 practice of professional counseling;

82 (13) "Referral", **evaluating and identifying needs of a client or patient to determine**
83 **the advisability of referral to other specialists, informing the client or patient of such**
84 **judgment, and communicating as requested or deemed appropriate to such referral**
85 **sources;**

86 (14) "Research", a systematic effort to collect, analyze, and interpret quantitative
87 and qualitative data that describes how social characteristics, behavior, emotion,
88 cognitions, disabilities, mental disorders, and interpersonal transactions among individuals
89 and organizations interact.
