AN ACT

Be it enacted by the General Assembly of the state of Missouri, as follows:

43.500. As used in sections 43.500 to 43.543, the following terms mean:

- 2 (1) "Administration of criminal justice", performance of any of the following activities:
3 detection, apprehension, detention, pretrial release, post-trial release, prosecution, adjudication,
4 correctional supervision, or rehabilitation of accused persons or criminal offenders. The
5 administration of criminal justice shall include criminal identification activities and the
6 collection, storage, and dissemination of criminal history information, including fingerprint
7 searches, photographs, and other [indicia of] **unique biometric** identification;
- 8 (2) "Central repository", the **division within the** Missouri state highway patrol [criminal
9 records and identification division] **responsible** for compiling and disseminating complete and
10 accurate criminal history records and for compiling, maintaining, and disseminating criminal
11 incident and arrest reports and statistics;
- 12 (3) "Committee", criminal records and justice information advisory committee;
- 13 (4) "**Comparable ordinance violation**", a **violation of an ordinance having all the**
14 **essential elements of a statutory felony or a class A misdemeanor**;
- 15 (5) "Criminal history record information", information collected by criminal justice
16 agencies on individuals consisting of identifiable descriptions and notations of arrests,
17 detentions, indictments, informations, or other formal criminal charges, and any disposition
18 arising therefrom, sentencing, correctional supervision, and release;
- 19 [(5)] (6) "Final disposition", the formal conclusion of a criminal proceeding at whatever
20 stage it occurs in the criminal justice system;
- 21 [(6)] (7) "Missouri charge code", a unique number assigned by the office of state courts
22 administrator to an offense for tracking and grouping offenses. Beginning January 1, 2005, the
23 complete charge code shall consist of digits assigned by the office of state courts administrator,
24 the two-digit national crime information center modifiers and a single digit designating attempt,

25 accessory, or conspiracy. The only exception to the January 1, 2005, date shall be the courts that
26 are not using the statewide court automation case management pursuant to section 476.055,
27 RSMo; the effective date will be as soon thereafter as economically feasible for all other courts;

28 [(7)] (8) "State offense cycle number", a unique number, supplied by or approved by the
29 Missouri state highway patrol, on the state criminal fingerprint card. The offense cycle number,
30 OCN, is used to link the identity of a person, through [fingerprints] **unique biometric**
31 **identification**, to one or many offenses for which the person is arrested or charged. The OCN
32 will be used to track an offense incident from the date of arrest to the final disposition when the
33 offender exits from the criminal justice system[.] ;

34 (9) "**Unique biometric identification**", **automated methods of recognizing and**
35 **identifying an individual based on a physiological characteristic. Biometric identification**
36 **methods may include but are not limited to facial recognition, fingerprints, palm prints,**
37 **hand geometry, iris recognition, and retinal scan.**

43.503. 1. For the purpose of maintaining complete and accurate criminal history record
2 information, all police officers of this state, the clerk of each court, the department of corrections,
3 the sheriff of each county, the chief law enforcement official of a city not within a county and
4 the prosecuting attorney of each county or the circuit attorney of a city not within a county shall
5 submit certain criminal arrest, charge, and disposition information to the central repository for
6 filing without undue delay in the form and manner required by sections 43.500 to 43.543.

7 2. All law enforcement agencies making misdemeanor and felony arrests as determined
8 by section 43.506 shall furnish without undue delay, to the central repository, fingerprints,
9 **photograph and any other unique biometric identification collected**, charges, appropriate
10 charge codes, and descriptions of all persons who are arrested for such offenses on standard
11 fingerprint forms supplied or approved by the highway patrol or electronically in a format and
12 manner approved by the highway patrol **and in compliance with the standards set by the**
13 **Federal Bureau of Investigation in its Automated Fingerprint Identification System or its**
14 **successor program**. All such agencies shall also notify the central repository of all decisions
15 not to refer such arrests for prosecution. An agency making such arrests may enter into
16 arrangements with other law enforcement agencies for the purpose of furnishing without undue
17 delay such fingerprints, **photograph and any other unique biometric identification collected**,
18 charges, appropriate charge codes, and descriptions to the central repository upon its behalf.

19 3. In instances where an individual less than seventeen years of age and not currently
20 certified as an adult is taken into custody for an offense which would be a felony if committed
21 by an adult, the arresting officer shall take fingerprints for the central repository. These
22 fingerprints shall be taken on fingerprint cards supplied by or approved by the highway patrol
23 or transmitted electronically in a format and manner approved by the highway patrol **and in**

24 **compliance with the standards set by the Federal Bureau of Investigation in its Automated**
25 **Fingerprint Identification System or its successor program.** The fingerprint cards shall be
26 so constructed that the name of the juvenile should not be made available to the central
27 repository. The individual's name and the unique number associated with the fingerprints and
28 other pertinent information shall be provided to the court of jurisdiction by the agency taking the
29 juvenile into custody. The juvenile's fingerprints and other information shall be forwarded to the
30 central repository and the courts without undue delay. The fingerprint information from the card
31 shall be captured and stored in the automated fingerprint identification system operated by the
32 central repository. In the event the fingerprints are found to match other tenprints or unsolved
33 latent prints, the central repository shall notify the submitting agency who shall notify the court
34 of jurisdiction as per local agreement. **Under section 211.031, RSMo, in instances where a**
35 **juvenile over fifteen and one-half years of age is alleged to have violated a state or**
36 **municipal traffic ordinance or regulation, which does not constitute a felony, and the**
37 **juvenile court does not have jurisdiction, the juvenile shall not be fingerprinted unless**
38 **certified as an adult.**

39 4. Upon certification of the individual as an adult, the certifying court shall order a law
40 enforcement agency to immediately fingerprint **and photograph** the individual **and certification**
41 **papers will be forwarded to the appropriate law enforcement agency with the order for**
42 **fingerprinting.** The law enforcement agency shall submit such fingerprints, **photograph and**
43 **certification papers** to the central repository within fifteen days and shall furnish the offense
44 cycle number associated with the fingerprints to the prosecuting attorney or the circuit attorney
45 of a city not within a county and to the clerk of the court ordering the subject fingerprinted. If
46 the juvenile is acquitted of the crime and is no longer certified as an adult, the prosecuting
47 attorney shall notify within fifteen days the central repository of the change of status of the
48 juvenile. Records of a child who has been fingerprinted and photographed after being taken into
49 custody shall be closed records as provided under section 610.100, RSMo, if a petition has not
50 been filed within thirty days of the date that the child was taken into custody; and if a petition
51 for the child has not been filed within one year of the date the child was taken into custody, any
52 records relating to the child concerning the alleged offense may be expunged under the
53 procedures in sections 610.122 to 610.126, RSMo.

54 5. The prosecuting attorney of each county or the circuit attorney of a city not within a
55 county **or the municipal prosecuting attorney** shall notify the central repository on standard
56 forms supplied by the highway patrol or in a manner approved by the highway patrol [of all
57 charges filed, including all those added subsequent to the filing of a criminal court case, and
58 whether charges were not filed in criminal cases for which the central repository has a record of
59 an arrest] **of his or her decision to not file a criminal charge on any charge referred to such**

60 **prosecuting attorney or circuit attorney for criminal charges.** All records forwarded to the
61 central repository **and the courts** by prosecutors or circuit attorneys as required by sections
62 43.500 to 43.530 shall include the state offense cycle number of the offense, the charge code for
63 the offense, and the originating agency identifier number of the reporting prosecutor, using such
64 numbers as assigned by the highway patrol.

65 6. The clerk of the courts of each county or city not within a county **or municipal court**
66 **clerk** shall furnish the central repository, on standard forms supplied by the highway patrol or
67 in a manner approved by the highway patrol, with **a record of all charges filed, including all**
68 **those added subsequent to the filing of a criminal court case, amended charges, and** all final
69 dispositions of cases for which the central repository has a record of an arrest or a record of
70 fingerprints reported pursuant to sections 43.500 to 43.506. Such information shall include, for
71 each charge:

72 (1) All judgments of not guilty, acquittals on the ground of mental disease or defect
73 excluding responsibility, judgments or pleas of guilty including the sentence, if any, or probation,
74 if any, pronounced by the court, nolle pros, discharges, releases and dismissals in the trial court;

75 (2) Court orders filed with the clerk of the courts which reverse a reported conviction
76 or vacate or modify a sentence;

77 (3) Judgments terminating or revoking a sentence to probation, supervision or
78 conditional release and any resentencing after such revocation; and

79 (4) The offense cycle number of the offense, and the originating agency identifier
80 number of the sentencing court, using such numbers as assigned by the highway patrol.

81 7. The clerk of the courts of each county or city not within a county shall furnish, to the
82 department of corrections or department of mental health, court judgment and sentence
83 documents and the state offense cycle number and the charge code of the offense which resulted
84 in the commitment or assignment of an offender to the jurisdiction of the department of
85 corrections or the department of mental health if the person is committed pursuant to chapter
86 552, RSMo. This information shall be reported to the department of corrections or the
87 department of mental health at the time of commitment or assignment. If the offender was
88 already in the custody of the department of corrections or the department of mental health at the
89 time of such subsequent conviction, the clerk shall furnish notice of such subsequent conviction
90 to the appropriate department by certified mail, return receipt requested, or in a manner and
91 format mutually agreed to, within fifteen days of such disposition.

92 8. Information and fingerprints, [and other indicia] **photograph and any other unique**
93 **biometric identification collected,** forwarded to the central repository, normally obtained from
94 a person at the time of the arrest, may be obtained at any time the subject is in the criminal
95 justice system or committed to the department of mental health. A law enforcement agency or

96 the department of corrections may fingerprint, **photograph and capture any other unique**
97 **biometric identification of** the person and obtain the necessary information at any time the
98 subject is in custody. If at the time of [disposition] **any court appearance**, the defendant has
99 not been fingerprinted **and photographed** for an offense in which a fingerprint **and photograph**
100 is required by statute to be collected, maintained, or disseminated by the central repository, the
101 court shall order a law enforcement agency **or court marshal** to fingerprint **and photograph**
102 immediately the defendant. **The order for fingerprints shall contain the offense, charge code,**
103 **date of offense, and any other information necessary to complete the fingerprint card.** The
104 law enforcement agency **or court marshal** shall submit such fingerprints, **photograph and any**
105 **other unique biometric identification collected**, to the central repository without undue delay
106 and within thirty days and shall furnish the offense cycle number associated with the fingerprints
107 to the prosecuting attorney or the circuit attorney of a city not within a county and to the court
108 clerk of the court ordering the subject fingerprinted.

109 9. The department of corrections and the department of mental health shall furnish the
110 central repository with all information concerning the receipt, escape, execution, death, release,
111 pardon, parole, commutation of sentence, granting of executive clemency, legal name change,
112 or discharge of an individual who has been sentenced to that department's custody for any
113 offenses which are mandated by law to be collected, maintained or disseminated by the central
114 repository. All records forwarded to the central repository by the department as required by
115 sections 43.500 to 43.543 shall include the offense cycle number of the offense, and the
116 originating agency identifier number of the department using such numbers as assigned by the
117 highway patrol.

43.506. 1. Those offenses considered reportable for the purposes of sections 43.500 to
2 43.543 include all felonies [and serious or aggravated] ; **class A misdemeanors; all violations**
3 **for driving under the influence of drugs or alcohol; any offense that can be enhanced to a**
4 **class A misdemeanor or higher for subsequent violations; and comparable ordinance**
5 **violations** consistent with the reporting standards established by the National Crime Information
6 Center, Federal Bureau of Investigation, for the Federal Interstate Identification Index System[.
7 In addition,] ; **and** all cases arising [pursuant to sections 566.010 to 566.141, RSMo, where the
8 defendant pleads guilty to an offense involving a child under seventeen years of age and the court
9 imposes a suspended imposition of sentence shall be reported] **under chapter 566, RSMo.** The
10 following types of offenses shall not be considered reportable for the purposes of sections
11 57.403, RSMo, 43.500 to 43.543, and 595.200 to 595.218, RSMo: [disturbing the peace, curfew
12 violation, loitering, false fire alarm, disorderly conduct,] nonspecific charges of suspicion or
13 investigation, [and] general traffic violations and all misdemeanor violations of the state wildlife
14 code. [All violations for driving under the influence of drugs or alcohol are reportable.] All

15 offenses considered reportable shall be reviewed annually and noted in the Missouri charge code
16 manual established in section 43.512. All information collected pursuant to sections 43.500 to
17 43.543 shall be available only as set forth in section 610.120, RSMo.

18 2. Law enforcement agencies, court clerks, prosecutors and custody agencies may report
19 required information by electronic medium either directly to the central repository or indirectly
20 to the central repository via other criminal justice agency computer systems in the state with the
21 approval of the highway patrol, based upon standards established by the advisory committee.

22 3. In addition to the repository of fingerprint records for individual offenders and
23 applicants, the central repository of criminal history and identification records for the state shall
24 maintain a repository of latent prints, palm prints and other [prints] **unique biometric**
25 **identification** submitted to the repository.

43.540. 1. As used in this section, the following terms mean:

2 (1) "Authorized state agency", a division of state government or an office of state
3 government designated by the statutes of Missouri to issue or renew a license, permit,
4 certification, or registration of authority to a qualified entity;

5 (2) "Care", the provision of care, treatment, education, training, instruction, supervision,
6 or recreation;

7 (3) "Missouri criminal record review", a review of criminal history records and sex
8 offender registration records pursuant to sections 589.400 to 589.425, RSMo, maintained by the
9 Missouri state highway patrol in the Missouri criminal records repository;

10 (4) "National criminal record review", a review of the criminal history records
11 maintained by the Federal Bureau of Investigation;

12 (5) "Patient or resident", a person who by reason of age, illness, disease or physical or
13 mental infirmity receives or requires care or services furnished by a provider, as defined in this
14 section, or who resides or boards in, or is otherwise kept, cared for, treated or accommodated in
15 a facility as defined in section 198.006, RSMo, for a period exceeding twenty-four consecutive
16 hours;

17 (6) "Provider", a person who:

18 (a) Has or may have unsupervised access to children, the elderly, or persons with
19 disabilities; and

20 (b) a. Is employed by or seeks employment with a qualified entity; or

21 b. Volunteers or seeks to volunteer with a qualified entity; or

22 c. Owns or operates a qualified entity;

23 (7) "Qualified entity", a person, business, or organization, whether public or private, for
24 profit, not for profit, or voluntary, that provides care, placement, or educational services for

25 children, the elderly, or persons with disabilities as patients or residents, including a business or
26 organization that licenses or certifies others to provide care or placement services;

27 (8) "Youth services agency", any public or private agency, school, or association which
28 provides programs, care or treatment for or which exercises supervision over minors.

29 2. A qualified entity may obtain a Missouri criminal record review of a provider from
30 the highway patrol by furnishing information on forms and in the manner approved by the
31 highway patrol. **The qualified entity must register with the highway patrol before
32 submitting a request for screening under this section and:**

33 (1) **Each such request must be voluntary and conform to the requirements
34 established in the National Child Protection Act of 1993, as amended. As a part of the
35 registration, the qualified entity must agree to comply with state and federal law and must
36 so indicate by signing an agreement approved by the highway patrol. The highway patrol
37 may periodically audit qualified entities to ensure compliance with federal law and this
38 section;**

39 (2) **A qualified entity shall submit to the highway patrol a request for screening an
40 employee or volunteer or person applying to be an employee or volunteer on a completed
41 fingerprint card, with a signed waiver allowing the release of state and national criminal
42 history record information to the qualified entity;**

43 (3) **Each such request must be accompanied by a fee, which shall approximate the
44 actual cost of producing the record information, as provided in section 43.530, plus the
45 amount required by the Federal Bureau of Investigation for the national criminal history
46 check in compliance with the National Child Protection Act of 1993, as amended;**

47 (4) **Any current or prospective employee or volunteer who is subject to a request
48 for screening must indicate to the qualified entity submitting the request the name and
49 address of each qualified entity that has submitted a previous request for screening
50 regarding that employee or volunteer;**

51 (5) **The highway patrol shall provide directly to the qualified entity the state
52 criminal history records that are not exempt from disclosure under section 610.120, RSMo,
53 or otherwise confidential under law;**

54 (6) **The national criminal history data is available to qualified entities to use only
55 for the purpose of screening employees and volunteers or persons applying to be an
56 employee or volunteer with a qualified entity. The highway patrol shall provide this
57 national criminal history record information directly to the qualified entity as authorized
58 by the written waiver required for submission of a request to the highway patrol;**

59 (7) **The determination whether the criminal history record shows that the employee
60 or volunteer has been convicted of or is under pending indictment for any crime that bears**

61 upon the fitness of the employee or volunteer to have responsibility for the safety and well-
62 being of children, the elderly, or disabled persons shall solely be made by the qualified
63 entity. This section does not require the highway patrol to make such a determination on
64 behalf of any qualified entity;

65 (8) The qualified entity must notify, in writing, the person of his or her right to
66 obtain a copy of any background screening report, including the criminal history records,
67 if any, contained in the report, and of the person's right to challenge the accuracy and
68 completeness of any information contained in any such report and to obtain a
69 determination as to the validity of such challenge before a final determination regarding
70 the person is made by the qualified entity reviewing the criminal history information. A
71 qualified entity that is required by law to apply screening criteria, including any right to
72 contest or request an exemption from disqualification, shall apply such screening criteria
73 to the state and national criminal history record information received from the highway
74 patrol for those persons subject to the required screening;

75 (9) A qualified entity is not liable for damages solely for failing to obtain the
76 information under this section with respect to an employee or volunteer. The state, any
77 political subdivision of the state, or any agency, officer, or employee of the state or a
78 political subdivision is not liable for damages for providing the information requested
79 under this section.

80 3. [A qualified entity may request a Missouri criminal record review and a national
81 criminal record review of a provider through an authorized state agency. No authorized state
82 agency is required by this section to process Missouri or national criminal record reviews for a
83 qualified entity, however, if an authorized state agency agrees to process Missouri and national
84 criminal record reviews for a qualified entity, the qualified entity shall provide to the authorized
85 state agency on forms and in a manner approved by the highway patrol the following:

86 (1) Two sets of fingerprints of the provider if a national criminal record review is
87 requested;

88 (2) A statement signed by the provider which contains:

89 (a) The provider's name, address, and date of birth;

90 (b) Whether the provider has been convicted of or has pled guilty to a crime which
91 includes a suspended imposition of sentence;

92 (c) If the provider has been convicted of or has pled guilty to a crime, a description of
93 the crime, and the particulars of the conviction or plea;

94 (d) The authority of the qualified entity to check the provider's criminal history;

95 (e) The right of the provider to review the report received by the qualified entity; and

96 (f) The right of the provider to challenge the accuracy of the report. If the challenge is
97 to the accuracy of the criminal record review, the challenge shall be made to the highway patrol.

98 4. The authorized state agency shall forward the required forms and fees to the highway
99 patrol. The results of the record review shall be forwarded to the authorized state agency who
100 will notify the qualified entity. The authorized state agency may assess a fee to the qualified
101 entity to cover the cost of handling the criminal record review and may establish an account
102 solely for the collection and dissemination of fees associated with the criminal record reviews.

103 5. Any information received by an authorized state agency or a qualified entity pursuant
104 to the provisions of this section shall be used solely for internal purposes in determining the
105 suitability of a provider. The dissemination of criminal history information from the Federal
106 Bureau of Investigation beyond the authorized state agency or related governmental entity is
107 prohibited.] All criminal record check information shall be confidential and any person who
108 discloses the information beyond the scope allowed is guilty of a class A misdemeanor.

109 [6.] 4. The highway patrol shall make available or approve the necessary forms,
110 procedures, and agreements necessary to implement the provisions of this section.

82.300. 1. Any city with a population of four hundred thousand or more inhabitants
2 which is located in more than one county may enact all needful ordinances for preserving order,
3 securing persons or property from violence, danger and destruction, protecting public and private
4 property and for promoting the general interests and ensuring the good government of the city,
5 and for the protection, regulation and orderly government of parks, public grounds and other
6 public property of the city, both within and beyond the corporate limits of such city; and to
7 prescribe and impose, enforce and collect fines, forfeitures and penalties for the breach of any
8 provisions of such ordinances and to punish the violation of such ordinances by fine or
9 imprisonment, or by both fine and imprisonment; but no fine shall exceed [five hundred] **one**
10 **thousand** dollars nor imprisonment exceed twelve months for any such offense, except as
11 provided in subsection 2 of this section.

12 2. Any city with a population of four hundred thousand or more inhabitants which is
13 located in more than one county which operates a publicly owned treatment works in accordance
14 with an approved pretreatment program pursuant to the federal Clean Water Act, 33 U.S.C. 1251,
15 et seq. and chapter 644, RSMo, may enact all necessary ordinances which require compliance
16 by an industrial user with any pretreatment standard or requirement. Such ordinances may
17 authorize injunctive relief or the imposition of a fine of at least one thousand dollars but not
18 more than five thousand dollars per violation for noncompliance with such pretreatment

20 considered a separate offense.

21 3. Any city with a population of more than four hundred thousand inhabitants may enact

24 thousand dollars or by imprisonment not to exceed twelve months for each offense, or by both
25 such fine and imprisonment.

26 4. Any city with a population of more than four hundred thousand inhabitants may enact
27 all needful ordinances to protect public and private property from nuisance and property
28 maintenance code violations, and to punish the violation of such ordinances by a fine not to
29 exceed one thousand dollars or by imprisonment not to exceed twelve months for each offense,
30 or by both such fine and imprisonment.

 192.925. 1. To increase public awareness of the problem of elder abuse and neglect **and**
2 **financial exploitation of the elderly**, the department of health and senior services shall
3 implement an education and awareness program. Such program shall have the goal of reducing
4 the incidences of elder abuse and neglect **and financial exploitation of the elderly**, and may
5 focus on:

6 (1) The education and awareness of mandatory reporters on their responsibility to report
7 elder abuse and neglect **and financial exploitation of the elderly**;

8 (2) Targeted education and awareness for the public on the problem, identification and
9 reporting of elder abuse and neglect **and financial exploitation of the elderly**;

10 (3) Publicizing the elder abuse and neglect hot line telephone number;

11 (4) Education and awareness for law enforcement agencies and prosecutors on the
12 problem and identification of elder abuse and neglect **and financial exploitation of the elderly**,
13 and the importance of prosecuting cases pursuant to chapter 565, RSMo; and

14 (5) Publicizing the availability of background checks prior to hiring an individual for
15 caregiving purposes.

16 2. The department of social services and facilities licensed pursuant to chapters 197 and
17 198, RSMo, shall cooperate fully with the department of health and senior services in the
18 distribution of information pursuant to this program.

 195.202. 1. Except as authorized by sections 195.005 to 195.425, it is unlawful for any
2 person to possess or have under his control a controlled substance.

3 2. **Except as provided in subsection 4 of this section**, any person who violates this
4 section with respect to any controlled substance except thirty-five grams or less of marijuana is
5 guilty of a class C felony.

6 3. Any person who violates this section with respect to not more than thirty-five grams
7 of marijuana is guilty of a class A misdemeanor.

8 **4. Any person who violates subsection 2 of this section in the presence of a person**
9 **less than seventeen years of age or in a residence where a person less than seventeen years**
10 **of age resides is guilty of a class B felony.**

210.1012. 1. There is hereby created a statewide program called the "Amber Alert
2 System" referred to in this section as the "system" to aid in the identification and location of an
3 abducted child.

4 2. For the purposes of this section, "abducted child" means a child whose whereabouts
5 are unknown and who is:

6 (1) Less than eighteen years of age and reasonably believed to be the victim of the crime
7 of kidnapping as defined by section 565.110, RSMo, as determined by local law enforcement;

8 (2) Reasonably believed to be the victim of the crime of child kidnapping as defined by
9 section 565.115, RSMo, as determined by [local] law enforcement; or

10 (3) Less than eighteen years of age and at least fourteen years of age, and who[, if under
11 the age of fourteen,] would otherwise be reasonably believed to be a victim of child kidnapping
12 as defined by section 565.115, RSMo, as determined by [local] law enforcement, **if such person**
13 **was under the age of fourteen.**

14 3. The department of public safety shall develop regions to provide the system. The
15 department of public safety shall coordinate local law enforcement agencies and public
16 commercial television and radio broadcasters to provide an effective system. In the event that
17 a local law enforcement agency opts not to set up a system and an abduction occurs within the
18 jurisdiction, it shall notify the department of public safety who will notify local media in the
19 region.

20 4. The Amber alert system shall include all state agencies capable of providing urgent
21 and timely information to the public together with broadcasters and other private entities that
22 volunteer to participate in the dissemination of urgent public information. At a minimum, the
23 Amber alert system shall include the department of public safety, highway patrol, department of
24 transportation, department of health and senior services, and Missouri lottery.

25 5. The department of public safety shall have the authority to notify other regions upon
26 verification that the criteria established by the oversight committee has been met.

27 6. Participation in an Amber alert system is entirely at the option of local law
28 enforcement agencies and federally licensed radio and television broadcasters.

29 7. Any person who knowingly makes a false report that triggers an alert pursuant to this
30 section is guilty of a class A misdemeanor.

217.439. Upon the victim's request, a photograph shall be taken of the incarcerated
2 **individual prior to release from incarceration and a copy of the photograph shall be**
3 **provided to the crime victim.**

217.450. 1. Any person confined in a department correctional facility may request a final disposition of any untried indictment, information or complaint pending in this state on the basis of which a **law enforcement agency, prosecuting attorney's office, or circuit attorney's office has delivered a certified copy of a warrant and has requested that a** detainer [has been] **be** lodged against him [while so imprisoned] **with the facility where the offender is confined**. The request shall be in writing addressed to the court in which the indictment, information or complaint is pending and to the prosecuting attorney charged with the duty of prosecuting it, and shall set forth the place of imprisonment.

2. **When the director receives a certified copy of a warrant and a written request by the issuing agency to place a detainer, the director shall lodge a detainer in favor of the requesting agency.** The director shall promptly inform each offender in writing of the source and nature of any untried indictment, information or complaint for which a detainer has been lodged against him of which the director has knowledge, and of his right to make a request for final disposition of such indictment, information or complaint on which the detainer is based.

3. Failure of the director to [inform an offender, as required by this section, within one year after a detainer has been filed at the facility shall entitle him to a final dismissal of the indictment, information or complaint with prejudice] **comply with this section shall not be the basis for dismissing the indictment, information, or complaint unless the court also finds that the offender has been denied his constitutional right to a speedy trial.**

217.460. Within one hundred eighty days after the receipt of the request and certificate, pursuant to sections 217.450 and 217.455, by the court and the prosecuting attorney or within such additional necessary or reasonable time as the court may grant, for good cause shown in open court, the offender or his counsel being present, the indictment, information or complaint shall be brought to trial. The parties may stipulate for a continuance or a continuance may be granted if notice is given to the attorney of record with an opportunity for him to be heard. If the indictment, information or complaint is not brought to trial within the period **and if the court finds that the offender's constitutional right to a speedy trial has been denied**, no court of this state shall have jurisdiction of such indictment, information or complaint, nor shall the untried indictment, information or complaint be of any further force or effect; and the court shall issue an order dismissing the same with prejudice.

217.665. 1. Beginning August 28, 1996, the board of probation and parole shall consist of seven members appointed by the governor by and with the advice and consent of the senate.

2. Beginning August 28, 1996, members of the board shall be persons of recognized integrity and honor, known to possess education and ability in decision making through career experience and other qualifications for the successful performance of their official duties. Not more than four members of the board shall be of the same political party.

7 3. At the expiration of the term of each member and of each succeeding member, the

217.670. 1. The board shall adopt an official seal of which the courts shall take official
2 notice.

3 2. Decisions of the board regarding granting of paroles, extensions of a conditional
4 release date or revocations of a parole or conditional release shall be by a majority vote of the
5 hearing panel members. The hearing panel shall consist of one member of the board and two
6 hearing officers appointed by the board. A member of the board may remove the case from the

2 away or otherwise supply any intoxicating liquor, **or any nonintoxicating beer as defined in**
3 **section 312.010, RSMo**, in any quantity whatsoever to any person under the age of twenty-one
4 years, or to any person intoxicated or appearing to be in a state of intoxication, or to a habitual
5 drunkard, and any person whomsoever except his parent or guardian who shall procure for, sell,
6 give away or otherwise supply intoxicating liquor to any person under the age of twenty-one
7 years, or to any intoxicated person or any person appearing to be in a state of intoxication, or to
8 a habitual drunkard, shall be deemed guilty of a misdemeanor, except that this section shall not
9 apply to the supplying of intoxicating liquor to a person under the age of twenty-one years for
10 medical purposes only, or to the administering of such intoxicating liquor to any person by a duly
11 licensed physician. No person shall be denied a license or renewal of a license issued under this
12 chapter solely due to a conviction for unlawful sale or supply to a minor when serving in the
13 capacity as an employee of a licensed establishment.

14 2. Any owner, occupant, or other person or legal entity with a lawful right to the
15 exclusive use and enjoyment of any property who knowingly allows a person under the age of

4 **intoxicated condition** as defined in section 577.001, RSMo, or has a detectable blood alcohol
5 content of more than two-hundredths of one percent or more by weight of alcohol in such
6 person's blood is guilty of a misdemeanor. For purposes of prosecution under this section or any
7 other provision of this chapter involving an alleged illegal sale or transfer of intoxicating liquor

17 tested to verify that there is intoxicating liquor in such container. The alleged violator may allege
18 that there was not intoxicating liquor in such container, but the burden of proof of such allegation
19 is on such person, as it shall be presumed that such a sealed container describing that there is
20 intoxicating liquor therein contains intoxicating liquor.

21 3. **Any person under the age of twenty-one years who purchases or attempts to**
22 **purchase, or has in his or her possession, any intoxicating liquor, or who is visibly in an**
23 **intoxicated condition as defined in section 577.001, RSMo, shall be deemed to have given**

- 47 (4) **The type and status of any permit which was held by the person who performed**
48 **the test;**
- 49 (5) **If the test was administered by means of a breath-testing instrument, the date**
50 **of performance of the most recent required maintenance of such instrument.**

52 **Full information does not include manuals, schematics, or software of the instrument used**
53 **to test the person or any other material that is not in the actual possession of the state.**
54 **Additionally, full information does not include information in the possession of the**
55 **manufacturer of the test instrument.**

56 **4. The provisions of this section shall not apply to a student who:**

- 57 (1) **Is eighteen years of age or older;**
- 58 (2) **Is enrolled in an accredited college or university and is a student in a culinary course;**

5 (b) The commission of the crime of assault in the first degree [pursuant to the provisions
6 of section 565.050] or assault in the second degree [pursuant to the provisions of section
7 565.060,] if the victim of the assault was a family or household member;

8 (c) **The commission of a crime in another state, or any federal, tribal, or military**
9 **offense which, if committed in this state, would be a violation of any offense listed in**
10 **paragraph (a) or (b) of this subdivision;**

11 (2) "Family" or "household member", spouses, former spouses, adults related by blood
12 or marriage, adults who are presently residing together or have resided together in the past and
13 adults who have a child in common regardless of whether they have been married or have resided
14 together at any time;

15 (3) "Persistent domestic violence offender", a person who has pleaded guilty to or has
16 been found guilty of two or more domestic assault offenses, where such two or more offenses
17 occurred within ten years of the occurrence of the domestic assault offense for which the person
18 is charged; and

19 (4) "Prior domestic violence offender", a person who has pleaded guilty to or has been
20 found guilty of one domestic assault offense, where such prior offense occurred within five years
21 of the occurrence of the domestic assault offense for which the person is charged.

22 2. No court shall suspend the imposition of sentence as to a prior or persistent domestic
23 violence offender pursuant to this section nor sentence such person to pay a fine in lieu of a term
24 of imprisonment, section 557.011, RSMo, to the contrary notwithstanding, nor shall such person
25 be eligible for parole or probation until such person has served a minimum of six months'
26 imprisonment.

27 3. The court shall find the defendant to be a prior domestic violence offender or
28 persistent domestic violence offender, if:

29 (1) The indictment or information, original or amended, or the information in lieu of an
30 indictment pleads all essential facts warranting a finding that the defendant is a prior domestic
31 violence offender or persistent domestic violence offender; and

32 (2) Evidence is introduced that establishes sufficient facts pleaded to warrant a finding
33 beyond a reasonable doubt the defendant is a prior domestic violence offender or persistent
34 domestic violence offender; and

35 (3) The court makes findings of fact that warrant a finding beyond a reasonable doubt
36 by the court that the defendant is a prior domestic violence offender or persistent domestic

38 4. In a jury trial, such facts shall be pleaded, established and found prior to submission

42 6. The defendant shall be accorded full rights of confrontation and cross-examination,

44 7. The defendant may waive proof of the facts alleged.

45 8. Nothing in this section shall prevent the use of presentence investigations or
46 commitments.

47 9. At the sentencing hearing both the state and the defendant shall be permitted to present
48 additional information bearing on the issue of sentence.

49 10. The pleas or findings of guilty shall be prior to the date of commission of the present
50 offense.

51 11. The court shall not instruct the jury as to the range of punishment or allow the jury,
52 upon a finding of guilty, to assess and declare the punishment as part of its verdict in cases of
53 prior domestic violence offenders or persistent domestic violence offenders.

54 12. Evidence of prior convictions shall be heard and determined by the trial court out of
55 the hearing of the jury prior to the submission of the case to the jury, and shall include but not
56 be limited to evidence of convictions received by a search of the records of the Missouri uniform
57 law enforcement system maintained by the Missouri state highway patrol. After hearing the
58 evidence, the court shall enter its findings thereon.

59 13. Evidence of similar criminal convictions of domestic violence pursuant to this

64 court finds the offender is a prior domestic violence offender. The offender shall be sentenced
65 to the authorized term of imprisonment for a class A felony which term shall be served without
66 probation or parole if the court finds the offender is a persistent domestic violence offender or
67 the prior domestic violence offender inflicts serious physical injury on the victim.

68 15. Any person who has pleaded guilty to or been found guilty of a violation of section
69 565.073 shall be sentenced:

70 (a) To the authorized term of imprisonment for a class B felony if the court finds the
71 offender is a prior domestic violence offender; or

72 (b) To the authorized term of imprisonment for a class A felony if the court finds the
73 offender is a persistent domestic violence offender.

565.081. 1. A person commits the crime of assault of a law enforcement officer,

3 **zone**, or probation and parole officer in the first degree if such person attempts to kill or

7 2. As used in this section, "emergency personnel" means any paid or volunteer
8 firefighter, emergency room or trauma center personnel, or emergency medical technician as
9 defined in subdivisions (15), (16), [and] (17), **and (18)** of section 190.100, RSMo.

10 3. **As used in this section the term "corrections officer" includes any jailer or**
11 **corrections officer of the state or any political subdivision of the state.**

12 **4. When used in this section, the terms "highway worker", "construction zone",**
13 **or "work zone" shall have the same meaning as such terms are defined in section 304.580,**
14 **RSMo.**

15 **5. Assault of a law enforcement officer, corrections officer, emergency personnel,**
16 **highway worker in a construction zone or work zone, or probation and parole officer in the**
17 **first degree is a class A felony.**

 565.082. 1. A person commits the crime of assault of a law enforcement officer,
2 **corrections officer, emergency personnel, highway worker in a construction zone or work**
3 **zone, or probation and parole officer in the second degree if such person:**

4 (1) Knowingly causes or attempts to cause physical injury to a law enforcement officer,
5 **corrections officer, emergency personnel, or probation and parole officer by means of a deadly**

3. A judicial officer's family for purposes of this section shall be:

(1) [His] **Such officer's** spouse; or

(2) [His] **Such officer** or [his] **such officer's** spouse's ancestor or descendant by blood or adoption; or

(3) [His] **Such officer's** stepchild, while the marriage creating that relationship exists.

4. Tampering with a judicial officer is a class C felony.

566.093. 1. A person commits the crime of sexual misconduct in the second degree if such person:

(1) Exposes his or her genitals under circumstances in which he or she knows that his or her conduct is likely to cause affront or alarm;

(2) Has sexual contact in the presence of a third person or persons under circumstances in which he or she knows that such conduct is likely to cause affront or alarm; or

4 endangering the welfare of a child in the first degree; subsection 2 of section 568.080,
5 RSMo, use of a child in a sexual performance; section 568.090, RSMo, promoting a sexual
6 performance by a child; section 573.023, RSMo, sexual exploitation of a minor; section
7 573.025, RSMo, promoting child pornography in the first degree; section 573.035, RSMo,
8 promoting child pornography in the second degree; section 573.037, RSMo, possession of

4 from such record prior to disclosure to the public. Identifying information shall include the
5 name, home or temporary address, telephone number, Social Security number or physical

19 2. Endangering the welfare of a child in the first degree is a class C felony unless the

 570.030. 1. A person commits the crime of stealing if he or she appropriates property
2 or services of another with the purpose to deprive him or her thereof, either without his or her
3 consent or by means of deceit or coercion.

4 2. Evidence of the following is admissible in any criminal prosecution pursuant to this
5 section on the issue of the requisite knowledge or belief of the alleged stealer:

6 (1) That he or she failed or refused to pay for property or services of a hotel, restaurant,
7 inn or boardinghouse;

8 (2) That he or she gave in payment for property or services of a hotel, restaurant, inn or
9 boardinghouse a check or negotiable paper on which payment was refused;

10 (3) That he or she left the hotel, restaurant, inn or boardinghouse with the intent to not

14 (5) That he or she, with intent to cheat or defraud a retailer, possesses, uses, utters,

16 price code label, or possesses with intent to cheat or defraud, the device that manufactures
17 fraudulent receipts or universal price code labels.

18 3. Notwithstanding any other provision of law, any offense in which the value of
19 property or services is an element is a class C felony if:

20 (1) The value of the property or services appropriated is five hundred dollars or more but
21 less than twenty-five thousand dollars; or

22 (2) The actor physically takes the property appropriated from the person of the victim;
23 or

24 (3) The property appropriated consists of:

25 (a) Any motor vehicle, watercraft or aircraft; or

26 (b) Any will or unrecorded deed affecting real property; or

27 (c) Any credit card or letter of credit; or

28 (d) Any firearms; or

29 (e) **Any explosive weapon as defined in section 571.010, RSMo; or**

30 (f) A United States national flag designed, intended and used for display on buildings
31 or stationary flagstaffs in the open; or

32 [(f)] (g) Any original copy of an act, bill or resolution, introduced or acted upon by the
33 legislature of the state of Missouri; or

34 [(g)] (h) Any pleading, notice, judgment or any other record or entry of any court of this
35 state, any other state or of the United States; or

36 [(h)] (i) Any book of registration or list of voters required by chapter 115, RSMo; or

37 [(i)] (j) Any animal of the species of horse, mule, ass, cattle, swine, sheep, or goat; or

38 [(j)] (k) Live fish raised for commercial sale with a value of seventy-five dollars; or

39 [(k)] (l) Any controlled substance as defined by section 195.010, RSMo; or

40 [(l)] (m) Anhydrous ammonia;

41 [(m)] (n) Ammonium nitrate; or

42 [(n)] (o) Any document of historical significance which has fair market value of five
43 hundred dollars or more.

44 4. If an actor appropriates any material with a value less than five hundred dollars in
45 violation of this section with the intent to use such material to manufacture, compound, produce,
46 prepare, test or analyze amphetamine or methamphetamine or any of their analogues, then such
47 violation is a class C felony. The theft of any amount of anhydrous ammonia or liquid nitrogen,
48 or any attempt to steal any amount of anhydrous ammonia or liquid nitrogen, is a class B felony.
49 The theft of any amount of anhydrous ammonia by appropriation of a tank truck, tank trailer, rail
50 tank car, bulk storage tank, field (nurse) tank or field applicator is a class A felony.

51 5. The theft of any item of property or services pursuant to subsection 3 of this section
52 which exceeds five hundred dollars may be considered a separate felony and may be charged in
53 separate counts.

54 6. Any person with a prior conviction of paragraph [(i)] (j) of subdivision (3) of
55 subsection 3 of this section and who violates the provisions of paragraph [(i)] (j) of subdivision
56 (3) of subsection 3 of this section when the value of the animal or animals stolen exceeds three
57 thousand dollars is guilty of a class B felony.

58 7. Any offense in which the value of property or services is an element is a class B felony
59 if the value of the property or services equals or exceeds twenty-five thousand dollars.

60 8. Any violation of this section for which no other penalty is specified in this section is
61 a class A misdemeanor.

570.040. 1. Every person who has previously pled guilty **to** or been found guilty [on two
2 separate occasions] of [a] **two** stealing-related [offense] **offenses committed on two separate**
3 **occasions** where such offenses occurred within ten years of the date of occurrence of the present
4 offense [and where the person received a sentence of ten days or more on such previous offense]
5 and who subsequently pleads guilty or is found guilty of a stealing-related offense is guilty of a
6 class D felony, unless the subsequent plea or guilty verdict is pursuant to paragraph (a) of

7 subdivision (3) of subsection 3 of section 570.030, in which case the person shall be guilty of
8 a class B felony, and shall be punished accordingly.

9 2. As used in this section, the term "stealing-related offense" shall include federal and
10 state violations of criminal statutes against stealing, **robbery**, or buying or receiving stolen
11 property and shall also include municipal ordinances against same if the defendant was either
12 represented by counsel or knowingly waived counsel in writing and the judge accepting the plea
13 or making the findings was a licensed attorney at the time of the court proceedings.

14 3. Evidence of prior guilty pleas or findings of guilt shall be heard by the court, out of
15 the hearing of the jury, prior to the submission of the case to the jury, and the court shall
16 determine the existence of the prior guilty pleas or findings of guilt.

570.080. 1. A person commits the crime of receiving stolen property if for the purpose
2 of depriving the owner of a lawful interest therein, he or she receives, retains or disposes of
3 property of another knowing that it has been stolen, or believing that it has been stolen.

4 2. Evidence of the following is admissible in any criminal prosecution pursuant to this
5 section to prove the requisite knowledge or belief of the alleged receiver:

6 (1) That he or she was found in possession or control of other property stolen on separate
7 occasions from two or more persons;

8 (2) That he or she received other stolen property in another transaction within the year
9 preceding the transaction charged;

10 (3) That he or she acquired the stolen property for a consideration which he or she knew
11 was far below its reasonable value;

12 (4) That he or she obtained control over stolen property knowing the property to have
13 been stolen or under such circumstances as would reasonably induce a person to believe the
14 property was stolen.

15 3. Receiving stolen property is a class A misdemeanor unless the property involved has
16 a value of five hundred dollars or more, or the person receiving the property is a dealer in goods
17 of the type in question, **or the property involved is a firearm or explosive weapon as those**
18 **terms are defined in section 571.010, RSMo**, in which cases receiving stolen property is a class
19 C felony.

575.060. 1. A person commits the crime of making a false declaration if, with the
2 purpose to mislead a public servant in the performance of his **or her** duty, [he] **such person**:

3 (1) Submits any written false statement, which he **or she** does not believe to be true

4 (a) In an application for any pecuniary benefit or other consideration; or

5 (b) On a form bearing notice, authorized by law, that false statements made therein are
6 punishable; or

7 (2) Submits or invites reliance on:

8 (a) Any writing which he **or she** knows to be forged, altered or otherwise lacking in
9 authenticity; or

10 (b) Any sample, specimen, map, boundary mark, or other object which he **or she** knows
11 to be false; **or**

12 **(3) Provides any verbal false statement regarding their identity, which he or she**
13 **believes or knows not to be true.**

14 2. The falsity of the statement or the item under subsection 1 of this section must be as
15 to a fact which is material to the purposes for which the statement is made or the item submitted;
16 and the provisions of subsections 2 and 3 of section 575.040 shall apply to prosecutions under
17 subsection 1 of this section.

18 3. It is a defense to a prosecution under subsection 1 of this section that the actor
19 retracted the false statement or item but this defense shall not apply if the retraction was made
20 after:

21 (1) The falsity of the statement or item was exposed; or

22 (2) The public servant took substantial action in reliance on the statement or item.

23 4. The defendant shall have the burden of injecting the issue of retraction under
24 subsection 3 of this section.

25 5. For the purpose of this section, "written" shall include filings submitted in an
26 electronic or other format or medium approved or prescribed by the secretary of state.

27 6. Making a false declaration is a class B misdemeanor.

575.080. 1. A person commits the crime of making a false report if [he] **such person**
2 knowingly:

3 (1) Gives false information to any person for the purpose of implicating another person
4 in a crime; or

5 (2) Makes a false report to a law enforcement officer that a crime has occurred or is
6 about to occur; or

7 (3) Makes a false report or causes a false report to be made to a law enforcement officer,
8 security officer, fire department or other organization, official or volunteer, which deals with
9 emergencies involving danger to life or property that a fire or other incident calling for an
10 emergency response has occurred or is about to occur.

11 2. It is a defense to a prosecution under subsection 1 of this section that the actor
12 retracted the false statement or report before the law enforcement officer or any other person took
13 substantial action in reliance thereon.

14 3. The defendant shall have the burden of injecting the issue of retraction under
15 subsection 2 of this section.

16 4. Making a false report is a class [B misdemeanor] **A misdemeanor**.

2 **575.082. 1. A person commits the crime of filing a false report if such person**
3 **knowingly files a false report with the Missouri department of natural resources that a**
4 **regulation or ordinance has been violated.**

5 **2. Filing a false report is a class C misdemeanor.**

6 575.150. 1. A person commits the crime of resisting or interfering with arrest, detention,
7 or stop if, knowing that a law enforcement officer is making an arrest, or attempting to lawfully
8 detain or stop an individual or vehicle, or the person reasonably should know that a law
9 enforcement officer is making an arrest or attempting to lawfully detain or lawfully stop an
10 individual or vehicle, for the purpose of preventing the officer from effecting the arrest, stop or
11 detention, the person:

12 (1) Resists the arrest, stop or detention of such person by using or threatening the use of
13 violence or physical force or by fleeing from such officer; or

14 (2) Interferes with the arrest, stop or detention of another person by using or threatening
15 the use of violence, physical force or physical interference.

16 2. This section applies to arrests, stops or detentions with or without warrants and to
17 arrests, stops or detentions for any crime, infraction or ordinance violation. **This section also**
18 **applies to arrests on warrants issued for probation or parole warrants and arrests on**
19 **capias warrants or bench warrants issued by federal, state, or municipal judges.**

20 3. A person is presumed to be fleeing a vehicle stop if that person continues to operate
21 a motor vehicle after that person has seen or should have seen clearly visible emergency lights
22 or has heard or should have heard an audible signal emanating from the law enforcement vehicle
23 pursuing that person.

24 4. It is no defense to a prosecution pursuant to subsection 1 of this section that the law
25 enforcement officer was acting unlawfully in making the arrest. However, nothing in this section
26 shall be construed to bar civil suits for unlawful arrest.

27 5. Resisting or interfering with an arrest for a felony is a class [D] C felony. **Resisting**
28 **or interfering with an arrest for a probation warrant, a parole warrant, a capias warrant,**
29 **or a bench warrant where such warrant issued was related to a felony, is a class D felony.**
30 Resisting an arrest, detention or stop by fleeing in such a manner that the person fleeing creates
31 a substantial risk of serious physical injury or death to any person is a class [D] C felony;
32 otherwise, resisting or interfering with an arrest, detention or stop in violation of subdivision (1)
33 or (2) of subsection 1 of this section is a class A misdemeanor.

34 **575.153. 1. A person commits the crime of disarming a peace officer, as defined in**
35 **section 590.100, RSMo, or a correctional officer if such person intentionally:**

3 (1) **Removes a firearm or other deadly weapon from the person of a peace officer**
 4 **or correctional officer while such officer is acting within the scope of his or her official**
 5 **duties; or**

6 (2) **Deprives a peace officer or correctional officer of such officer's use of a firearm**
 7 **or deadly weapon while the officer is acting within the scope of his or her official duties.**

8 **2. The provisions of this section shall not apply when:**

9 (1) **The defendant does not know or could not reasonably have known that the**
 10 **person he or she disarmed was a peace officer or correctional officer; or**

11 (2) **The peace officer or correctional officer was engaged in an incident involving**
 12 **felonious conduct by the peace officer or correctional officer at the time the defendant**
 13 **disarmed such officer.**

14 **3. Disarming a peace officer or correctional officer is a class C felony.**

 575.260. 1. A person commits the crime of tampering with a judicial proceeding if, with
 2 purpose to influence the official action of a judge, juror, special master, referee [or] , arbitrator,
 3 **or state prosecuting or circuit attorney** in a judicial proceeding, he **or she:**

4 (1) Threatens or causes harm to any person or property; or

5 (2) Engages in conduct reasonably calculated to harass or alarm such official or juror;
 6 or

7 (3) Offers, confers or agrees to confer any benefit, direct or indirect, upon such official
 8 or juror.

9 2. Tampering with a judicial proceeding is a class C felony.

577.029. A licensed physician, registered nurse, or trained medical technician acting
 2 **at the request and direction of the law enforcement officer, shall withdraw blood for the**
 3 **purpose of determining the alcohol content of the blood, unless such medical personnel, in**
 4 **his or her good faith medical judgment, believes such procedure would endanger the life**
 5 **or health of the person in custody. Blood may be withdrawn only by such medical**
 6 **personnel, but such restriction shall not apply to the taking of a breath test, a saliva**
 7 **specimen, or a urine specimen. In withdrawing blood for the purpose of determining the**
 8 **alcohol content thereof, only a previously unused and sterile needle and sterile vessel shall**
 9 **be utilized and the withdrawal shall otherwise be in strict accord with accepted medical**
 10 **practices. Upon the request of the person who is tested, full information concerning the**
 11 **test taken at the direction of the law enforcement officer shall be made available to him or**
 12 **her.**

 578.250. No person shall intentionally smell or inhale the fumes of any solvent,
 2 particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite,**
 3 **and propyl nitrite and their iso-analogues** or induce any other person to do so, for the purpose

4 of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria, dizziness,
5 excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of senses or
6 nervous system, or for the purpose of, in any manner, changing, distorting, or disturbing the
7 audio, visual, or mental processes; except that this section shall not apply to the inhalation of any
8 anesthesia for medical or dental purposes.

578.255. 1. **As used in this section "alcohol beverage vaporizer" means any device
2 which, by means of heat, a vibrating element, or any method, is capable of producing a
3 breathable mixture containing one or more alcoholic beverages to be dispensed for
4 inhalation into the lungs via the nose or mouth or both.**

5 **2. No person shall intentionally or willfully induce the symptoms of intoxication, elation,
6 euphoria, dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or
7 dulling of the senses or nervous system, distortion of audio, visual or mental processes by the
8 use or abuse of any [solvent, particularly toluol.] of the following substances:**

- 9 **(1) Solvents, particularly toluol;**
- 10 **(2) Ethyl alcohol;**
- 11 **(3) Amyl nitrite and its iso-analogues;**
- 12 **(4) Butyl nitrite and its iso-analogues;**
- 13 **(5) Cyclohexyl nitrite and its iso-analogues;**
- 14 **(6) Ethyl nitrite and its iso-analogues;**
- 15 **(7) Pentyl nitrite and its iso-analogues; and**
- 16 **(8) Propyl nitrite and its iso-analogues.**

17 **3. This section shall not apply to substances that have been approved by the United
18 States Food and Drug Administration as therapeutic drug products or are contained in
19 approved over-the-counter drug products or administered lawfully pursuant to the order
20 of an authorized medical practitioner.**

21 [2.] **4. No person shall intentionally possess any solvent, particularly toluol, amyl nitrite,
22 butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-
23 analogues for the purpose of using it in the manner prohibited by section 578.250 and this
24 section.**

25 **5. No person shall possess or use an alcoholic beverage vaporizer.**

26 **6. Nothing in this section shall be construed to prohibit the legal consumption of
27 intoxicating liquor, as defined by section 311.020, RSMo, or nonintoxicating beer, as
28 defined by section 312.010, RSMo.**

578.260. 1. No person shall intentionally possess or buy any solvent, particularly toluol,
2 **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite**

3 **and their iso-analogues** for the purpose of inducing or aiding any other person to violate the
4 provisions of sections 578.250 and 578.255.

5 2. Any person who violates any provision of sections 578.250 to 578.260 is guilty of a
6 class B misdemeanor **for the first violation and a class D felony for any subsequent**
7 **violations.**

8 578.265. 1. No person shall knowingly and intentionally sell or otherwise transfer
2 possession of any solvent, particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite,**
3 **ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-analogues** to any person for the
4 purpose of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria,
5 dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of
6 senses or nervous system, or for the purpose of, in any manner, changing, distorting, or
7 disturbing the audio, visual, or mental processes.

8 2. No person who owns or operates any business which receives over fifty percent of its
9 gross annual income from the sale of alcoholic beverages or beer shall sell or offer for sale
10 toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl**
11 **nitrite and their iso-analogues,** or any toxic glue.

12 3. **No person who owns or operates any business which operates as a venue for live**
13 **entertainment performance or receives over fifty percent of its gross annual income from**
14 **the sale of recorded video entertainment shall sell or offer for sale toluol, amyl nitrite, butyl**
15 **nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, propyl nitrite or their iso-analogues.**

16 4. Any person who violates the provisions of subsection 1 or 2 of this section is guilty
17 of a class C felony.

595.010. 1. As used in sections 595.010 to 595.075, unless the context requires
2 otherwise, the following terms shall mean:

3 (1) "Child", a dependent, unmarried person who is under eighteen years of age and
4 includes a posthumous child, stepchild, or an adopted child;

5 (2) "Claimant", a victim or a dependent, relative, survivor, or member of the family, of
6 a victim eligible for compensation pursuant to sections 595.010 to 595.075;

7 (3) "Conservator", a person or corporation appointed by a court to have the care and
8 custody of the estate of a minor or a disabled person, including a limited conservator;

9 (4) "Counseling", problem-solving and support concerning emotional issues that result
10 from criminal victimization licensed pursuant to section 595.030. Counseling is a confidential
11 service provided either on an individual basis or in a group. Counseling has as a primary purpose
12 to enhance, protect and restore a person's sense of well-being and social functioning after
13 victimization. Counseling does not include victim advocacy services such as crisis telephone

14 counseling, attendance at medical procedures, law enforcement interviews or criminal justice
15 proceedings;

16 (5) "Crime", an act committed in this state which, if committed by a mentally competent,
17 criminally responsible person who had no legal exemption or defense, would constitute a crime;
18 provided that, such act involves the application of force or violence or the threat of force or
19 violence by the offender upon the victim but shall include the crime of driving while intoxicated,
20 vehicular manslaughter and hit and run; and provided, further, that no act involving the operation
21 of a motor vehicle except driving while intoxicated, vehicular manslaughter and hit and run
22 which results in injury to another shall constitute a crime for the purpose of sections 595.010 to
23 595.075, unless such injury was intentionally inflicted through the use of a motor vehicle. A
24 crime shall also include an act of terrorism, as defined in 18 U.S.C. section 2331, which has been
25 committed outside of the United States against a resident of Missouri;

26 (6) "Crisis intervention counseling", helping to reduce psychological trauma where
27 victimization occurs;

28 (7) "Department", the department of public safety;

29 (8) "Dependent", mother, father, spouse, spouse's mother, spouse's father, child,
30 grandchild, adopted child, illegitimate child, niece or nephew, who is wholly or partially
31 dependent for support upon, and living with, but shall include children entitled to child support
32 but not living with, the victim at the time of his injury or death due to a crime alleged in a claim
33 pursuant to sections 595.010 to [595.070] **595.075**;

34 (9) "Direct service", providing physical services to a victim of crime including, but not
35 limited to, transportation, funeral arrangements, child care, emergency food, clothing, shelter,
36 notification and information;

37 (10) "Director", the director of public safety of this state or a person designated by him
38 for the purposes of sections 595.010 to [595.070] **595.075**;

39 (11) "Disabled person", one who is unable by reason of any physical or mental condition
40 to receive and evaluate information or to communicate decisions to such an extent that the
41 person lacks ability to manage his financial resources, including a partially disabled person who
42 lacks the ability, in part, to manage his financial resources;

43 (12) ["Division", the division of workers' compensation of the state of Missouri;

44 (13)] "Emergency service", those services provided within thirty days to alleviate the
45 immediate effects of the criminal act or offense, and may include cash grants of not more than
46 one hundred dollars;

47 [(14)] **(13)** "Earnings", net income or net wages;

48 [(15)] (14) "Family", the spouse, parent, grandparent, stepmother, stepfather, child,
49 grandchild, brother, sister, half brother, half sister, adopted children of parent, or spouse's
50 parents;

51 [(16)] (15) "Funeral expenses", the expenses of the funeral, burial, cremation or other
52 chosen method of interment, including plot or tomb and other necessary incidents to the
53 disposition of the remains;

54 [(17)] (16) "Gainful employment", engaging on a regular and continuous basis, up to
55 the date of the incident upon which the claim is based, in a lawful activity from which a person
56 derives a livelihood;

57 [(18)] (17) "Guardian", one appointed by a court to have the care and custody of the
58 person of a minor or of an incapacitated person, including a limited guardian;

59 [(19)] (18) "Hit and run", the crime of leaving the scene of a motor vehicle accident as
60 defined in section 577.060, RSMo;

61 [(20)] (19) "Incapacitated person", one who is unable by reason of any physical or
62 mental condition to receive and evaluate information or to communicate decisions to such an
63 extent that he lacks capacity to meet essential requirements for food, clothing, shelter, safety or
64 other care such that serious physical injury, illness, or disease is likely to occur, including a
65 partially incapacitated person who lacks the capacity to meet, in part, such essential
66 requirements;

67 [(21)] (20) "Injured victim", a person:

68 (a) Killed or receiving a personal physical injury in this state as a result of another
69 person's commission of or attempt to commit any crime;

70 (b) Killed or receiving a personal physical injury in this state while in a good faith
71 attempt to assist a person against whom a crime is being perpetrated or attempted;

72 (c) Killed or receiving a personal physical injury in this state while assisting a law
73 enforcement officer in the apprehension of a person who the officer has reason to believe has
74 perpetrated or attempted a crime;

75 [(22)] (21) "Law enforcement official", a sheriff and his regular deputies, municipal
76 police officer or member of the Missouri state highway patrol and such other persons as may be
77 designated by law as peace officers;

78 [(23)] (22) "Offender", a person who commits a crime;

79 [(24)] (23) "Personal physical injury", actual bodily harm only with respect to the
80 victim. Personal physical injury may include mental or nervous shock resulting from the specific
81 incident upon which the claim is based;

82 [(25)] (24) "Private agency", a not-for-profit corporation, in good standing in this state,
83 which provides services to victims of crime and their dependents;

84 [(26)] (25) "Public agency", a part of any local or state government organization which
85 provides services to victims of crime;

86 [(27)] (26) "Relative", the spouse of the victim or a person related to the victim within
87 the third degree of consanguinity or affinity as calculated according to civil law;

88 [(28)] (27) "Survivor", the spouse, parent, legal guardian, grandparent, sibling or child
89 of the deceased victim of the victim's household at the time of the crime;

90 [(29)] (28) "Victim", a person who suffers personal physical injury or death as a direct
91 result of a crime, as defined in subdivision (5) of this subsection;

92 [(30)] (29) "Victim advocacy", assisting the victim of a crime and his dependents to
93 acquire services from existing community resources.

94 2. As used in sections 565.024 and 565.060, RSMo, and sections 595.010 to 595.075,
95 the term "alcohol-related traffic offense" means those offenses defined by sections 577.001,
96 577.010, and 577.012, RSMo, and any county or municipal ordinance which prohibits operation
97 of a motor vehicle while under the influence of alcohol.

595.015. 1. The [division of workers' compensation] **department of public safety** shall,
2 pursuant to the provisions of sections 595.010 to 595.075, have jurisdiction to determine and
3 award compensation to, or on behalf of, victims of crimes. The [division of workers'
4 compensation] **department of public safety** may pay directly to the provider of the services
5 compensation for medical or funeral expenses, or expenses for other services as described in
6 section 595.030, incurred by the claimant. The [division] **department** is not required to provide
7 compensation in any case, nor is it required to award the full amount claimed. The [division]
8 **department** shall make its award of compensation based upon independent verification obtained
9 during its investigation.

10 2. Such claims shall be made by filing an application for compensation with the [division
11 of workers' compensation] **department of public safety**. The application form shall be
12 furnished by the [division] **department** and the signature shall be notarized. The application
13 shall include:

14 (1) The name and address of the victim;

15 (2) If the claimant is not the victim, the name and address of the claimant and
16 relationship to the victim, the names and addresses of the victim's dependents, if any, and the
17 extent to which each is so dependent;

18 (3) The date and nature of the crime or attempted crime on which the application for
19 compensation is based;

20 (4) The date and place where, and the law enforcement officials to whom, notification
21 of the crime was given;

22 (5) The nature and extent of the injuries sustained by the victim, the names and addresses
23 of those giving medical and hospital treatment to the victim and whether death resulted;

24 (6) The loss to the claimant or a dependent resulting from the injury or death;

25 (7) The amount of benefits, payments or awards, if any, payable from any source which
26 the claimant or dependent has received or for which the claimant or dependent is eligible as a
27 result of the injury or death;

28 (8) Releases authorizing the surrender to the [division] **department** of reports,
29 documents and other information relating to the matters specified under this section; and

30 (9) Such other information as the [division] **department** determines is necessary.

31 3. In addition to the application, the [division] **department** may require that the claimant
32 submit materials substantiating the facts stated in the application.

33 4. If the [division] **department** finds that an application does not contain the required
34 information or that the facts stated therein have not been substantiated, it shall notify the
35 claimant in writing of the specific additional items of information or materials required and that
36 the claimant has thirty days from the date of mailing in which to furnish those items to the
37 [division] **department**. Unless a claimant requests and is granted an extension of time by the
38 [division] **department**, the [division] **department** shall reject with prejudice the claim of the
39 claimant for failure to file the additional information or materials within the specified time.

40 5. The claimant may file an amended application or additional substantiating materials
41 to correct inadvertent errors or omissions at any time before the [division] **department** has
42 completed its consideration of the original application.

43 6. The claimant, victim or dependent shall cooperate with law enforcement officials in
44 the apprehension and prosecution of the offender in order to be eligible, or the [division]
45 **department** has found that the failure to cooperate was for good cause.

46 7. Any state or local agency, including a prosecuting attorney or law enforcement agency,
47 shall make available without cost to the fund, all reports, files and other appropriate information
48 which the [division] **department** requests in order to make a determination that a claimant is
49 eligible for an award pursuant to sections 595.010 to 595.075.

595.020. 1. Except as hereinafter provided, the following persons shall be eligible for
2 compensation pursuant to sections 595.010 to 595.075:

3 (1) A victim of a crime;

4 (2) In the case of a sexual assault victim:

5 (a) A relative of the victim requiring counseling in order to better assist the victim in his
6 recovery; and

7 (3) In the case of the death of the victim as a direct result of the crime:

8 (a) A dependent of the victim;

9 (b) Any member of the family who legally assumes the obligation, or who pays the
10 medical or burial expenses incurred as a direct result thereof; and

11 (c) A survivor of the victim requiring counseling as a direct result of the death of the
12 victim.

13 2. An offender or an accomplice of an offender shall in no case be eligible to receive
14 compensation with respect to a crime committed by the offender. No victim or dependent shall
15 be denied compensation solely because he is a relative of the offender or was living with the
16 offender as a family or household member at the time of the injury or death. However, the
17 [division] **department** may award compensation to a victim or dependent who is a relative,
18 family or household member of the offender only if the [division] **department** can reasonably
19 determine the offender will receive no substantial economic benefit or unjust enrichment from
20 the compensation.

21 3. No compensation of any kind may be made to a victim or intervenor injured while
22 confined in any federal, state, county, or municipal jail, prison or other correctional facility,
23 including house arrest **or electronic monitoring**.

24 4. No compensation of any kind may be made to a victim who has been finally
25 adjudicated and found guilty, in a criminal prosecution under the laws of this state, of two
26 felonies within the past ten years, of which one or both involves illegal drugs or violence. The
27 [division] **department** may waive this restriction if it determines that the interest of justice
28 would be served otherwise.

29 5. In the case of a claimant who is not otherwise ineligible pursuant to subsection 4 of
30 this section, who is incarcerated as a result of a conviction of a crime not related to the incident
31 upon which the claim is based at the time of application, or at any time following the filing of
32 the application:

33 (1) The [division] **department** shall suspend all proceedings and payments until such
34 time as the claimant is released from incarceration;

35 (2) The [division] **department** shall notify the applicant at the time the proceedings are
36 suspended of the right to reactivate the claim within six months of release from incarceration.
37 The notice shall be deemed sufficient if mailed to the applicant at the applicant's last known
38 address;

39 (3) The claimant shall file an application to request that the case be reactivated not later
40 than six months after the date the claimant is released from incarceration. Failure to file such
41 request within the six-month period shall serve as a bar to any recovery.

42 6. Victims of crime who are not residents of the state of Missouri may be compensated
43 only when federal funds are available for that purpose. Compensation for nonresident victims
44 shall terminate when federal funds for that purpose are no longer available.

45 7. A Missouri resident who suffers personal physical injury or, in the case of death, a
46 dependent of the victim or any member of the family who legally assumes the obligation, or who
47 pays the medical or burial expenses incurred as a direct result thereof, in another state,
48 possession or territory of the United States may make application for compensation in Missouri
49 if:

50 (1) The victim of the crime would be compensated if the crime had occurred in the state
51 of Missouri;

52 (2) The place that the crime occurred is a state, possession or territory of the United
53 States, or location outside of the United States that is covered and defined in 18 U.S.C. section
54 2331, that does not have a crime victims' compensation program for which the victim is eligible
55 and which provides at least the same compensation that the victim would have received if he had
56 been injured in Missouri.

595.025. 1. A claim for compensation may be filed by a person eligible for
2 compensation or, if the person is an incapacitated or disabled person, or a minor, by the person's
3 spouse, parent, conservator, or guardian.

4 2. A claim shall be filed not later than two years after the occurrence of the crime or the
5 discovery of the crime upon which it is based.

6 3. Each claim shall be filed in person or by mail. The [division of workers'
7 compensation] **department of public safety** shall investigate such claim, prior to the opening
8 of formal proceedings. The claimant shall be notified of the date and time of any hearing on such
9 claim. In determining the amount of compensation for which a claimant is eligible, the [division]
10 **department** shall consider the facts stated on the application filed pursuant to section 595.015,
11 and:

12 (1) Need not consider whether or not the alleged assailant has been apprehended or
13 brought to trial or the result of any criminal proceedings against that person; however, if any
14 person is convicted of the crime which is the basis for an application for compensation, proof
15 of the conviction shall be conclusive evidence that the crime was committed;

16 (2) Shall determine the amount of the loss to the claimant, or the victim's survivors or
17 dependents;

18 (3) Shall determine the degree or extent to which the victim's acts or conduct provoked,
19 incited, or contributed to the injuries or death of the victim.

20 4. The claimant may present evidence and testimony on his own behalf or may retain
21 counsel. The [division of workers' compensation] **department of public safety** may, as part of
22 any award entered under sections 595.010 to 595.075, determine and allow reasonable attorney's
23 fees, which shall not exceed fifteen percent of the amount awarded as compensation under
24 sections 595.010 to 595.075, which fee shall be paid out of, but not in addition to, the amount

25 of compensation, to the attorney representing the claimant. No attorney for the claimant shall
26 ask for, contract for or receive any larger sum than the amount so allowed.

27 5. The person filing a claim shall, prior to any hearing thereon, submit reports, if
28 available, from all hospitals, physicians or surgeons who treated or examined the victim for the
29 injury for which compensation is sought. If, in the opinion of the [division of workers'
30 compensation] **department of public safety**, an examination of the injured victim and a report
31 thereon, or a report on the cause of death of the victim, would be of material aid, the [division
32 of workers' compensation] **department of public safety** may appoint a duly qualified, impartial
33 physician to make such examination and report.

34 6. Each and every payment shall be exempt from attachment, garnishment or any other
35 remedy available to creditors for the collection of a debt.

36 7. Payments of compensation shall not be made directly to any person legally
37 incompetent to receive them but shall be made to the parent, guardian or conservator for the
38 benefit of such minor, disabled or incapacitated person.

595.027. 1. Upon request by the [division] **department** for verification of injuries of
2 victims, medical providers shall submit the information requested by the [division] **department**
3 within twenty working days of the request at no cost to the fund.

4 2. For purposes of this section, "medical providers" means physicians, **pharmacists**,
5 dentists, clinical psychologists, optometrists, podiatrists, registered nurses, physician's assistants,
6 chiropractors, physical therapists, hospitals, **pharmacies**, ambulatory surgical centers, and
7 nursing homes.

8 3. Failure to submit the information as required by this section shall be an infraction.

595.030. 1. No compensation shall be paid unless the claimant has incurred an
2 out-of-pocket loss of at least fifty dollars or has lost two continuous weeks of earnings or support
3 from gainful employment. "Out-of-pocket loss" shall mean unreimbursed or unreimbursable
4 expenses or indebtedness reasonably incurred:

5 (1) For medical care or other services, including psychiatric, psychological or counseling
6 expenses, necessary as a result of the crime upon which the claim is based, except that the
7 amount paid for psychiatric, psychological or counseling expenses per eligible claim shall not
8 exceed two thousand five hundred dollars; or

9 (2) As a result of personal property being seized in an investigation by law enforcement.
10 Compensation paid for an out-of-pocket loss under this subdivision shall be in an amount equal
11 to the loss sustained, but shall not exceed two hundred fifty dollars.

12 2. No compensation shall be paid unless the [division of workers' compensation]
13 **department of public safety** finds that a crime was committed, that such crime directly resulted
14 in personal physical injury to, or the death of, the victim, and that police records show that such

15 crime was promptly reported to the proper authorities. In no case may compensation be paid if
16 the police records show that such report was made more than forty-eight hours after the
17 occurrence of such crime, unless the [division of workers' compensation] **department of public**
18 **safety** finds that the report to the police was delayed for good cause. If the victim is under
19 eighteen years of age such report may be made by the victim's parent, guardian or custodian; by
20 a physician, a nurse, or hospital emergency room personnel; by the division of family services
21 personnel; or by any other member of the victim's family. In the case of a sexual offense, filing
22 a report of the offense to the proper authorities may include, but not be limited to, the filing of
23 the report of the forensic examination by the appropriate medical provider, as defined in section
24 [191.225, RSMo] **595.220**, with the prosecuting attorney of the county in which the alleged
25 incident occurred.

26 3. No compensation shall be paid for medical care if the service provider is not a medical
27 provider as that term is defined in section 595.027, and the individual providing the medical care
28 is not licensed by the state of Missouri or the state in which the medical care is provided.

29 4. No compensation shall be paid for psychiatric treatment or other counseling services,
30 including psychotherapy, unless the service provider is a:

31 (1) Physician licensed pursuant to chapter 334, RSMo, or licensed to practice medicine
32 in the state in which the service is provided;

33 (2) Psychologist licensed pursuant to chapter 337, RSMo, or licensed to practice
34 psychology in the state in which the service is provided;

35 (3) Clinical social worker licensed pursuant to chapter 337, RSMo; or

36 (4) Professional counselor licensed pursuant to chapter 337, RSMo.

37 5. Any compensation paid pursuant to sections 595.010 to 595.075 for death or personal
38 injury shall be in an amount not exceeding out-of-pocket loss, together with loss of earnings or
39 support from gainful employment, not to exceed [two] **four** hundred dollars per week, resulting
40 from such injury or death. In the event of death of the victim, an award may be made for
41 reasonable and necessary expenses actually incurred for preparation and burial not to exceed five
42 thousand dollars.

43 6. **Compensation shall be paid under sections 595.010 to 595.075 for replacement**
44 **of clothing, bedding, or other personal items of the victim that are seized by law**
45 **enforcement as evidence of the crime and shall be in an amount equal to the loss sustained**
46 **and not to exceed two hundred fifty dollars.**

47 7. Any compensation for loss of earnings or support from gainful employment shall be
48 in an amount equal to the actual loss sustained not to exceed two hundred dollars per week;
49 provided, however, that no award pursuant to sections 595.010 to 595.075 shall exceed
50 twenty-five thousand dollars. If two or more persons are entitled to compensation as a result of

51 the death of a person which is the direct result of a crime or in the case of a sexual assault, the
52 compensation shall be apportioned by the [division of workers' compensation] **department of**
53 **public safety** among the claimants in proportion to their loss.

54 [7.] **8.** The method and timing of the payment of any compensation pursuant to sections
55 595.010 to 595.075 shall be determined by the [division] **department**.

595.035. 1. For the purpose of determining the amount of compensation payable
2 pursuant to sections 595.010 to 595.075, the [division of workers' compensation] **department**
3 **of public safety** shall, insofar as practicable, formulate standards for the uniform application of
4 sections 595.010 to 595.075, taking into consideration the provisions of sections 595.010 to
5 595.075, the rates and amounts of compensation payable for injuries and death pursuant to other
6 laws of this state and of the United States, excluding pain and suffering, and the availability of
7 funds appropriated for the purpose of sections 595.010 to 595.075. All decisions of the [division
8 of workers' compensation] **department of public safety** on claims [heard] pursuant to sections
9 595.010 to 595.075 shall be in writing, setting forth the name of the claimant, the amount of
10 compensation and the reasons for the decision. The [division of workers' compensation]
11 **department of public safety** shall immediately notify the claimant in writing of the decision and
12 shall forward to the state treasurer a certified copy of the decision and a warrant for the amount
13 of the claim. The state treasurer, upon certification by the commissioner of administration, shall,
14 if there are sufficient funds in the crime victims' compensation fund, pay to or on behalf of the
15 claimant the amount determined by the [division] **department**.

16 2. The crime victims' compensation fund is not a state health program and is not intended
17 to be used as a primary payor to other health care assistance programs, but is a public,
18 quasi-charitable fund whose fundamental purpose is to assist victims of violent crimes through
19 a period of financial hardship, as a payor of last resort. Accordingly, any compensation paid
20 pursuant to sections 595.010 to 595.075 shall be reduced by the amount of any payments,
21 benefits or awards received or to be received as a result of the injury or death:

22 (1) From or on behalf of the offender;

23 (2) Under private or public insurance programs, including champus, Medicare, Medicaid
24 and other state or federal programs, but not including any life insurance proceeds; or

25 (3) From any other public or private funds, including an award payable pursuant to the
26 workers' compensation laws of this state.

27 3. In determining the amount of compensation payable, the [division of workers'
28 compensation] **department of public safety** shall determine whether, because of the victim's
29 consent, provocation, incitement or negligence, the victim contributed to the infliction of the
30 victim's injury or death, and shall reduce the amount of the compensation or deny the claim
31 altogether, in accordance with such determination; provided, however, that the [division of

32 workers' compensation] **department of public safety** may disregard the responsibility of the
33 victim for his or her own injury where such responsibility was attributable to efforts by the
34 victim to aid a victim, or to prevent a crime or an attempted crime from occurring in his or her
35 presence, or to apprehend a person who had committed a crime in his or her presence or had in
36 fact committed a felony.

37 4. In determining the amount of compensation payable pursuant to sections 595.010 to
38 [595.070] **595.075**, monthly Social Security disability or retirement benefits received by the
39 victim shall not be considered by the [division] **department** as a factor for reduction of benefits.

40 5. The [division] **department** shall not be liable for payment of compensation for any
41 out-of-pocket expenses incurred more than three years following the date of the occurrence of
42 the crime upon which the claim is based.

595.037. 1. All information submitted to the **department or division of workers'**
2 **compensation** and any hearing of the division **of workers' compensation** on a claim filed
3 pursuant to sections 595.010 to [595.070] **595.075** shall be open to the public except for the
4 following claims which shall be deemed closed and confidential:

5 (1) A claim in which the alleged assailant has not been brought to trial and disclosure
6 of the information or a public hearing would adversely affect either the apprehension, or the trial,
7 of the alleged assailant;

8 (2) A claim in which the offense allegedly perpetrated against the victim is rape, sodomy
9 or sexual abuse and it is determined by the **department or division of workers' compensation**
10 to be in the best interest of the victim or of the victim's dependents that the information be kept
11 confidential or that the public be excluded from the hearing;

12 (3) A claim in which the victim or alleged assailant is a minor; or

13 (4) A claim in which any record or report obtained by the **department or division of**
14 **workers' compensation**, the confidentiality of which is protected by any other law, shall remain
15 confidential subject to such law.

16 2. The **department and division of workers' compensation**, by separate order, may
17 close any record, report or hearing if it determines that the interest of justice would be frustrated
18 rather than furthered if such record or report was disclosed or if the hearing was open to the
19 public.

595.040. 1. Acceptance of any compensation under sections 595.010 to 595.075 shall
2 subrogate this state, to the extent of such compensation paid, to any right or right of action
3 accruing to the claimant or to the victim to recover payments on account of losses resulting from
4 the crime with respect to which the compensation has been paid. The attorney general may
5 enforce the subrogation, and he shall bring suit to recover from any person to whom
6 compensation is paid, to the extent of the compensation actually paid under sections 595.010 to

7 595.075, any amount received by the claimant from any source exceeding the actual loss to the
8 victim.

9 2. The [division] **department** shall have a lien on any compensation received by the
10 claimant, in addition to compensation received under provisions of sections 595.010 to 595.075,
11 for injuries or death resulting from the incident upon which the claim is based. The claimant
12 shall retain, as trustee for the [division] **department**, so much of the recovered funds as
13 necessary to reimburse the Missouri crime victims' compensation fund to the extent that
14 compensation was awarded to the claimant from that fund.

15 3. If a claimant initiates any legal proceeding to recover restitution or damages related
16 to the crime upon which the claim is based, or if the claimant enters into negotiations to receive
17 any proceeds in settlement of a claim for restitution or damages related to the crime, the claimant
18 shall give the [division] **department** written notice within fifteen days of the filing of the action
19 or entering into negotiations. The [division] **department** may intervene in the proceeding of a
20 complainant to recover the compensation awarded. If a claimant fails to give such written notice
21 to the [division] **department** within the stated time period, or prior to any attempt by claimant
22 to reach a negotiated settlement of claims for recovery of damages related to the crime upon
23 which the claim is based, the [division's] **department's** right of subrogation to receive or recover
24 funds from claimant, to the extent that compensation was awarded by the [division] **department**,
25 shall not be reduced in any amount or percentage by the costs incurred by claimant attributable
26 to such legal proceedings or settlement, including, but not limited to, attorney's fees,
27 investigative cost or cost of court. If such notice is given, attorney fees may be awarded in an
28 amount not to exceed fifteen percent of the amount subrogated to the [division] **department**.

29 4. Whenever compensation is awarded to a claimant who is entitled to restitution from
30 a criminal defendant, the [division] **department** may initiate restitution hearings in such criminal
31 proceedings or intervene in the same. The [division] **department** shall be entitled to receive
32 restitution in such proceedings to the extent compensation was awarded; provided, however, the
33 [division] **department** shall be exempt from the payment of any fees or other charges for the
34 recording of restitution orders in the offices of the judges of probate. The claimant shall notify
35 this [division] **department** when restitution is ordered. Failure to notify the [division]
36 **department** will result in possible forfeiture of any amount already received from the [division]
37 **department**.

38 5. Whenever the [division] **department** shall deem it necessary to protect, maintain or
39 enforce the [division's] **department's** right to subrogation or to exercise any of its powers or to
40 carry out any of its duties or responsibilities, the attorney general may initiate legal proceedings
41 or intervene in legal proceedings as the [division's] **department's** legal representative.

595.045. 1. There is established in the state treasury the "Crime Victims' Compensation Fund". A surcharge of seven dollars and fifty cents shall be assessed as costs in each court proceeding filed in any court in the state in all criminal cases including violations of any county ordinance or any violation of criminal or traffic laws of the state, including an infraction and violation of a municipal ordinance; except that no such fee shall be collected in any proceeding in any court when the proceeding or the defendant has been dismissed by the court or when costs are to be paid by the state, county, or municipality. A surcharge of seven dollars and fifty cents shall be assessed as costs in a juvenile court proceeding in which a child is found by the court to come within the applicable provisions of subdivision (3) of subsection 1 of section 211.031, RSMo.

2. Notwithstanding any other provision of law to the contrary, the moneys collected by clerks of the courts pursuant to the provisions of subsection 1 of this section shall be collected and disbursed in accordance with sections 488.010 to 488.020, RSMo, and shall be payable to the director of the department of revenue.

3. The director of revenue shall deposit annually the amount of two hundred fifty thousand dollars to the state forensic laboratory account administered by the department of public safety to provide financial assistance to defray expenses of crime laboratories if such analytical laboratories are registered with the federal Drug Enforcement Agency or the Missouri department of health and senior services. Subject to appropriations made therefor, such funds shall be distributed by the department of public safety to the crime laboratories serving the courts of this state making analysis of a controlled substance or analysis of blood, breath or urine in relation to a court proceeding.

4. The remaining funds collected under subsection 1 of this section shall be denoted to the payment of an annual appropriation for the administrative and operational costs of the office for victims of crime and, if a statewide automated crime victim notification system is established pursuant to section 650.310, RSMo, to the monthly payment of expenditures actually incurred in the operation of such system. Additional remaining funds shall be subject to the following provisions:

(1) On the first of every month, the director of revenue or the director's designee shall determine the balance of the funds in the crime victims' compensation fund available to satisfy the amount of compensation payable pursuant to sections 595.010 to 595.075, excluding sections 595.050 and 595.055;

(2) Beginning on September 1, 2004, and on the first of each month, the director of revenue or the director's designee shall deposit fifty percent of the balance of funds available to the credit of the crime victims' compensation fund and fifty percent to the services to victims' fund established in section 595.100.

37 5. The director of revenue or such director's designee shall at least monthly report the
38 moneys paid pursuant to this section into the crime victims' compensation fund and the services
39 to victims fund to the [division of workers' compensation and the] department of public safety[,
40 respectively].

41 6. The moneys collected by clerks of municipal courts pursuant to subsection 1 of this
42 section shall be collected and disbursed as provided by sections 488.010 to 488.020, RSMo.
43 Five percent of such moneys shall be payable to the city treasury of the city from which such
44 funds were collected. The remaining ninety-five percent of such moneys shall be payable to the
45 director of revenue. The funds received by the director of revenue pursuant to this subsection
46 shall be distributed as follows:

47 (1) On the first of every month, the director of revenue or the director's designee shall
48 determine the balance of the funds in the crime victims' compensation fund available to satisfy
49 the amount of compensation payable pursuant to sections 595.010 to 595.075, excluding sections
50 595.050 and 595.055;

51 (2) Beginning on September 1, 2004, and on the first of each month the director of
52 revenue or the director's designee shall deposit fifty percent of the balance of funds available to
53 the credit of the crime victims' compensation fund and fifty percent to the services to victims'
54 fund established in section 595.100.

55 7. These funds shall be subject to a biennial audit by the Missouri state auditor. Such
56 audit shall include all records associated with crime victims' compensation funds collected, held
57 or disbursed by any state agency.

58 8. In addition to the moneys collected pursuant to subsection 1 of this section, the court
59 shall enter a judgment in favor of the state of Missouri, payable to the crime victims'
60 compensation fund, of sixty-eight dollars upon a plea of guilty or a finding of guilt for a class
61 A or B felony; forty-six dollars upon a plea of guilty or finding of guilt for a class C or D felony;
62 and ten dollars upon a plea of guilty or a finding of guilt for any misdemeanor under Missouri
63 law except for those in chapter 252, RSMo, relating to fish and game, chapter 302, RSMo,
64 relating to drivers' and commercial drivers' license, chapter 303, RSMo, relating to motor vehicle
65 financial responsibility, chapter 304, RSMo, relating to traffic regulations, chapter 306, RSMo,
66 relating to watercraft regulation and licensing, and chapter 307, RSMo, relating to vehicle
67 equipment regulations. Any clerk of the court receiving moneys pursuant to such judgments
68 shall collect and disburse such crime victims' compensation judgments in the manner provided
69 by sections 488.010 to 488.020, RSMo. Such funds shall be payable to the state treasury and
70 deposited to the credit of the crime victims' compensation fund.

71 9. The clerk of the court processing such funds shall maintain records of all dispositions
72 described in subsection 1 of this section and all dispositions where a judgment has been entered

73 against a defendant in favor of the state of Missouri in accordance with this section; all payments
74 made on judgments for alcohol-related traffic offenses; and any judgment or portion of a
75 judgment entered but not collected. These records shall be subject to audit by the state auditor.
76 The clerk of each court transmitting such funds shall report separately the amount of dollars
77 collected on judgments entered for alcohol-related traffic offenses from other crime victims'
78 compensation collections or services to victims collections.

79 10. The department of revenue shall maintain records of funds transmitted to the crime
80 victims' compensation fund by each reporting court and collections pursuant to subsection 16 of
81 this section and shall maintain separate records of collection for alcohol-related offenses.

82 11. The state courts administrator shall include in the annual report required by section
83 476.350, RSMo, the circuit court caseloads and the number of crime victims' compensation
84 judgments entered.

85 12. All awards made to injured victims under sections 595.010 to 595.105 and all
86 appropriations for administration of sections 595.010 to 595.105, except sections 595.050 and
87 595.055, shall be made from the crime victims' compensation fund. Any unexpended balance
88 remaining in the crime victims' compensation fund at the end of each biennium shall not be
89 subject to the provision of section 33.080, RSMo, requiring the transfer of such unexpended
90 balance to the ordinary revenue fund of the state, but shall remain in the crime victims'
91 compensation fund. In the event that there are insufficient funds in the crime victims'
92 compensation fund to pay all claims in full, all claims shall be paid on a pro rata basis. If there
93 are no funds in the crime victims' compensation fund, then no claim shall be paid until funds
94 have again accumulated in the crime victims' compensation fund. When sufficient funds become
95 available from the fund, awards which have not been paid shall be paid in chronological order
96 with the oldest paid first. In the event an award was to be paid in installments and some
97 remaining installments have not been paid due to a lack of funds, then when funds do become
98 available that award shall be paid in full. All such awards on which installments remain due
99 shall be paid in full in chronological order before any other postdated award shall be paid. Any
100 award pursuant to this subsection is specifically not a claim against the state, if it cannot be paid
101 due to a lack of funds in the crime victims' compensation fund.

102 13. When judgment is entered against a defendant as provided in this section and such
103 sum, or any part thereof, remains unpaid, there shall be withheld from any disbursement,
104 payment, benefit, compensation, salary, or other transfer of money from the state of Missouri to
105 such defendant an amount equal to the unpaid amount of such judgment. Such amount shall be
106 paid forthwith to the crime victims' compensation fund and satisfaction of such judgment shall

118 16. [Any gifts, contributions, grants or federal funds specifically given to the division
119 for the benefit of victims of crime shall be credited to the crime victims' compensation fund.
120 Payment or expenditure of moneys in such funds shall comply with any applicable federal crime
121 victims' compensation laws, rules, regulations or other applicable federal guidelines] **The**
122 **department may receive gifts and contributions for the benefit of crime victims. Such gifts**
123 **and contributions shall be credited to the crime victims' compensation fund as used solely**
124 **for compensating victims under the provisions of sections 595.010 to 595.075.**

2 595.060. The director shall promulgate rules and regulations necessary to implement
3 the provisions of sections 595.010 to [595.070] **595.220** as provided in this section and chapter
4 536, RSMo. In the performance of its functions under sections 595.010 to [595.070] **section**
5 **595.036**, the division **of workers' compensation** is authorized to promulgate rules pursuant to
6 chapter 536, RSMo, prescribing the procedures to be followed in the filing of applications and
7 the proceedings under sections 595.010 to [595.070] **section 595.036**. [No rule or portion of a
8 rule promulgated under the authority of this chapter shall become effective unless it has been
9 promulgated pursuant to the provisions of section 536.024, RSMo.] **Any rule or portion of a**
10 **rule, as that term is defined in section 536.010, RSMo, that is created under the authority**
11 **delegated in this section shall become effective only if it complies with and is subject to all**
12 **of the provisions of chapter 536, RSMo, and, if applicable, section 536.028, RSMo. This**
13 **section and chapter 536, RSMo, are nonseverable and if any of the powers vested with the**
14 **general assembly pursuant to chapter 536, RSMo, to review, to delay the effective date, or**
15 **to disapprove and annul a rule are subsequently held unconstitutional, then the grant of**
16 **rulemaking authority and any rule proposed or adopted after August 28, 2009, shall be**
invalid and void.

2 595.209. 1. The following rights shall automatically be afforded to victims of dangerous
3 felonies, as defined in section 556.061, RSMo, victims of murder in the first degree, as defined
4 in section 565.020, RSMo, victims of voluntary manslaughter, as defined in section 565.023,
5 RSMo, and victims of an attempt to commit one of the preceding crimes, as defined in section

5 564.011, RSMo; and, upon written request, the following rights shall be afforded to victims of
6 all other crimes and witnesses of crimes:

7 (1) For victims, the right to be present at all criminal justice proceedings at which the
8 defendant has such right, including juvenile proceedings where the offense would have been a
9 felony if committed by an adult, even if the victim is called to testify or may be called to testify
10 as a witness in the case;

11 (2) For victims, the right to information about the crime, as provided for in subdivision
12 (5) of this subsection;

13 (3) For victims and witnesses, to be informed, in a timely manner, by the prosecutor's
14 office of the filing of charges, preliminary hearing dates, trial dates, continuances and the final
15 disposition of the case. Final disposition information shall be provided within five days;

16 (4) For victims, the right to confer with and to be informed by the prosecutor regarding
17 bail hearings, guilty pleas, pleas under chapter 552, RSMo, or its successors, hearings, sentencing
18 and probation revocation hearings and the right to be heard at such hearings, including juvenile
19 proceedings, unless in the determination of the court the interests of justice require otherwise;

20 (5) The right to be informed by local law enforcement agencies, the appropriate juvenile
21 authorities or the custodial authority of the following:

22 (a) The status of any case concerning a crime against the victim, including juvenile
23 offenses;

24 (b) The right to be informed by local law enforcement agencies or the appropriate
25 juvenile authorities of the availability of victim compensation assistance, assistance in obtaining
26 documentation of the victim's losses, including, but not limited to and subject to existing law
27 concerning protected information or closed records, access to copies of complete, unaltered,
28 unedited investigation reports of motor vehicle, pedestrian, and other similar accidents upon
29 request to the appropriate law enforcement agency by the victim or the victim's representative,
30 and emergency crisis intervention services available in the community;

31 (c) Any release of such person on bond or for any other reason;

32 (d) Within twenty-four hours, any escape by such person from a municipal detention
33 facility, county jail, a correctional facility operated by the department of corrections, mental
34 health facility, or the division of youth services or any agency thereof, and any subsequent
35 recapture of such person;

36 (6) For victims, the right to be informed by appropriate juvenile authorities of probation
37 revocation hearings initiated by the juvenile authority and the right to be heard at such hearings
38 or to offer a written statement, video or audio tape, **counsel** or a [statement by counsel or a]
39 representative designated by the victim [on behalf of the victim] in lieu of a personal appearance,
40 the right to be informed by the board of probation and parole of probation revocation hearings

41 initiated by the board and of parole hearings, the right to be present at each and every phase of
42 parole hearings, the right to be heard at probation revocation and parole hearings or to offer a
43 written statement, video or audio tape, **counsel or a representative designated by the victim**
44 in lieu of a personal appearance, and the right to have, upon written request of the victim, a
45 partition set up in the probation or parole hearing room in such a way that the victim is shielded
46 from the view of the probationer or parolee, and the right to be informed by the custodial mental

52 (7) For victims and witnesses, upon their written request, the right to be informed by the
53 appropriate custodial authority, including any municipal detention facility, juvenile detention
54 facility, county jail, correctional facility operated by the department of corrections, mental health
55 facility, division of youth services or agency thereof if the offense would have been a felony if
56 committed by an adult, postconviction or commitment pursuant to the provisions of chapter 552,

16 prosecuting attorney declines to file information thereon, in which case the
17 proceedings shall be dismissed at the cost of the party filing the complaint.]

2 [577.029. A licensed physician, registered nurse, or trained medical
3 technician at the place of his employment, acting at the request and direction of
4 the law enforcement officer, shall withdraw blood for the purpose of determining
5 the alcohol content of the blood, unless such medical personnel, in his good faith
6 medical judgment, believes such procedure would endanger the life or health of

6 the person in custody. Blood may be withdrawn only by such medical personnel,
7 but such restriction shall not apply to the taking of a breath test, a saliva
8 specimen, or a urine specimen. In withdrawing blood for the purpose of
9 determining the alcohol content thereof, only a previously unused and sterile
10 needle and sterile vessel shall be utilized and the withdrawal shall otherwise be
11 in strict accord with accepted medical practices. Upon the request of the person
12 who is tested, full information concerning the test taken at the direction of the
13 law enforcement officer shall be made available to him.]
