# FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Office of the Secretary of State (SOS)** assume there are just over 16,000 limited partnerships that have been registered by the SOS. Since most limited partnerships have a duration of perpetual or an average of 50 years, the number of partnerships affected by this legislation, while unknown, is assumed to be minimal. Therefore, the number of notices sent by the SOS will also be minimal; the SOS will absorb the fiscal impact of this legislation
