## FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the Metropolitan Community College, Missouri Southern State University, Missouri State University, Linn State Technical College, Truman State University, Moberly Area Community College, Missouri Senate, University of Central Missouri, Department of Higher Education, Missouri Western State University, Missouri House of Representatives and the Lincoln University assume that there is no fiscal impact from this proposal.

Officials at the **University of Missouri** assume this would cost \$1,255,000 due to additional administrative costs to implement the legislation as well as lost revenue from distant education and dual credit students.

**Oversight** assumes that the costs associated with this proposal will be paid out of the College or Universities' normal operating expenses and that there is no fiscal impact to General Revenue. Additionally, Oversight assumes that the Colleges and Universities will raise their fees to cover the costs of the additional requirements outlined in this proposal.
