Bill Summary:

This proposal eliminates the requirement that a summons in cases before associate circuit judges specify a court date not less than ten days nor more than sixty days from the date process is served, allows municipal courts to use fees assessed for an appointed counsel fund in addition to a judicial education fund, and allows the annual report of the Judicial Finance Commission to be combined with any other annual report of the Missouri Supreme Court or Office of State Courts Administrator under certain circumstances.

FISCAL ANALYSIS

<u>ASSUMPTION</u>

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Section 479.260 – Appointed Counsel Fund

Officials from the City of Centralia, City of Kansas City, and St. Louis County assume the proposal would have no fiscal impact on their agencies.

In response to a similar proposal from the current session (HB 482, LR # 1164-01), officials from the, City of West Plains and Cass County assumed the proposal would have no fiscal impact on their agencies.

In response to a similar proposal from the current session (HB 482, LR # 1164-01), officials from the **City of Kansas City (CKC)** assumed the legislation will have a significant positive fiscal impact because CKC could charge a fee to cover indigent court defense as well as judicial education. Annual savings to CKC could approach \$830,000, as that is the current annual contract cost with Legal Aid for indigent court defense.

Oversight assumes the City of Kansas City would shift the payments for indigent court defense from the current annual contract with Legal Aid to the newly created appointed counsel fund, resulting in no net fiscal impact.

Oversight assumes the proposal would allow municipalities to re-allocate existing court fees. Instead of the fees being deposited into the judicial education fund, the fees will be allocated between the judicial education fund and the appointed counsel fund. Municipalities would have increased revenues of an unknown amount to the appointed counsel fund that would be offset by losses of an unknown amount to the judicial education fund.

FISCAL IMPACT - Small Business

FISCAL DESCRIPTION

Section 479.260 – Appointed Counsel Fund

The proposed legislation allows municipal courts to create an appointed counsel fund to pay the reasonable attorney fees approved by the court of any attorney appointed to represent a defendant who is indigent and unable to pay for legal representation when prescribed by Supreme Court rules.

FISCAL DESCRIPTION (continued)

Moneys for the fund will come from the \$1 fee collected on each case which currently is deposited into a judicial education fund. The court will determine the allocation of the fees between the accounts, but no court can retain more than \$1,500 in the judicial education fund for each judge, administrator, or clerk of the court and no more than \$5,000 in the appointed counsel fund.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
