#### FISCAL ANALYSIS

#### **ASSUMPTION**

#### Section 191.990:

Officials from the **Department of Insurance**, **Financial Institutions & Professional Registration**, **Missouri Senate** and the **Office of the Missouri Lieutenant Governor** each assume the proposal would have no fiscal impact on their respective agencies.

In response to a previous version of this proposal, officials from the **Office of the Missouri Governor** assume the proposal would have no fiscal impact on their agency.

Officials from the **Department of Social Services (DSS)** assume since the task force is established in the Department of Health and Senior Services (DHSS), DSS assumes DHSS would provide support to the task force. Participation by the Director of DSS as a member of the task force would not cause a significant fiscal impact to the Department of Social Services.

In response to a previous version of this proposal, officials from the **Missouri House of Representatives** assume that any expenses incurred by members serving on the task force would be paid by the Department of Health and Senior Services.

Officials from the **Department of Mental Health (DMH)** assume this legislation would require the Director of the DMH (or designee) to be a member of the Alzheimer's Task Force and potentially attend at least 4 meetings at diverse geographic regions in the state of Missouri. The legislation states the members will serve without compensation, but may be reimbursed for actual expenses from funds appropriated to the Department of Health and Senior Services. The cost, therefore, would not be borne by the DMH.

In response to a previous version of this proposal, officials from the **Department of Health and Senior Services (DHSS)** assume the following fiscal impact:

Year two (FY 2011): Printing:  $$12.50 \times 250 = $3,125$ Year three (FY 2012) and thereafter: Printing:  $$8.25 \times 250 = $2,063$  (per year)

**Oversight** assumes the DHSS could absorb the printing cost and has not included it in the fiscal note.
