ASSUMPTION

Officials from the Counties of: Andrew, Barry, Bates, Butler, Carroll, Cooper, DeKalb, Hickory, Knox, Laclede, Lawrence, Lincoln, Marion, Miller, Moniteau, Monroe, Montgomery, Nodaway, Ozark, Peniscot, Perry, Phelps, Pulaski, Randolph, Texas, Warren, and Webster did not respond to Oversight’s request for fiscal impact.

Oversight assumes the proposal is permissive, allowing counties of the third classification to erect and maintain a jail or holding cell facility at a location other than the county seat, but would not require the counties to do so. Therefore, Oversight reflects no fiscal impact.

FISCAL DESCRIPTION (continued)


This legislation is not federally mandated, would not duplicate any other program, and would not require additional capital improvements or rental space.
