**FISCAL ANALYSIS**

ASSUMPTION

Officials at the **Department of Agriculture** assume there is no fiscal impact from this proposed legislation.

In response to the previous version, officials at the **University of Missouri** assumed no fiscal impact from this proposal.

In response to the previous version, officials at the **Office of the Attorney General (AGO)** assumed that any potential costs relating to implementation of the proposal could be absorbed with existing resources. Since the proposal could be the subject of litigation, the AGO assumes that costs are unknown. If significant cases result over time, the AGO would seek an additional appropriation in the future.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
