Bill Summary: This legislation specifies that no pharmacy can be required to perform, assist, recommend, refer to, or participate in any act or service resulting in an abortion and will be immune from liability for refusing to do so.

FISCAL ANALYSIS

ASSUMPTION

Section 338.575:

Officials from the **Department of Health and Senior Services, Office of Prosecution Services, Office of the State Courts Administrator, Office of the State Public Defender** and the **Department of Insurance, Financial Institutions & Professional Registration** each assume the proposal would have no fiscal impact on their respective agencies.

Officials from the **Office of the Attorney General (AGO)** assume that implementation of this proposal will create no fiscal impact for this office. However, because the AGO is responsible for defending such legislation in constitutionality claims, AGO assumes that the nature of these provisions could create a fiscal impact. As a result, AGO assumes costs are unknown.

Oversight assumes, because the potential for defending such legislation is speculative, that the AGO will not incur significant costs related to this proposal. If a fiscal impact were to result, the AGO may request additional funding through the appropriations process.

Officials from the **Department of Social Services** assume there is no fiscal impact to the Department. Current policy requires MO HealthNet providers to comply with all applicable laws, policies, and regulations of Missouri and the federal government. In addition, the MC+ Managed Care contracts include language which prohibits a health plan from requiring a provider to perform a service contrary to the provider's conscience and allows the provider to make a referral to another health care provider licensed to provide the appropriate care.

Officials from the **Department of Corrections (DOC)** assume the long-range effect of this proposal for the DOC is unknown. However, for fiscal note purposes only, no fiscal impact for FY12, FY13, and FY14.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

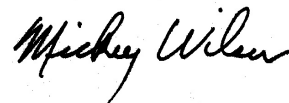
FISCAL DESCRIPTION
