HB 1578 -- Income Tax Exemption for Respite Care Payments

Sponsor: Largent

Beginning January 1, 2012, this bill establishes an exemption from individual and corporate income tax for reimbursement payments paid to an individual or business under a contract with the Children's Division of the Department of Social Services for respite care provided for children in foster care.
