ASSUMPTION

§§ 305.635, 305.637, 305.639, and 305.641 - Preserving Freedom from Unwarranted Surveillance Act:

Officials from the **Columbia Police Department** assume this proposal would result in no fiscal impact on the department since the department does not own an unmanned aerial vehicle.

In response to the previous version of this proposal, officials from the **Department of Public Safety - Missouri State Highway Patrol**, and the **Boone County Sheriff Department** each assumed the proposal would not fiscally impact their respective agencies.

Officials from numerous local law enforcement agencies did not respond to **Oversight's** request for fiscal impact.

Oversight assumes there is no direct fiscal impact from this proposed legislation on state or local government funds.
