### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume there does not appear to be a fiscal impact to the state. There could be costs to the local school districts to maintain the high school in each sub-district; however, that cost would be unknown.

Officials from the **St. Louis City Public School District** did not respond to a request for fiscal impact.

**Oversight** assumes the proposal expands existing duties of the Special Administrative Board and will assign no fiscal impact.
