## FISCAL ANALYSIS

### ASSUMPTION

The fiscal impact shown below is based on the current holders of out-of-state college specialty license plates. This legislation would allow these individuals to continue renewing their specialty license plates.

Officials from the **Department of Revenue (DOR) - Motor Vehicle Bureau (MVB)** state the following procedures will need to be implemented for the changes in this proposal:

- Procedures will need to be revised by a Management Analyst Specialist I requiring 40 hours of overtime at a cost of \$1,206 in FY 14.
- DOR's website will need to be updated to include the new plate type. This will require 10 hours of overtime for an Administrative Analyst III, at a cost of \$325 in FY 14.

In summary, DOR assumes a cost of \$1,531 (\$1,206 + \$325) in FY 2014 to provide for the implementation of the changes in this proposal.

Even though this proposal includes an emergency clause, the existing specialty plates may expire before the passage and signing of this legislation. DOR assumes that if this legislation passed, they would hold any expired plates pending its final approval. DOR also assumes that if this legislation passed, they would mail the plates to the owners nearest local license office. It costs approximately \$5.55 to mail a box of 10 plates to a license office. The mailing costs could be up to \$45 in FY 14.

**Oversight** assumes DOR is provided with core funding to handle a certain amount of legislative activity each year. Oversight assumes DOR could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, DOR could request funding through the appropriation process.

Officials from the **Department of Higher Education** and **Department of Corrections** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Missouri State University** and **University of Missouri** each assume the proposal will have no fiscal impact on their respective organizations.
