**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Department of Public Safety - Division of Fire Safety (DFS)** state this legislation requires a permit for hobby firework manufacturers. DFS currently administers the Fireworks Inspection and Licensing program, and issues more than 1,200 permits annually. While the total number of hobby manufacturers is unknown, it is not expected to be such which would require additional resources to administer.

DFS states the proposal may have a slight impact on state revenue in that additional fees may be incurred from hobby firework manufacturers.

The legislation sets an annual fee of \$100 for a permit for a hobby manufacturer of fireworks. **Oversight** assumes a minimal number of these new permits would be issued by the Division of Fire Safety. Therefore, Oversight will assume that the proposal will not have a material fiscal impact on the state.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
