### ASSUMPTION

### § 416.415 - Sale of Milk:

As a result of this proposal, small business dairy farmers could expect to see a direct fiscal impact if competitors sell milk at less than cost to a processor or distributor, or a small business dairy farmer elects to sell milk at less than cost to processors and distributors.


FISCAL DESCRIPTION
