FISCAL ANALYSIS

ASSUMPTION

Officials at the **Missouri Ethics Commission** (**MEC**) assume §105.456.3 would prohibit a state or local elected official, or the spouses, dependent children, staff/employees of such official from accepting anything of value from lobbyist/lobbyist principal.

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, telephone and email assistance.
- Provide oversight in adherence to the specific gift prohibition, including reviewing lobbyist reports as established in §105.959, RSMo. This oversight, it is assumed, would be primarily from receiving written complaints, as established in §105.955.14, RSMo, through conducting investigations and the related legal actions. It is assumed this prohibition would result in a minimal number of complaints; however, if this assumption is incorrect the Commission would require additional staff resources.

§105.473.13 would prohibit a lobbyist from delivering anything of value to a local or state elected official, or the spouses, dependent children, staff/employees of such official

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, telephone and email assistance.
- Provide oversight in adherence to the specific gift prohibition, including reviewing lobbyist reports as established in §105.959, RSMo. This oversight, it is assumed, would be primarily from receiving written complaints, as established in §105.955.14, RSMo, through conducting investigations and the related legal actions.
