**ASSUMPTION**

Officials from the **Department of Economic Development - Office of the Public Counsel**, the **Department of Economic Development - Public Service Commission (PSC)**, and the **Department of Economic Development - Division of Energy (DE)** each assume the current proposal would not fiscally impact their respective agencies.

Officials from the **Metropolitan St. Louis Sewer District** assume the current proposal would not fiscally impact their agency.

Officials from the **DE** also state the division participates in PSC regulatory cases to evaluate issues from a formal state policy and planning perspective consistent with its interest in clean, affordable, abundant energy and its efficient use. DE assumes it would be involved in the implementation of this proposal.

Small businesses may be involved and benefit from the additional economic development opportunities from this proposal.


FISCAL DESCRIPTION
