FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Officials from the **Department of Transportation (MoDOT)** state this proposal revises the definitions of “local log trucks” and “local log tractors” registered under Chapter 301. This proposal provides such local log trucks and local log tractors may not exceed the weight limits of Section 304.180, RSMo, when operating outside of the one hundred-mile radius from the forested site where the trucks or tractors transport harvested forest products. This proposal will not have a fiscal impact to MoDOT.

Officials from the **Department of Revenue** assume this proposal will have a minimal fiscal impact.

Officials from the **Department of Agriculture** each assume the proposal will have no fiscal impact on their respective organizations.

Small business logging companies could be impacted by this proposal.


FISCAL DESCRIPTION
