1 AMEND House Amendment No. \_\_\_\_\_ to Senate Bill No. 411, Page 1, Line 1, by deleting all of  
2 said line and inserting in lieu thereof the following:

4 "AMEND Senate Bill No. 411, Page 1, Section A, Line 2, by inserting after all of said section and  
5 line the following:

6 "68.075. 1. This section shall be known and may be cited as the "Advanced Industrial  
7 Manufacturing Zones Act".

8 2. As used in this section, the following terms shall mean:

9 (1) "AIM zone", an area identified through a resolution passed by the port authority board  
10 of commissioners appointed under section 68.045 that is being developed or redeveloped for any  
11 purpose so long as any infrastructure and building built or improved is in the development area.  
12 The port authority board of commissioners shall file an annual report indicating the established AIM  
13 zones with the department of revenue;

14 (2) "County average wage", the average wages in each county as determined by the  
15 Missouri department of economic development for the most recently completed full calendar year.  
16 However, if the computed county average wage is above the statewide average wage, the statewide  
17 average wage shall be deemed the county average wage for such county for the purpose of  
18 determining eligibility;

19 (3) "New job", the number of full-time employees located at the project facility that exceeds  
20 the project facility base employment less any decrease in the number of full-time employees at  
21 related facilities below the related facility base employment. No job that was created prior to the  
22 date of the notice of intent shall be deemed a new job. An employee that spends less than fifty  
23 percent of the employee's work time at the facility is still considered to be located at a facility if the  
24 employee receives his or her directions and control from that facility, is on the facility's payroll, one  
25 hundred percent of the employee's income from such employment is Missouri income, and the  
26 employee is paid at or above the [state] county average wage.

27 3. Any port authority located in this state may establish an AIM zone. Such zone may only  
28 include the area within the port authority's jurisdiction, ownership, or control, and may include any  
29 such area. The port authority shall determine the boundaries for each AIM zone, and more than one  
30 AIM zone may exist within the port authority's jurisdiction or under the port authority's ownership  
31 or control, and may be expanded or contracted by resolution of the port authority board of  
32 commissioners.

33 4. Fifty percent of the state tax withholdings imposed by sections 143.191 to 143.265 on

1 new jobs within such zone after development or redevelopment has commenced shall not be  
2 remitted to the general revenue fund of the state of Missouri. Such moneys shall be deposited into  
3 the port authority AIM zone fund established under subsection 5 of this section for the purpose of  
4 continuing to expand, develop, and redevelop AIM zones identified by the port authority board of  
5 commissioners and may be used for managerial, engineering, legal, research, promotion, planning,  
6 satisfaction of bonds issued under section 68.040, and any other expenses.

7 5. There is hereby created in the state treasury the "Port Authority AIM Zone Fund", which  
8 shall consist of money collected under this section. The state treasurer shall be custodian of the  
9 fund and shall approve disbursements from the fund in accordance with sections 30.170 and 30.180  
10 to the port authorities from which the funds were collected, less the pro-rata portion appropriated by  
11 the general assembly to be used solely for the administration of this section which shall not exceed  
12 ten percent of the total amount collected within the zones of a port authority. Notwithstanding the  
13 provisions of section 33.080 to the contrary, any moneys remaining in the fund at the end of the  
14 biennium shall not revert to the credit of the general revenue fund. The state treasurer shall invest  
15 moneys in the fund in the same manner as other funds are invested. Any interest and moneys  
16 earned on such investments shall be credited to the fund.

17 6. The port authority shall approve any projects that begin construction and disperse any  
18 money collected under this section. The port authority shall submit an annual budget for the funds  
19 to the department of economic development explaining how and when such money will be spent.

20 7. The provision of section 23.253 notwithstanding, no AIM zone may be established after  
21 August 28, 2023. Any AIM zone created prior to that date shall continue to exist and be  
22 coterminous with the retirement of all debts incurred under subsection 4 of this section. No debts  
23 may be incurred or reauthorized using AIM zone revenue after August 28, 2023."; and
