#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials at the **Office of State Public Defender** cannot assume existing staff will provide competent, effective representation for any new cases where indigent persons are charged with the proposed new crime of taking or killing a feral swine, a new Class A misdemeanor. The Missouri State Public Defender System is currently providing legal representation in caseloads in excess of recognized standards.

While the number of new cases may be too few or uncertain to request additional funding for this specific bill, the Office of the State Public Defender will continue to request sufficient appropriations to provide competent and effective representation in all cases where the right to counsel attaches.

Officials at the Department of Agriculture, Department of Corrections, Department of Public Safety - Highway Patrol, Joint Committee on Administrative Rules, Department of Conservation, Office of Prosecution Services, and Office of State Courts Administrator each assume this proposal will not have a fiscal impact on their respective organizations.
