FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Elementary and Secondary Education** and the **Office of the Governor** each assume there is no fiscal impact from this proposal to their respective organizations.

Oversight notes that current statute allows school districts to be excused from compliance with certain statutes when funding is withheld by the Governor in fiscal years 2011, 2012 and 2013. This proposal would extend to all future fiscal years the excuse from compliance due to the Governor withholding funds. Oversight assumes the extension of this proposal into future fiscal years would not have a direct fiscal impact.
