## FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Office of Administration**, the **Office of State Auditor**, the **Office of the State Treasurer** and the **Department of Insurance, Financial Institutions and Professional Registration** each assume no fiscal impact to their respective agencies from this proposal.

Officials at **St. Louis County** and the **Callaway County Commission** each assume no fiscal impact to their respective entities from this proposal.

Officials at **Boone County** assume a requirement that all public indebtedness be issued in a public auction will likely cause the public to have to pay a higher interest rate than a private sale for certain types of bonds.

**Oversight** notes this proposal prohibits political subdivisions from issuing debt under any method other than public sale. The Office of the State Treasurer is to provide information to the political subdivisions on how to award bonds to the highest and best bidder. Oversight assumes the decision to issue bonds is optional for the political subdivisions. Oversight will not show a fiscal impact from this proposal.
