FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration - Information Technology Services Division** assume the proposal will have no fiscal impact on their organization.

Officials from the Department of Agriculture, Department of Elementary and Secondary Education, Department of Higher Education, Department of Health and Senior Services, Department of Insurance, Financial Institutions and Professional Registration, Department of Mental Health. Department of Natural Resources. Department of Labor and Industrial Relations, Department of Public Safety (Capitol Police, Alcohol & Tobacco Control, Fire Safety, Gaming Commission, Missouri Highway Patrol), Office of the Governor, Joint Committee on Administrative Rules, Joint Committee on Public Employee Retirement, Missouri Lottery Commission, Missouri Consolidated Health Care Plan, Missouri Department of Conservation, Missouri Ethics Commission, Office of the Lieutenant Governor, Department of Transportation, Office of Prosecution Services, Missouri State Employee's Retirement System, MoDOT & Patrol Employees' Retirement System, Office of Administration (Administrative Hearing Commission, Division of Accounting, Purchasing Division), Office of the State Courts Administrator, Office of the State Auditor, Missouri Senate, Office of the State Public Defender, Department of Social Services, Office of the State Treasurer and the State Tax Commission each assume the proposal will have no fiscal impact on their respective organizations.

In response to a previous verison, officials from the **Department of Public Safety** (**Office of the Director**, **State Emergency Management Agency** and **Missouri Veterans Commission**), **Missouri House of Representatives** and the **Missouri State Employee's Retirement System** each assumed the proposal will have no fiscal impact on their respective organizations.

Officials from the **Department of Revenue**, the **Department of Corrections** and the **Office of Administration - Budget and Planning** each defer to the Office of Administration to estimate the fiscal impact of the proposed legislation on their respective organizations.

In response to a previous version, officials from the **Department of Economic Development** deferred to the Office of Administration to estimate the fiscal impact of the proposed legislation on their respective organization.

<u>ASSUMPTION</u> (continued)

Officials from the **Joint Committee on Administrative Rules** state this legislation is not anticipated to cause a fiscal impact beyond its current appropriation.

Officials from the **Attorney General's Office** assume any potential cost arising from this proposal can be absorbed with existing resources.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the Secretary of State's Office for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.
