FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services (DHSS)** provided the following information for this proposal:

A one-time cost for information technology (IT) services in FY 18 of \$8,100 to implement changes to the individual abortion report form and the mainframe ITOP application is required by the Office of Administration (OA), Information Technology Services Division (ITSD)/DHSS. The additional cost will also include costs to create a new data entry, storage and reporting system for the required fetal organ and tissue reports and the location of final disposition reports.

Oversight assumes the OA, ITSD/DHSS could absorb this one-time minimal cost within current funding levels.

Officials from the **University of Missouri Health Care (MUHC)** have reviewed the proposed legislation and determined that the fiscal impact should not exceed \$100,000 annually.

Oversight assumes the costs incurred by the UMHC related to this proposal can be absorbed within current resource levels.

Officials from the **Office of Attorney General (AGO)** assume any potential costs arising from this proposal can be absorbed with existing resources. The AGO may seek additional future appropriations if the proposal results in a significant increase in referrals.

Officials from the **Department of Natural Resources**, the **Department of Corrections**, the **Department of Labor and Labor Relations**, the **Missouri Office of Prosecution Services**, the **Office of State Courts Administrator** and the **Office of State Public Defender** each assume the proposal would not fiscally impact their respective agencies.

Officials from the following **hospitals**: Barton County Memorial Hospital, Bates County Memorial Hospital, Cass Regional Medical Center, Cedar County Memorial Hospital, Cooper County Memorial Hospital, Excelsior Springs Hospital, Golden Valley Memorial Hospital, Hermann Area District Hospital, Samaritan Hospital, Putnam County Memorial Hospital and Washington County Memorial Hospital did not respond to **Oversight's** request for a statement of fiscal impact.
