FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Labor and Industrial Relations (DOLIR)** assume this proposal would have a negative fiscal impact to their organization based on the following information;

Division of Workers' Compensation

Sub-section 287.068.1 requires the Division of Workers' Compensation (DWC) to prepare a report that contains the information relating to presumed cancer claims set forth in Sub-section 287.067.6.

- (1) The Division interprets "approved" claims to mean claims that are resolved either by the issuance of an Award by an Administrative Law Judge (ALJ) after an evidentiary hearing or by the approval of a Settlement Agreement as set forth in §287.390.
- (2) The Division interprets "disapproved" claims as claims that are resolved or reflected as closed in the Division's system based upon an Order of Dismissal issued by an ALJ. It would also include claims that are denied or where benefits have *not* been awarded because the presumption has been rebutted based upon the evidence presented at the hearing.
- (3) The costs related to the claims include the benefits that have been awarded pursuant to the settlement or award. Under the Workers' Compensation Law, the benefit categories are medical, temporary total disability benefits, permanent partial or permanent total disability benefits, and/or death benefits payable to dependents.

DWC can absorb any costs relating to the creation of new correspondence types and forms, website changes, and modifications to existing forms that would be required to comply with this legislation.

<u>Information Technology Services Division</u>

Changes would be required to the DWC computer system to capture the additional data required to determine if each claim was for cancer was a result of a firefighter involved with hazardous duty and produce the report required in the bill. The Information Technology Services Division (ITSD) anticipates changes to fourteen programs and an estimated thirty-one individual screens would be required. ITSD estimates 891 hours at \$75 per contract hour, or \$66,825 in FY2018. Ongoing maintenance is estimated to cost approximately \$14,000 annually.

Also noted by DWC, the legal ramifications of the proposed legislation are unknown at this time and therefore, the effect of any judicial pronouncements and costs associated with this legislation would be seen in fiscal years beyond the fiscal note period.

Oversight will show a negative fiscal impact to DOLIR - DWC for the cost of ITSD consultants and on-going ITSD support to upgrade and maintain necessary changes to programs.

Officials at the **Department of Corrections** and **Department of Public Safety - Fire Safety Division** each assume this proposal will not have a fiscal impact on their respective organizations.

Officials at the **DeSoto Rural Fire Protection District** assume this proposal would not have a fiscal impact on their organization.

Officials at **Callaway County** and **St. Louis County** each assume this proposal will not have a fiscal impact on their respective organizations.

Officials at the Battlefield Fire Protection District, Central County Fire and Rescue, Centralia Fire Department, Creve Coeur Fire District, Hawk Point Fire Protection District, Hillsboro Fire Protection District, Lake St. Louis Fire District, Mehlville Fire District, Nixa Fire Protection District, Saline Valley Fire Protection District and the Southern Iron County Fire Protection District did not respond to **Oversight's** request for fiscal impact.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Currently, the law provides that certain diseases of the respiratory and cardiovascular systems, including carcinoma, may be recognized as occupational diseases if a paid firefighter is exposed to certain substances. This bill includes volunteer firefighters in this definition of occupational disease.

The bill also provides for a rebuttable presumption that a paid or volunteer firefighter who contracts cancer has a compensable occupational disease under certain circumstances. The presumption aries if the firefighter was exposed to a known or probable carcinogen and has been assigned to at least five years of hazardous duty as a firefighter.

The bill also requires the Division of Workers Compensation to prepare a biannual report containing specified information about presumed cancers claims filed under the provisions of this bill.

This legislation is not federally mandated, would not duplicate any other program and would not
