**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Department of Insurance, Financial Institutions and Professional Registration (DIFP)** state the proposal would have an unknown fiscal impact to the Missouri Board of Pharmacy contingent on potential future appropriations made by the General Assembly to fund the Rx Cares for Missouri Program.

**Oversight** notes the balance of the Board of Pharmacy Fund (0637) on March 31, 2017 was \$6,709,696. Oversight assumes the Board of Pharmacy has the funds available to make the appropriation for the Rx Cares for Missouri Program without raising licensing fees. However, Oversight also assumes if the operation of this program reduces the cash balance of the Board of Pharmacy Fund below the operating cash needs of the Board, the Board would have the ability to raise licensing fees. This program expires on August 28, 2019 (FY 2020).

Officials from the **Department of Health and Senior Services** assume the proposal would not fiscally impact their agency.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

This bill creates the "Rx Cares for Missouri Program" to be administered by the Board of Pharmacy, within the Department of Insurance, Financial Institutions and Professional Registration, in consultation with the Department of Health and Senior Services to promote medication safety and prevent prescription drug abuse. Funds shall not be used for any state prescription drug monitoring program.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
