1 AMEND House Committee Substitute for Senate Bill No. 780, Page 1, Section A, Line 3, by  
2 inserting after all of said section and line the following:

4 "66.420. 1. As used in this section, the following terms mean:

5 (1) "International airport", any international airport located in any county with a charter  
6 form of government and with more than nine hundred fifty thousand inhabitants or any city not  
7 within a county; provided, however that "international airport" shall not include any airport owned  
8 by any county with a charter form of government and with more than nine hundred fifty thousand  
9 inhabitants;

10 (2) "Outlying property", property of an international airport that is not used as a control  
11 tower, parking lot, runway, taxiway, or terminal.

12 2. There is hereby established the "St. Louis Airport Oversight Commission" whose purpose  
13 is to review any decision by the governing body of an international airport regarding any outlying  
14 property that may substantially affect property neighboring the outlying property.

15 3. The commission shall consist of twelve members as follows:

16 (1) Two members appointed by the governing body of any home rule city with more than  
17 eight thousand but fewer than nine thousand inhabitants and located in any county with a charter  
18 form of government and with more than nine hundred fifty thousand inhabitants;

19 (2) Two members appointed by the governing body of any home rule city with more than  
20 ten thousand but fewer than eleven thousand nine hundred inhabitants and located in any county  
21 with a charter form of government and with more than nine hundred fifty thousand inhabitants;

22 (3) One member appointed by the governing body of any city of the fourth classification  
23 with more than eight hundred but fewer than nine hundred inhabitants and located in any county  
24 with a charter form of government and with more than nine hundred fifty thousand inhabitants;

25 (4) One member appointed by the governing body of any home rule city with more than  
26 twenty-four thousand but fewer than twenty-seven thousand inhabitants;

27 (5) Two members appointed by the governing body of any city of the fourth classification  
28 with more than two hundred eighty-five but fewer than three hundred twenty inhabitants and located  
29 in any county with a charter form of government and with more than nine hundred fifty thousand  
30 inhabitants;

31 (6) One member appointed by the governing body of any city of the fourth classification

1 with more than twelve thousand but fewer than thirteen thousand five hundred inhabitants and  
2 located in any county with a charter form of government and with more than nine hundred fifty  
3 thousand inhabitants;

4 (7) Two members appointed by the governing body of any county with a charter form of  
5 government and with more than three hundred thousand but fewer than four hundred fifty thousand  
6 inhabitants; and

7 (8) One member appointed by the governing body of any city of the fourth classification  
8 with more than four thousand but fewer than four thousand five hundred inhabitants and located in  
9 any county with a charter form of government and with more than nine hundred fifty thousand  
10 inhabitants.

11 4. The commission shall have veto power over any decision by the governing structure of  
12 the international airport or by any city not within a county regarding the airport.

13 5. The commission shall meet at least weekly to review and vote on any decision.

15 The meeting shall be held at the regular meeting place of the governing body of each city and  
16 county represented on the commission on an alternating basis. Notice of the meeting shall be  
17 provided as required by law."; and

19 Further amend said bill by amending the title, enacting clause, and intersectional references  
20 accordingly.
