1 AMEND House Committee Substitute for Senate Substitute for Senate Committee Substitute for
2 Senate Bill No. 843, Page 53, Section 620.1200, Line 29, by inserting after all of said section and
3 line the following:

5 "620.2200. 1. This act shall be known and may be cited as the "Missouri Route 66
6 Centennial Commission Act".

7 2. The commission shall be composed of eighteen members who reflect the interests,
8 history, and importance of the communities along Route 66 in Missouri. The members shall be
9 appointed as follows:

10 (1) Two public members appointed by the speaker of the house of representatives;

11 (2) Two public members appointed by the minority leader of the house of representatives;

12 (3) Two public members appointed by the president pro tempore of the senate;

13 (4) Two public members appointed by the minority leader of the senate;

14 (5) Three public members appointed by the governor, one of whom shall serve as
15 chairperson; and

16 (6) Seven ex officio members as follows:

17 (a) The governor, or his or her designee;

18 (b) The director of the department of transportation, or his or her designee;

19 (c) The director of the department of natural resources, or his or her designee;

20 (d) The director of the division of tourism, or his or her designee;

21 (e) The director of the department of economic development, or his or her designee;

22 (f) The secretary of state, or his or her designee; and

23 (g) The president of the Route 66 Association of Missouri, or his or her designee.

24 3. An ex officio member of the commission vacates his or her position on the commission if
25 he or she ceases to hold the position that qualifies the person for service on the commission.

26 4. (1) A public member of the commission is not entitled to compensation but is entitled to
27 reimbursement for the travel expenses incurred by the member while transacting commission
28 business.

29 (2) An ex officio member's service on the commission is an additional duty of the
30 underlying position that qualifies the member for service on the commission. The entitlement of an
31 ex officio member to compensation or reimbursement for travel expenses incurred while transacting
32 commission business is governed by the law that applies to the member's service in that underlying
33 position, and any payment to the member for either purpose shall be made from an appropriation
34 that may be used for the purpose and is available to the state agency that the member serves in that
35 underlying position.

36 5. (1) The commission shall meet at least quarterly at the times and places in this state that

1 the commission designates.

2 (2) A majority of the members of the commission constitutes a quorum for transacting
3 commission business.

4 6. The duties of the commission shall be to:

5 (1) Plan and sponsor official Route 66 centennial events, programs, and activities in the
6 state;

7 (2) Encourage the development of programs designed to involve all citizens in activities that
8 commemorate Route 66 centennial events in the state; and

9 (3) To the best of the commission's ability, make available to the public information on
10 Route 66 centennial events happening throughout the state.

11 7. Subject to appropriation, the office of tourism shall provide administrative and other
12 support to the commission.

13 8. (1) The commission may accept monetary gifts and grants from any public or private
14 source, to be held in the Missouri Route 66 centennial commission fund. The Missouri Route 66
15 centennial commission fund is created as a nonappropriated trust fund to be held outside of the state
16 treasury, with the state treasurer as custodian. The fund shall be expended solely for the use of the
17 commission in performing the commission's powers and duties under this section.

18 (2) The commission may also accept in-kind gifts.

19 9. Before June 30, 2027, a final report on the commission's activities shall be delivered to
20 the governor. The commission shall be dissolved on June 30, 2027, and any moneys remaining in
21 the Missouri Route 66 centennial commission fund shall be deposited in the general revenue fund.

22 10. The provisions of this section terminate on December 1, 2027."; and
