4 "~~operated]~~ In the case of a charter school allowed to operate only under subdivision (4) of
5 subsection 2 of this section, the person, group, or organization seeking to establish such a charter
6 school shall submit the proposed charter to the local school board in which the charter school is to
7 be located before or at the same time that the charter school submits its proposed charter to any
8 other sponsor. Upon receipt of a proposed charter for a location within the district, the local school
9 board shall have sixty days to consider the proposed charter and either enter into a sponsorship
10 agreement or notify the charter school that it declines the opportunity to sponsor the charter school.
11 Such notification shall be made in writing. If the local school board declines to sponsor the charter
12 school or does not respond within the specified time, any other authorized sponsor may enter into a
13 sponsorship agreement. No person, group, or organization seeking to establish a charter school shall
14 be required to submit its proposed charter to the local school board if the district in which it is to be
15 located is provisionally accredited or unaccredited by the state board of education."; and
