1 AMEND House Amendment No. ____ to House Committee Bill No. 23, Page 1, Line 1, by
2 deleting said line and inserting in lieu thereof the following:

4 "AMEND House Committee Bill No. 23, Page 3, Section 59.800, Line 41, by inserting
5 immediately after said section and line the following:

7 "66.420. 1. As used in this section, the following terms mean:

8 (1) "International airport", any international airport located in any county with a charter
9 form of government and with more than nine hundred fifty thousand inhabitants or any city not
10 within a county;

11 (2) "Outlying property", property of an international airport that is not used as a control
12 tower, parking lot, runway, taxiway, or terminal.

13 2. There is hereby established the "St. Louis Airport Oversight Commission" whose purpose
14 is to review any decision by the governing body of an international airport regarding any outlying
15 property that may substantially affect property neighboring the outlying property.

16 3. The commission shall consist of ten members as follows:

17 (1) Two members appointed by the governing body of any home rule city with more than
18 eight thousand but fewer than nine thousand inhabitants and located in any county with a charter
19 form of government and with more than nine hundred fifty thousand inhabitants;

20 (2) Two members appointed by the governing body of any home rule city with more than
21 ten thousand but fewer than eleven thousand nine hundred inhabitants and located in any county
22 with a charter form of government and with more than nine hundred fifty thousand inhabitants;

23 (3) One member appointed by the governing body of any city of the fourth classification
24 with more than eight hundred but fewer than nine hundred inhabitants and located in any county
25 with a charter form of government and with more than nine hundred fifty thousand inhabitants;

26 (4) One member appointed by the governing body of any home rule city with more than
27 twenty-four thousand but fewer than twenty-seven thousand inhabitants;

28 (5) Two members appointed by the governing body of any city of the fourth classification
29 with more than two hundred eighty-five but fewer than three hundred twenty inhabitants and located
30 in any county with a charter form of government and with more than nine hundred fifty thousand
31 inhabitants;

32 (6) One member appointed by the governing body of any city of the fourth classification
33 with more than twelve thousand but fewer than thirteen thousand five hundred inhabitants and

1 located in any county with a charter form of government and with more than nine hundred fifty
2 thousand inhabitants; and

3 (7) One member appointed by the governing body of any city of the fourth classification
4 with more than four thousand but fewer than four thousand five hundred inhabitants and located in
5 any county with a charter form of government and with more than nine hundred fifty thousand
6 inhabitants.

7 4. The commission shall have veto power over any decision by the governing structure of
8 the international airport or by any city not within a county regarding the airport.

9 5. The commission shall meet at least weekly to review and vote on any decision. The
10 meeting shall be held at the city hall of each city represented on the commission on an alternating
11 basis. Notice of the meeting shall be provided as required by law."; and

15 Further amend said bill by amending the title, enacting clause, and intersectional references
16 accordingly.
