**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Office of the State Courts Administrator** and the **Department of Corrections** each assume the proposal would not fiscally impact their respective agencies.

In response to a previous version, officials from the **Department of Public Safety - Missouri Highway Patrol** and the **Office of Prosecution Services** each assumed the proposal would not fiscally impact their respective agencies.

For the purpose of this proposed legislation, officials from the **Office of State Public Defender (SPD)** cannot assume that existing staff will provide effective representation for any new cases arising where indigent persons are faced with the enhanced penalties for crimes against sporting officials - now defined as “special victims”, which enhances the penalties.

While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide effective representation in all cases where the right to counsel attaches.

**Oversight** assumes the SPD can absorb the additional caseload that may result from this proposal.
