## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Economic Development (Public Service Commission (PSC), Office of Public Counsel, Division of Energy)** assume the proposal will have no fiscal impact on their organizations.

**Oversight** notes the Missouri Universal Service Fund (MoUSF) is a Federal Fund, managed by the PSC, and put in place for low income or disabled Missouri citizens to receive a discount on monthly landline telephone bills if they are qualified by the Missouri Universal Service Fund Board. Oversight assumes this Fund is outside the Office of the State Treasurer and therefore assumes the proposal will have no fiscal impact on state or local government.
